## 1. ADDITION OF ONE ENGINEERING TECHNICIAN POSITION, RANGE 18, TO THE BUREAU OF PUBLIC WORKS STAFFING TABLE, EFFECTIVE JANUARY 1, 1999.

**Mr. Jim Weber,** P.E., Director, Sewer Operations and Maintenance, greeted the Commissioners and said, "In both Items A-1 and A-2 we are requesting your formal action to add two positions to the Manning Table for the Department of Sewer Operations and Maintenance. Both positions were included in our 1999 budget requests. When the Board of County Commissioners adopted the budget a decision was made to include the funding of the 1999 budget but to defer actual creation of the positions to a later date. The funding was placed in a contingency line item within the sewer budget.

"In Item A-1 we are requesting addition of one engineering technician at range 18 to begin January first or soon after that as we can find one. Funding for this position was included in the 1999 budget. An increase in our overall work load and an anticipated increase in capital projects has necessitated the addition of this position. We request your approval of the recommended action. Be happy to answer any questions that you might have."
