C. REPORT OF THE BOARD OF BIDS AND CONTRACTS' DECEMBER 31, 1998 REGULAR MEETING.

(3) COMPUTER ROOM EQUIPMENT MAINTENANCE- INFORMATION SERVICES FUNDING: INFORMATION SERVICES

Item three, computer room equipment maintenance for Informat

"Item three, computer room equipment maintenance for Information Services. It was recommended to accept the proposal of IBM Corporation. That amount for 1999, \$72,588.82. A complete analysis of that recommendation is attached.

(4) FORENSIC EVIDENCE DRYING CABINET-REGIONAL FORENSIC SCIENCE CENTER FUNDING: BJA LOCAL LAW ENFORCEMENT GRANT

"Item four is a forensic evidence drying cabinet for the Regional Forensic Science Center. It was recommended to accept the low bid, meeting specifications, of Misonix, Incorporated. That amount, \$13,180.00.

Commissioner Hancock said, "Commissioner Schroeder, this is your fifth term. Something like that. Commissioner Schroeder, we just couldn't find anybody better to do the job and I could say some other things about it, but I'll just say we couldn't find anybody to do the job. Over the years, he has served as Chairman of the Board of County Commissioners and I think this is the fifth year that he did so. Chairman Schroeder said, "Don't tell Phil Nelson. He's standing back there. He's my new boss. I don't want him thinking I'm retiring. I'll be there, Phil."

Commissioner Hancock said, "If he's not on time, Phil, there's no excuse."

Chairman Schroeder said, "Thank you, Bill."

Commissioner Hancock said, "Melody, this is for you."

Commissioner Miller said, "Retiring, that's kind of dating us."

Commissioner Hancock said, "Don't retire yet. We also took the opportunity . . . Mark Schroeder had a specific request for a gift as he departed. We took him out to lunch a few weeks ago. We haven't had the opportunity to have Melody out to lunch this time, so we wanted to give you, from the Commissioners, a small gift."

Commissioner Miller said, "Where's the drum roll?"

Commissioner Hancock said, "Every meeting, our staff in the front office makes sure there's a gavel placed up here. I don't believe, since I've been here, maybe it's been used one time. We joked today that I don't believe Commissioner Schroeder had the opportunity to use it."

I tend to get a little sentimental but I think it's good reason because when you've worked amongst individuals that you know are extremely committed and dedicated, just as they have presented me with this, I could too say the same for each of you because I've been here, I've seen you in action, I have experienced it and I wouldn't take anything for it in the world. So, I just simply needed to say that in front of the Board and in front of individuals that are here, that have been invited and so graciously excepted, and to every employee that works for Sedgwick County because really it is upon your shoulders that each of us is able to stand and perform as we do and work for you. Thank you. Thank you for giving me that opportunity and the lovely gift."

Chairman Schroeder said, "Looking for other lights."

Commissioner Hancock said, "Well, we've asked for twenty minutes from Commissioner Schroeder, and he's going to oblige us."

Chairman Schroeder said, "I won't take twenty minutes but I will take some time, first of all, to extend my thank you to the Board of County Commissioners, to you Bill, Tom, Betsy and Melody, I've enjoyed my term as a Commissioner of the Fifth District and to all the other Commissioners that I've worked with. It's been exciting at times and troubling in others but overall it's been a wonderful experience. I've learned a lot and I've always said that everyone in this community should have the chance to sit up here for at least a day to find out what it's really like, especially during budget sessions. To see where the tough work comes in, where you make the cuts and make the additions and the Manager can attest to that, it's very, very difficult. It's been a great experience and I know we've had our difficulties, from time to time, but we've also had some wonderful times together and I appreciate all that you've done for me.

"Mr. Manager, Bill Buchanan and your staff, you've done an excellent job. Thank you for your support. His senior staff is just outstanding and we've had quite a few new people coming on that have been great selections for the County and I know will do an excellent job for this organization and for the citizens of Sedgwick County and I appreciate their support and hard work that they've given over the years.

"I also want to say that it took me a year or two, once I got here, to figure out that the County takes care of the County but it's the Commissioners that take care of people. I think that is has been something that this Commission has shown very well. We all have our tasks, as Commissioners, as Managers, Department heads, as employees, and if we don't carry out those tasks, as needed, then the job doesn't get done. This organization has shown that it can do that all the way down the line and all the way back up the line. It's just been wonderful. I think we've proven to our constituents that we do try hard. We do the best job that we possibly can. One of those people . . . I don't see Jerry Harrison, who's been with me since I started. I know he's short, but he's not that short. Jerry's out in the hall. Jerry has been here as long as I have. Jerry's been here, I think, 23 years and he has served as an interim manager a couple of times and has done a great job and I know he has supported his manager, Bill Buchanan, very well and does an excellent job. I just wanted to extend my personal thanks to Jerry, for all that he has done for me over the years.

"Mr. Mayor, Bob Knight, Bob thank you for coming today. It is wonderful to have you here. Bob and I have done quite a few wonderful things together, I think, over the years. We've had a pretty good relationship. We've had our moments of discussion and disagreement but we have always agreed to disagree and we've remained friends over the years. Bob, I cherish your friendship and I hope that we can continue that friendship. I look forward to that. He's been a very big supporter of mine and I have been of him and I appreciate your friendship, Bob.

"To all of you that are here, to family and friends . . . I told myself I wouldn't do this . . .It's been great. My family has been wonderful."

Commissioner Gwin said, "Now, don't start me crying. You'll have mascara all over the place."

Chairman Schroeder said, "Thanks, Betsy. They've been great. Sharon and the kids have been wonderful. They've supported me, over the years, and without their support I wouldn't have done what I have done. My mother-in-law and father-in-law, Dan and Myrtle Fisher, they've been here with me and supported me. So has my sister-in-law, Julie and my sister, Amy and my brother, Matt and my mother, Donna and I just wish Dad was here. It's been great and I appreciate the support. It's been wonderful.

"Thank you, all again, all of you for being here. There's so many of you, the Sheriff, the Chief, and it's . . . what on earth is this."

Commissioner Gwin said, "It's a little remembrance."

Chairman Schroeder said, "That's nice. I don't know what to say, now. Bill says adjourn the meeting. Hurry. Thank you all, again. We're going to have a reception after this meeting and you're welcome to stay around and enjoy conversation with one another and with the Commissioners. Again, it's been a great twelve years. Thank you for all that all of you have done to support us up here. We hope that that tradition will continue and from what I have seen, it will continue. I wish the best of luck to Ben and to Carolyn, in their new term as Commissioners. Thank you all for being here. Meeting is adjourned."
