1. MODIFICATION OF PLANS AND CONSTRUCTION, REQUEST NUMBER ONE AND FINAL, WITH DONDLINGER AND SONS CONSTRUCTION CO., INC. ON SEDGWICK COUNTY PROJECT – SAVANNA AT CASTLE ROCK RANCH 9TH ADDITION, PHASE 1; SANITARY SEWER IMPROVEMENTS. DISTRICT #1.

Mr. Paul E.
