#### NEW BUSINESS

## A. FIRE DEPARTMENT.

# 1. RESOLUTION AUTHORIZING DISPOSITION OF A SURPLUS FIRE ENGINE.

**Chief Gary Curmode**, Fire District #1, greeted the Commissioners and said, "Today, on our first resolution, we have a 1989 Brigadier surplus engine. The City of Bentley, which is in the Fire District, is interested in obtaining this and we'd like to give that to them for the amount of a dollar.

Bentley, along with the City of Viola, are both in the Fire District, as I mentioned, and also they're managed under the auspices of the Emergency Management Department. I would recommend that we approve the resolution. I'm available for questions."

Chairman Norton said, "I see no questions. Commissioner Winters."

**Commissioner Winters** said, "Well, Mr. Chairman, I'm certainly going to support this. I think it really, in working with some of these small communities, it allows us to keep a piece of apparatus in the County, and yet let them take some responsibility for it. And if there comes a time again, in an emergency situation, we can always call on them and other small departments for assistance. So, I think this is a good partnership with some smaller communities, as opposed to letting a piece of fire apparatus go back on the sales block, where we probably won't get much money for them anyway, and yet will keep it here in the community. So, I'm going to be very supportive of this."

## 2. GRANT APPLICATION TO FEDERAL EMERGENCY MANAGEMENT ASSOCIATION FOR A FIREFIGHTERS ASSISTANCE GRANT TO FUND THE PURCHASE OF VEHICLE EXHAUST EXTRACTION SYSTEMS.

**Chief Curmode** said, "Commissioners, this is the third year of a fire grant. We've applied the last two years, unsuccessfully, but again the first year there was approximately \$100,000,000 available for the entire United States fire departments, which there was over 31,000 that applied for it. The second year, there was \$360,000,000 and we applied for that also, was unsuccessful. This year there's \$750,000,000 available to government level. It's basically, depending on the size of your community, in our case we do a 30% match. They provide 70%.

And basically, what this would do in our case would be for vehicle exhaust emission system for our stations. Again, I'm available for any questions that you may have at this time."

Chairman Norton said, "I see no questions. What's the will of the Board?"
