#### A. DONATION OF \$25,000, TO BE USED FOR CONTINUED FUNDING OF A PART-TIME POSITION FOR ACCREDITATION, DATA ANALYSIS, AND FIRE PREVENTION, AS DIRECTED BY THE BOARD OF DIRECTORS OF THE RESEARCH AND DEVELOPMENT DIVISION.

**Chief Gary Curmode**, Fire Department, greeted the Commissioners and said, "One of our strong supporters in our fire district and Sedgwick County has liked a lot of the things that's happened this past year and has come forward, especially after the ISO study that we did, and he stepped forward and wanted to offer a \$25,000 anonymous donation to our research and development division to continue funding of our part-time position that helps in accreditation, some data analysis that's also helped in data analysis of EMSS and also our fire prevention. And I'm very excited about this, our whole department is and I would strongly recommend that you would approve and I'm available for any questions."
