#### **PRESENTATION**

#### C. UPDATE FROM WICHITA FESTIVALS, INC.

#### **POWERPOINT PRESENTATION**

**Ms. Wendy Johnson**, Chair of the Board of Directors; Wichita Festivals, Inc., greeted the Commissioners and said, "I'm pleased to stand before you, having had the privilege of serving as Chair of the Wichita Festivals board of directors for the last year.

When we had the opportunity to talk to you back in May, prior to the Wichita River Festival, one of the things we heard and one of the things that you and others shared with us is that you would like to hear from us on a more regular basis and so we wanted to take this opportunity to come to you and give you an update. We're not here to ask you anything, other than your continuing support and your appreciate for the work that Wichita Festivals does in the community.

Before I go any further, I'd like to recognize the members of our 15-member board that are here today, many of them, we probably have seven or eight of them here. If you all would raise your hands there and be acknowledged, including your very own Lucy Burtnett and of course our president Janet Wright, whom you will have a chance to hear from in just a few moments. I'm going to share a little bit of information with you about the Wichita River Festival, in terms of our successes and it's fitting that we're here on such a beautiful day, because we had nine of them back in the beginning of May to celebrate the festival, and then Janet is going to share a little with you about the Wichita Flight Festival."

Chairman Sciortino said, "It looks like a campaign promotion, 'I promise'."

Ms. Johnson said, "Well you know, in a way it was. We made some pretty aggressive promises to

the community back in I believe it was January, when we announced the lineup, when we announced the button price and when we announced some of the goals that we had for our 35<sup>th</sup> anniversary event and frankly I'm proud to stand before you, on behalf of the board, and tell you that we met those promises. We came to the community and said we were going to bring big name entertainers, that we were going to bring a wider variety of items to the food court, family focused events, more parking and we found that the shuttle system worked quite well for us this year, and of course the change in the format of the festival guide, which was a big deal then and was a big deal now. We heard great feedback about that.

I'm pleased to share with you the results of the 2006, 35<sup>th</sup> anniversary Wichita River Festival. We had record crowds and like I said, nine days of absolutely beautiful weather does a whole lot for the success of an outdoor oriented event. We had an estimated 370 to 390 attendees participate in one or more Wichita River Festival events. Because of the success of the weather and the record turnout we had, we saw economic impact of over \$25,000,000 to our community and the sponsors that we told you about were there in force throughout the festival and we had 163 companies and entities, including Sedgwick County, that contributed nearly \$2,000,000 in investment to help support the costs that it takes to run the Wichita River Festival.

If any of you had the opportunity to join us on the first weekend for either the Nick Lachey concert Friday night or the REO Speedwagon concert Saturday night, you know that we had a lot of warm bodies over at the West Bank Stage. We had between 20 and 25 thousand people at each one of those shows, very well behaved crowds, again great weather, great sound, great music. It was a great way to start the Wichita River Festival.

Security was certainly something that we are always concerned about for the safety of our community and the ongoing well being of the event and so we thought this was an important feature to share with you. In 2005, there were 132 arrests and last year there were 27. Certainly that's due to weather. That's due to management of events. It's due to the public safety support that we have. It's due to a lot of things, but I think this shows us that the community really appreciated what we did. The gating of some events to control crowds was a very positive thing and so that's something we're proud of and we think reflects very well on our community.

We also have culturally diverse crowds at many of our events and some events that were targeted at culturally diverse audiences. I'll touch on a few of those in a moment, but as I hope you remember, Sedgwick County was an active part in supporting diversity events

I mentioned gating events, we did gate a number of events. The gating at the West Bank Stage worked well and some of the concert events and such that were down on Kennedy Plaza and then

finally, button sales, I'm proud to tell you that we met our projections for the 2006 event. I think we had some skeptics that really wanted to see if this community would support five dollar buttons for the Wichita River Festival and they did, we met our goals and we're very proud of that.

I mentioned diversity events, Sedgwick County's investment helped to support the gospel concert on Monday night, the poetry slam and the play 'Dearly Beloved' and the play in particular, at Mary Jane Teal Theater was packed each night it was conducted, so we know that's something the community supports and we hope to bring more activities for a more culturally diverse audience throughout our community, as the Wichita River Festival continues to grow into its next 35 successful years.

Lastly, to share a few of the challenges with you that we know we're facing, in terms of conducting an ongoing, successful, large community event certainly sponsorship and the continued opportunity to gain community support, business investment to conduct an event without any ongoing public tax support. We're proud of that. Certainly we come to you, we come to the city each year and request your partnership as a sponsor, but we know that we need to continue to grow resources and stage quality events, quality begets more quality and we will continue to do that for this community. And certainly the increase in costs, as we bring in larger name entertainers, have larger events, the natural operating costs that you all deal with in your budgets every year are certainly something that we look at as well.

And then finally, green space downtown is one of the issues that we know, over time, we will have to be aware of and contend with, as more and more development occurs downtown. That's a very good thing. It will certainly cause us to evaluate plans, make sure we're aware of what's happening along the riverbank in areas that are used for parking and other places that have been traditionally critical areas for us and to make sure that we're prepared to grow, as downtown development grows in the areas that we have traditionally used for River Festival Events."

**Chairman Sciortino** said, "Now if you need a space for a concert very soon we'll have a venue downtown that you could probably avail yourselves of."

**Ms. Johnson** said, "We had the distinct pleasure of hearing about that venue from Mr. Holt at our board meeting a week or so ago, so that's something that we're very interested in making sure we keep aware of and determine how we can partner with Sedgwick County, as the arena comes on-

line, taking advantage of the shuttle systems, the trolley systems, it sounds like you all are planning as part of that whole project, I think that will be very good for us in the nine days we conduct the Wichita River Festival downtown, but certainly the community at large. And jumping ahead to the end, before I introduce Janet, one of the things that we did hear as we met with community leaders over the last year is that the Wichita River Festival and Wichita Festivals, Incorporated has a role to play in the cultural development and we're still trying to figure out what that role is, but we know that things like the arena, the water walk projects that will enhance quality of life downtown are things that we want to make sure and be aware of and determine how we can partner and support to help make . . . "

**Chairman Sciortino** said, "Well keep your dialogue up with Ron, because I was serious when I was talking about that I'm sure there's something we can work out for the betterment of the whole community and the festival so lets keep talking about it."

**Ms. Johnson** said, "Absolutely. We appreciate the time that he took to come and visit with us.

In closing, we kept our promises to this community, in terms of the enhancements that we were going to make during this 35<sup>th</sup> anniversary year. Wichita River Festival and Wichita Festivals, Incorporated is financially sound, which we're very proud of in this community and we look forward to the next 35 years. I am pleased to turn the microphone over to Janet Wright, and then when she concludes with a Wichita Flight Festival update, we'll be glad to stand for any questions that you might have."

#### **POWERPOINT PRESENTATION**

**Ms. Janet Wright**, President/CEO, Wichita Festivals, Inc., greeted the Commissioners and said, "We appreciate the opportunity this morning to come and visit with you. Thank you very much for giving us that opportunity and your time on your schedule.

I'm here to kind of give you an update on where we are, what result we found from this year's Wichita Flight Festival. This was the second year that we have the opportunity to help manage this event and really take responsibility for how it turned out. It's obviously a new event for our community and something that we think has great potential and future and we are pleased to have you all participate in that with us, so we wanted to share some of the information related to what happened with this particular event.

I was many of you on Friday evening at the concert and others of you on Saturday and Sunday. We appreciate your attendance at the event and your participation. That says a lot about your interest in how the event goes. We secured the sponsorship from 30 different companies to help support the festival this year. That amounted to about \$237,000 worth of cash and in-kind support. Our

attendance was better than last year, although still not what we were hoping it would be this year. I think weather had a significant impact on that. Unfortunately those nine days we had of sunshine and warm weather in May transcended a little bit into August with the rain and not exactly the best conducive weather for an air show, but it did work out that every day we had a great air show and the weather cleared and it was a beautiful afternoon. It did however I think impact significantly the numbers of people that came out, because it did both mornings look a little gray as we moved forward.

We did recognize individuals came from a variety of different communities though, through a raffle drawing that we had to ride on the B-25, which was one of the hits of the air show. There were 26 different communities represented in the raffle that we held and we thought that was a pretty good representation of who was coming and participating in the event.

We also used the bus system that was transporting people from the Raytheon parking lots to Jabara Airport to do some surveys to find out what people thought about the air show and who they were. One of the interesting things we learned is that most people were coming either on Saturday or on Sunday. They didn't come Friday and Saturday or Sunday or they didn't come Saturday and Sunday. They came one of the two weekend days, the greatest majority of them. So I think that's interesting for us to learn, not that they came more on Saturday or more on Sunday, but just that they picked one or the other of those days to come.

We also learned that this crowd that comes to this event is a little older crowd than perhaps the River Festival, although I've noted here that the greatest majority of attendees were between 30 and 60, a more significant portion of them were actually between 40 and 60, so I think that helps us understand better who our target audience is and our market, as we proceed for next year.

The other very encouraging statistic from that survey was the percentage of those who responded about the quality of the air show, 88% of the attendees who filled out the survey said that they felt it was excellent, so we really felt pleased with the response that we got to the air show and the activities that were provided to the community for that weekend.

Want to share a couple of comments with you that we received via e-mail. As you can imagine, our e-mail is pretty public, just like yours, and so we get lots of comments, many times not always wonderful, but this time we really were the recipients of widespread praise, not for our work so much, but for the entertainment that people enjoyed and you'll see from these comments that they just felt like the flying acts were superb, they loved the transportation from Raytheon, it really made

life much easier for people. They enjoyed bringing elderly parents. We heard that from several people, WWII veterans that came out and were able to experience some of that history that they actually lived through. And then people just felt like it was a wonderful event, overall, and we were a lot about that from them.

One of the comments that we also heard repeatedly was from the air show performers who had come to participate in the event. They felt like this was probably one of the most quality events they had participated in over the year, certainly that we treated them with great hospitality than many others, so that really showcases I think not only our community, the hoteliers and the people who provided transportation, all of our great volunteers. That really was a comment to the quality of the execution of what they did for us, so we are very pleased with that.

We also want to thank all of you guys for coming out and sharing the weekend with us. In terms of the concert, unfortunately we had to make that decision at 8:00 in the morning on Friday about weather and we did move it inside to Century II. I think that dampened our attendance, without question. It's a lot more fun to have a big concert and fun evening on the airfield at Jabara than it is at Century II, but we still had about 1,700 people that attended. They enjoyed the music and it was a good event, and we appreciated the cooperation of those of you who came and all of our other sponsors. That was a hard move to go from being at Jabara and planning what you were going to do there, to moving to Century II and people did it in a very cooperative spirit, so we appreciated that a great deal.

The air show itself, as I said, had a lot of things to offer, for the whole weekend. We had eight nationally known entertainers that came from all over the United States. Plus I hope that you got to see the P-51... excuse me, the F-15 Eagle that came in from Eglin Air Force Base. That was a spectacular conclusion, both Saturday and Sunday, to the air show and when they did the heritage flight with the P-51 Mustang, it was quite a sight to see, so I hope you did get to experience that.

We also have approximately 50 static aircraft that were on display, representing all kinds of planes, from vintage aircraft, very old like the B-25 and one that was actually made here in Wichita, the Mystery Ship, in 1929 to war birds, to experimental aircraft, so we had something of everything and I think people really enjoyed it.

I think too, what people enjoyed was the opportunity to see different things. The Kansas Aviation Gallery was another means for people to learn more about our aviation history here in Wichita. It featured all the airframe manufacturers here, as well as Airbus and a variety of museums from across the state, so we tried to make sure that people had something to not only experience and enjoy, but also learn something about the heritage that is Wichita's aviation community. In terms of education seminars, I think one that I particularly enjoyed was one of the men who

actually a Tuskegee Airman who lives here in Wichita came and spoke to us about his experience and we did have a Tuskegee aircraft also on display, so it was a nice tie for people to be able to experience both his life and what it was like for him and the plane that he flew, so that was a real highlight for us, certainly for me, I enjoy those kinds of things.

In terms of financial results, we're going to receive a shortfall of approximately \$190,000. It was a budgeted shortfall of \$96,000 that the City Council approved when they initiated this event with us. Due to ticket sales and difficulty in securing sponsors because of the timing of when the contract was executed, we are going to see a shortfall of about \$190,000. We are disappointed with that but we also feel like this is an event not unlike the Wichita River Festival was in its early beginnings. It takes a number of years to get on its feet. We need to make commitments to do it earlier. That's what we believe is one of the keys to its future success. We need to know now that we're going to move forward again for next year. We need to have well-rounded community support and we really appreciated your investment again this year in this event. I think it is something that will, in time, build into a great event for our community. We have to give it time and I hope you will, if you're interested, will continue to look at how you might support this event in years to come.

We hope that the format can continue, that the time of year for the event can continue to be the same, because I think that is what will put it in its proper place in our schedule of activities and quality of life issues here in Wichita, as we move forward, so that's little bit about the Flight Festival. Wendy is going to wrap up our presentation today, to give you some insights into what we've been doing, our board in particular, over the past year and some of our initiatives. Thank you very much."

**Ms. Johnson** said, "That header that just flew right by and off the page said 'Wichita Festivals Roll In Economic Development'. This gives you an idea of what we have been talking about, what's important to our board, what our stakeholders tell us is important to the community. We know that quality of life is critical to the Visioneering effort through economic development considerations and the things that we know help you all bring businesses to the community. We've got to have a strong quality of life. We believe we have a role to play in that.

Our board has spent the last year talking with community leaders that are involved in projects such as the river corridor improvements, water walk, I mentioned Ron Holt and arena. Those things are all very important for us to continue to engage in, to receive information, to share information about what we're up to, so we can make sure and be active partners in the economic development of quality of life efforts in our community and I commit to you, on behalf of our board, that we will continue to do that and it will remain a critical focus for us, over the next several years.

One of the things we also heard in those meetings with community leaders was that Wichita Festivals is a great event resource in the community. The organization that Janet leads has shown that they know how to conduct successful events and that there might be additional roles for us to play, as we partner, whether it's with these entities noted on your screen or others in the community, to conduct other events that would add value to quality of life.

The last thing I would leave you with, if you would make note of October 19<sup>th</sup> on your calendar, at 5:30 on October 19<sup>th</sup> at the Wichita Center for the Arts we will host our annual volunteer party to recognize volunteers from the Wichita River Festival and the key sponsors. This will also be the night that we premier the documentary that was developed in the 35<sup>th</sup> anniversary festival year, highlighting the Wichita River Festival, its growth, everything that it takes to make it happen and it's actually a program that will be shared, I believe, with PBS and we hope that we'll get some national acclaim for the work that's done in our community to support community celebration, which is our mission. So 5:30 on October 19<sup>th</sup>, Wichita Center for the Arts, you will be receiving an invitation soon for that, but I hope you can make note of that and plan to join us. Thank you for your time and at this point, Janet and I would be happy to take any questions you may have."

Chairman Sciortino said, "And we do have some questions or comments. Commissioner Unruh."

**Commissioner Unruh** said, "Thank you, Mr. Chair. Well first of all, I'd say Wendy and Janet, that was very comprehensive and informative report. Thank you for taking the time and thanks to your board members for taking the time to be here too. I know you are busy folks so coming here for this presentation, we appreciate it.

I had a couple of question though about River Festival. How many folks attended? I mean, do you have estimates for specific events, like the parade itself and the block party?"

**Ms. Johnson** said, "We do. We try to look at each event and use the estimates provided to us by the police department and others. The parade we estimated between 75,000 and 80,000 people were down there that evening. The block party is one I don't remember right off the top of my head. I think it was about 60,000. We do have them for each particular event."

**Commissioner Unruh** said, "Okay. Well that's the preface to the real question I want to ask. The real question I want to ask is where did they park? Parking is kind of an issue right now, at the commission, and so just . . . where do all those cars park?"

**Ms. Johnson** said, "Well, if you'll recall, on the festival guide that we provided with each button purchased, there were 27 different parking lots I believe that were targeted in the main, downtown area to identify places for people to park. We also provided shuttle service throughout the nine

days that went two different routes, one north of Douglas, one south of Douglas so that people could park in those lots and see where the trolley would come by and pick them up and transport them to the primary festival area.

So we really didn't have too many complaints, actually, about parking this year. That was one of our initiatives is that we wanted to make sure people could easily access festival events and it's going to become even more significant for us in this coming year and the year after, as Water Walk and the arena and all those new initiatives get off the ground."

**Commissioner Unruh** said, "Okay, well thank you for that response. You know parking, people ask that question of us a lot about our projects and so with 75,000 people at one time, that represents I don't know how many cars but if it was handled without complaint, that gives us some optimism, as we face our problems.

All right, one other question Mr. Chairman, or really a comment, I just . . . about the air festival, it seems like one of the things that really adds to the potential for success is a word that you use in your report called 'hospitality' and you know, we can do a lot about logistics and planning and the actual event itself, but if you can engender and cultivate a sense of hospitality among not only your volunteers, but among the whole city of Wichita, I believe it's great to go some place where you really feel welcome, so that was a great comment you made."

**Ms. Johnson** said, "Thank you. We agree with you and I think the efforts to transport people and encourage them to park at Raytheon and take the shuttle was one of our efforts to provide that hospitality, because it did make it much easier for people to get out of their car and be moved right directly to the front door of the event and we did have a great many people that responded that they felt like that was a wonderful way to move and have the opportunity to not exhaust themselves with walking."

Commissioner Unruh said, "All right, very good, thank you. That's all I have, Mr. Chair."

Chairman Sciortino said, "Thank you. Commissioner Burtnett."

Commissioner Burtnett said, "Well I don't have any questions, just a couple of comments. I want to let the board know that I'm glad that the board members that showed up, this is great to see you here. It shows their commitment to the festivals and serving on that board, I have really enjoyed serving on this board, because these people are very engaged in moving festivals forward and they're always thinking and networking and talking about what we can do to make things better, and working with them, we also do a lot of volunteer work of building button packets and it was the first experience for me and boy, was that a lot of work. And when you look at how much effort it

takes to put these kinds of events together, it is just, it's mind-boggling, so I have really enjoyed being on this board. I think they did a great job. I think you will do very well in the future and I hope I can still be a part of that, so thank you very much for your report, it was great."

Chairman Sciortino said, "Commissioner Winters."

**Commissioner Winters** said, "Well thank you. I just want to add my thanks to both the staff of River Festivals and to the volunteer board members. I know a lot of you have worked at that for many years and we certainly appreciate the hospitality you showed to the commissioners in trying to make available the inside story of what's happening. So you all just continue to do a great job and it's a great event for our entire region for sure.

I just wanted to follow just briefly on Commissioner Unruh's comment about the parking downtown. You know, I've tried to and I've started and I try not to sound facetious when I say this but when I get the calls about 'what about parking for the arena?' I've started saying 'well, we're just going to use the River Festival plan'. And you know, I think if you can develop a plan to handle 75,000, 80,000 people downtown, and I attended a couple of those events and I was able to park, I've got a great deal of confidence that we can figure out how to make a plan to have a service to a building that will house 15,000 for basketball, but most all the events will probably be less that 7,000 people.

So as the nay-sayers continue to worry about parking in downtown, I'm confident, in just watching your activities through that 10-day event and how many people end up in downtown, get there, find what they're doing and then are able to leave, parking is just something that I think we can plan for and you all do a marvelous job of coordinating a lot of things that people never see, but make it available, so again, good job and thank you for coming today."

**Ms. Johnson** said, "Our pleasure."

**Chairman Sciortino** said, "And Janet, to pick up on what Tom said, somehow I have a feeling that if we told you next year's River Festival we'd only have 7,500 people, could you find parking spots for those people, you probably would think you'd died and went to heaven, so maybe we'll get you on board to do this plan, but seriously . . ."

**Ms. Wright** said, "I really don't want 7,500 people at the River Festival. I want zeros after that."

Chairman Sciortino said, "But the one thing, since we're talking about parking, that we are trying to do is we're trying not to be . . . we are going to have a parking plan. The public is going to be very happy with the plan, but we're not being short sighted and just thinking about ourselves as an island. We're working with the City of Wichita for a blended parking plan because they have a lot of ideas on how to develop the core area around the arena and there will be parking needs there, so we're trying to work with them to come up with a blended plan that will fit everybody's needs and we do take the River Festival example to heart. If 150,000 people come downtown on a weekend and can find somewhere to park and get to the events that they want to have and get home, coming up with something once or twice a year that might require 15,000, we will be able to satisfy that.

The other thing that we have been talking about are satellite parking facilities to kind of ease the crush of everybody trying to park in a small space and then trying to get out again. That could be . . . so that will not be a problem, but we're not rushing to this. We're taking our time, so that we get it right and I think it is very important that we work closely with the City of Wichita for a blended plan and we'll be . . . well, we are working on that and will continue.

You guys are doing a good job, keep it up. You have delivered on your promises and for the most part, I think that you're to be very commended on that and the air festival has a little challenges but with the leadership of Janet and the people that work with her, I'm sure that will be accomplished. It will be a tremendous event in the future. Mr. Norton, you have something you wish to say."

Commissioner Norton said, "The Norton family loves the River Festival."

Chairman Sciortino said, "Okay, end of comment. That's it?"

Commissioner Norton said, "No pontification."

**Chairman Sciortino** said, "Okay, great. You can tell he's not running for election this year. Thank you again, ladies. Next item please, Madam Clerk."

#### POWERPOINT PRESENTATION

**Mr. Robert W. Parnacott**, Assistant County Counselor, County Counselor's Office, greeted the Commissioners and said, "This is one of our post annexation hearings that we have five years after the annexation of an area by the city, in this case the City of Wichita. I'm going to use the curser on the screen I think, if I can find it. What we've got, this street that's running north/ south is Hoover and then down here we have  $21^{st}$  Street,  $29^{th}$  and  $37^{th}$  so you're seeing a series of shaded parcels on both sides of Hoover running from just above  $21^{st}$ , almost all the way up to  $37^{th}$ ."

Chairman Sciortino said, "All the dark shaded ones."

**Mr. Parnacott** said, "That's correct sir. The purpose of this hearing, of course, is to determine whether they provided the services that they said they would provide, set out in their service plan. This is phase three and phase four, had a six phase annexation. You heard phases one and two last December and you made an affirmative finding last then they had provided the services they said they were going to provide.

We sent out notices to approximately 50 landowners. Received no phone calls at all that had anything to do with services, complaints or any questions about services being provided by the city. The city has also provided us a report. There is a schedule of services on page 65 of your backup and then starting on page 66 is the city's report, showing the services they have provided, so at this point, my review shows that they have provided the services. I haven't heard anything contrary from anybody in the public, but this is a public hearing, so I would recommend that you open the public hearing, receive any comments either from the city or from members of the public and then close the hearing and make any findings that are appropriate."

**Chairman Sciortino** said, "Okay, thank you. At this time I will open the public hearing. Is there anyone here in the audience that would like to speak against this item? Is there anyone here in the audience would like to speak for this item?"

**Ms. Terry Cassidy,** City of Wichita Manager's Office, greeted the Commissioners and said, "As Mr. Parnacott indicated, we have provided a comprehensive report of services that had been delivered over the past five years to these two particular areas. We do believe we're in compliance with the requirements of the service plan. Would hope you would find in our favor this morning. I do have a number of city staff members with me today, if you have particular questions about specific services or specific things that had been provided for these citizens."

In addition to this purchase price of \$245,000, the county would again be responsible for closing costs and relocation costs. I request your approval and am available for questions."

**Ms. Marilyn Cook**, Director, COMCARE, greeted the Commissioners and said, "COMCARE has an agreement with landlord Keith Bomholt for housing for our Transitional Housing project. The contract provides HUD funding for 14 one-bedroom apartments and two two-bedroom apartments and one apartment that our staff uses as an office, to be near the consumers that they serve.

The original grant was provided to us in 2003 and this August they renewed that for two years, so

this is a consequence of that. It allows us to now contract once again with Mr. Bomholt. We recommend that you approve the contract."

**Chairman Sciortino** said, "Thank you. We do have a question or comment. Commissioner Burtnett."

**Commissioner Burtnett** said, "Do we have any other contracts with other people for this type of housing?"

Ms. Cook said, "No. We do . . . no, this is transitional housing for people that have co-occurring disorders, they have a mental illness and a substance abuse disorder. We do contract with the Mental Health Association to provide some transitional housing for folks that are leaving local or state in-patient hospitals, but this is very specific to the population with co-occurring disorders."

**Commissioner Burtnett** said, "Okay, great. Thank you. That's all I needed to know. Thank you, Mr. Chair."

**Chairman Sciortino** said, "What is substance abuse disorder? I mean, if a guy is an alcoholic, that's substance . . . what's the difference? What is the disorder? Is that just another . . . I mean, what is that? I never heard of that as an illness, substance abuse disorder."

**Ms.** Cook said, "Well, you could have either an abuse or a dependence problem and depending on how much it impacts your life, I'm using that as a generic term to describe someone that has either had a problem with alcohol or drugs and some of those individuals have abuse problems where they drink or use drugs too heavily and some have a dependence, so I lump them all together."

**Chairman Sciortino** said, "Okay, all right. Thank you. What's the will of the board on this item?"

This is just another good example of how governments and agencies collaborate with one another to maximize dollar investment, so that we can provide services and do a good job. Item three, vibratory sheepsfoot roller for Fleet Management. Recommend the proposal from Logan Contractors, option one, for a cost of \$107,650.

# 4) ASBESTOS SURVEY & RELATED ENVIRONMENTAL SERVICES FOR THE ARENA PROJECT- FACILITIES DEPARTMENT FUNDING: SPECIAL SALES TAX

And item four, asbestos survey and related environmental services for the arena project for Facilities Department. And the recommendation is to accept the proposal from American Metropolitan, option one, for \$13,765 and establish and execute contract pricing for additional environmental services and on-call services as required. Be happy to answer any questions and I recommend approval."

The other thing going on this Friday, at Lawrence Dumont Stadium is the opening of the . . . let's see what it's called, Kansas Book Festival and this is the first annual and it will be in the . . . the opening ceremonies are in the infield of the Lawrence Dumont Stadium and then the festival will take place there. So we're supposed to have great weather this weekend and it sounds like, from what Kristi said earlier, there's a lot going on, but this a free event so you can just pop by for an hour or two and see what's going on."

**Chairman Sciortino** said, "So this is the inaugural event. Great. Okay, is that it? Commissioner Unruh."

Commissioner Unruh said, "Thank you, Mr. Chair. I just want to remind everyone that the Komen Race for the Cure is taking place this weekend, on Saturday. I think the activities start about seven, with breakfast and 8:00 is the first timed race, it's a 5K race, so everyone needs to limber up and get out and get ready to run that. Then there's a walk, un-timed walk later on and then a family walk after that. There's a lot of activities, it's really a fun event and the proceeds go to the Mid Plains Chapter of the Komen Foundation and about 90% of those funds stay here in Kansas, so it's a worthwhile activity, money stays here and recommend everybody try to take advantage of it.

And I noticed Commissioner Burtnett is dressed in pink today to kind of commemorate that and she's got on her little pink ribbon of hope, so a lot of folks are aware of this activity and aware of the problem that cancer presents in our society, so I hope you all can find a way to get out and be supportive."

The revenues are good in the cafeteria and it continues to be very strong. With fall coming on and Halloween coming on, with some of the events they have going on there, I think we've done a pretty good job and it looks like the revenue is up over \$62,000 for that one event, with the Cyberdome, so good news for Exploration Place as they try to reinvent themselves and bring us back to the fold."

Chairman Sciortino said, "Great. Commissioner Winters."

Commissioner Winters said, "Well thank you. Just very briefly to report that last Thursday and Friday I traveled with a group of members of the board of the Kansas Association of Counties. We traveled out to Liberal and Seward County. And Thursday evening had a very nice reception with elected officials from Seward County and surrounding counties and Friday toured some of the things that are happening in Seward County and then had a very productive board meeting. And so we certainly were treated well out there. They've got a really aggressive board of county commissioners. They've just completed a 300,000 square foot warehouse for cotton, for a coop out of Texas that is taking full advantage of new cotton production in Kansas. They've got an ethanol plant on the ramp and so again, Kansas Association of Counties had a very good meeting out in Seward County last Friday, so just wanted to let you know where I was last week. Thanks."
