NEW BUSINESS

A. DONATION OF 1983 FORD TENDER TO THE CITY OF MT. HOPE FIRE DEPARTMENT.

Chief Rick Brazill, Deputy Fire Chief, greeted the Commissioners and said, "For the past 18 months Sedgwick County Fire District #1 has leased an older tender truck to the City of Mount Hope. They had their tender go out of service about that time and we had one that was surplus at that time. Over the course of that lease we have been studying our ISO ratings and we had a lack of hauled water in that area so I would recommend that we donate this tender truck to the City of Mount Hope because it will be a benefit both to the City of Mount Hope; it gives them a tender truck for their response area but also it gives us more hauled water capabilities in that northwest part of the County to help maintain Sedgwick County Fire District #1's ISO rating. I would be happy to answer any questions."

Chairman Winters said, "Alright, Rick, this does sound like a good project and a 1983 model truck is certainly not a new truck. I would assume that its value is quite reasonable and again it will be like it'll still be in the system, still be working in the system."

Chief Brazill said, "Correct, it won't get as much use up there in the City of Mount Hope. It is mechanically sound but this will absolve any liabilities that we have with it, with that fire apparatus."

Chief Brazill said, "That is correct."
