REGULAR MEETING

October 29, 2008

The Regular Meeting of the Board of the County Commissioners of Sedgwick County, Kansas, was called to order at 9:00 a.m. on Wednesday, October 29th, 2008 in the County Commission Meeting Room in the Courthouse in Wichita, Kansas, by Chairman Thomas G. Mr. Jeff Huxman, Director of Content, KPTS, greeted the Commissioners and said, "This is a very well received honor on behalf of KPTS. The Mister Rogers' Sweater Drive, as you mentioned, has been going on now for nine years. It kicks off on Saturday, November 8th with Kid Fest. Children who bring a gently used or new sweater to donate will get free admission to Kid Fest and the wonderful thing about this over the nine years is the partners that we have worked with including the Salvation Army who helps us distribute these sweaters to the folks that need them most, Walgreens is on board with us this year so we have 14 drop off locations at Walgreens, Clear Channel Radio helps us get the word out and a number of other businesses around the community also open their doors and have drop off locations. Accepting the proclamation on behalf of the Wichita core of cadets is our Cadet Colonel Mike Seis. Mike is a City Core Commander for Wichita and Mike is also seeking to go to the Air Force Academy and we are confident of his success. Colonel Seis."

Cadet Colonel Mike Seis, JROTC, greeted the Commissioners and said, "On behalf of Wichita JROTC we would like to thank the Sedgwick County Commission for giving us this proclamation. C. PUBLIC WORKS

1. APPROVAL OF K.D.O.T. FORM 1306 "CERTIFICATION OF REAL PROPERTY ACQUISTITION PROCEDURES AND UTILITY ARRANGEMENTS" FOR SEDGWICK COUNTY PROJECT 817-V, W, X; ROAD WIDENING PROJECT ON MERIDIAN BETWEEN 47TH ST. SOUTH AND 71ST ST. SOUTH. CIP# R-281. DISTRICT 2.

Mr. David Spears, Director/County Engineer, Public Works, greeted the Commissioners and said, "Item C-1 is requesting your approval of K.D.O.T Form 1306 for the road improvement project on Meridian between 47th Street South and 71st Street South, designated as R-281 in the Capital Improvement Program. This form certifies that all rights-of-way have been acquired and all utility

arrangements have been made. State funds will pay for \$3 million of the eligible costs of construction of the project. I recommend that you approve the 1306 form and authorize the Chairman to sign."

Chairman Winters said, "Thank you David. Are there questions? Commissioner Norton?"

Commissioner Norton said, "Well, I will make the motion. This is a project that I have worked on for several years. I am glad that we finally got the right-of-way totally taken care of and we can move forward on it. This is going to be a great corridor leading from south Wichita around 235 where there is a lot of growth going down into Haysville and will increase a nice traffic flow north to south on another corridor besides Seneca and Broadway so I am excited about this and I am glad that we got the right-of-way taken care of finally. And I will make that motion to approve."

Commissioner Parks said, "I just wanted to make one comment and this was without condemnation, right?"

Our staff and our right-of-way folks worked very, very hard with the landowners to be sure that it didn't have to go to condemnation, that we continued to go back to the table and visit with the folks that own the property until we got all of the right-of-way and I think that is good public policy. The recommendation is to accept the proposal from Evan Corporation, Alternate 1 for a negotiated cost of \$208,810.00 and execute a contract.
