On behalf of the Division of Health and Human Services, recommend to accept the quote from Trizetto Corporation for an estimated annual cost of \$54,000.00 and establish unit pricing for items 2-4 for one (1) year with four (4) one (1) year options to renew.

Gateway EDI is the approved clearinghouse solution for the Tritech (EMS) and PsychConsult (COMCARE) billing software already in use. It would be cost prohibitive to solicit bids for these services as there would be configuration and implementation costs in order to get another clearinghouse provider to work with our current system.

COMCARE processes approximately 20,000 claims per month, Emergency Medical Services (EMS) approximately 4,000 claims per month and the Health Department approximately 1,000 claims per month. It is thought that paper claim and claim inquiry services may be used in conjunction with the electronic clearinghouse services, but there is no estimate as to how often those services may be used at this time.

A clearinghouse transfers patient insurance claim data from the providers to the insurance carriers and is essential to timely processing and receipt of payment for services.

The Health Department billing software, KIPHS, has no approved clearinghouse vendor, but will work with the solution that is being implemented.
