In addition, ADAAG requires one in every eight accessible spaces, but not less than one, to be served by an access aisle 96 in (2440 mm) wide minimum and shall be designated "van accessible." The existing parking lot has 6 total parking spaces and none are designated accessible. According to ADAAG a required minimum of 1 accessible parking space should exist at this facility, if the facility is open to the public. Provide one van accessible parking space, which conforms to ADAAG specifications. If restriping occurs, ensure that it meets Wichita city code. Note: Wichita city code requires all accessible parking spaces to be 11' wide with a 5' aisle for a total of 16'. ADAAG recognizes these dimensions as universal design. However, this facility is not considered new construction, and therefore falls under the program access provisions of Title II.
