Five fishing piers and one boat dock exists in the park. The Recreational Facilities — Final Rule does not define how many existing fishing piers or boat docks are required to be accessible. Therefore, scoping for existing fishing piers and boat docks fall under the program access provisions of Title II. Under Title II, the fishing piers and boat docks program, as a whole, are required to be accessible. We recommend making at least two fishing piers/docks and one boat dock fully accessible, including creating at least one van accessible parking space, which complies with ADAAG specifications, located at each accessible pier or dock. We also recommend identifying the locations of accessible piers and docks via a variety of media including maps, and on-site signage. 10. Open Shelters, Camp Spaces and Picnic Tables	Numerous open picnic shelters and camping spaces exist at the Park. None of the open picnic shelters or camping sites provide designated accessible parking in parking areas that serve the shelters or camp sites; and none of the picnic tables at the existing shelters and camp sites are accessible. Technically, ADAAG nor the Recreational Facilities - Final Rule provide scoping for picnic tables. In addition, neither guideline provides specifications for what would constitute an accessible picnic table. However, the document titled "Accessibility Guidelines for Outdoor Developed Areas" (ODA) does provide both scoping and specifications for accessible picnic tables. These Guidelines (ODA) are neither final rules nor enforceable. "Proposed 16.17.2.3 requires the slope of the accessible parking space does not exceed 1:50 in any direction. Where surface conditions require a greater slope for proper drainage, an exception permits a 1:33 maximum slope. Camping spaces and shelters, according to the Outdoor Developed Areas Guidelines, are required to be accessible according to the scoping chart (Table 16.17). This table states that, where 2 to 25 shelters exist, at least 2 should be fully accessible including accessible parking and other accessible amenities that serve the particular shelter. In addition, this table states, where 76 to 100 camping spaces exist, at least, 5 camping spaces should be fully accessible, including accessible parking and accessible amenities that serve the camping space. Finally, according to ODA, where two or more fixed picnic tables are provided in a picnic area, at least 50 percent, but never less than two, shall comply with 16.5.4 through 16.5.6. We recommend making at least two picnic shelters, 5 camping spaces, and at least two picnic tables at accessible picnic shelter, camp space and other picnic "areas" with more than one picnic table, fully accessible. Therefore, we recommend, if the six Shelter Houses are considered existing, that at least two be made fully accessible, including the provision of accessible parking, accessible paths of travel from parking to accessible entrances, and all interior amenities be made fully accessible. In addition, we also recommend ensuring that Park visitors with disabilities be informed of the locations of accessible Park facilities, via public maps, public advertisements, and/or other means. 18. Play Areas	Two separate children's play areas exist in the Park. Both of the play areas provide structurally accessible play equipment. However, the following accessible features do not exist: accessible parking, accessible paths of travel to required accessible play equipment entrance and exit points, and accessible surfaces in the play equipment use zones.	15.6.4 .1 (Acc. Play Areas )	Since ADAAG does not specifically provide guidance on how to make play areas accessible, we are required to examine existing federal information, which is currently not part of the ADA and, therefore, not enforceable guidance. Two such documents exist; the Play Areas, Final Rule, October, 18th, 2000 (Play Areas Final Rule); and the New ADAAG, November 24th, 2004, Chapter 2, 240 Play Areas and Chapter 10, 1008 Play areas (New ADAAG). In essence, both of the Play Areas Final Rule and New ADAAG are identical and both were created by the U.S. Access Board. The individual and composite play components within this play area are accessible according to the Play Areas – Final Rule. However, Accessible routes do not lead to required accessible play equipment, due to surface cross slopes greater than 1:50, running slopes greater than 1:12, and abrupt changes in level greater than ½-inch. In other words, the existing sand surface is not considered an accessible surface. The composite play structure does have a rubber accessible surface which leads to it, but no such surface leads from it's exit points, nor to other ground level play components. To ensure an accessible route surface, not requiring regular maintenance, which is also impact attenuating, we recommend that one accessible path of travel, be installed which consists of either rubber tiles or poured rubber, leading to each single play component and exit points of the composite play structures at both play areas. We also recommend that a rubber surface be provide in the use zones of each single play component that is required to be accessible and the composite play structures. However, such rubber surfaces are not technically required by the available accessibility guidance, but may be required by the general program access provisions of Title II. (Note: A well maintained wood fiber surface, as defined in (Building Block 16), is also considered accessible under the conditions that such surface is maintained regularly.
