On recommendation of Angee Sisco, on behalf of the Facilities Department, Tim Kaufman moved to accept the proposals from Encore Construction LLC, Sky Contracting Company Inc., and Van Asdale Construction LLC and establish contract pricing at the rate identified above for a period of one (1) year with two (2) one-year options to renew. Linda Kizzire seconded the motion. The motion passed unanimously.

Under this contract vendors will provide on-call remodeling services on an as needed basis. Services may include, but are not limited to, general demolition, framing walls and partitions, finishing work, and modifications to existing space to accommodate ADA standards.

A review committee comprised on Tania Cole and Rob Lawrence - Facility Project Services, Greg Tuxhorn -Facilities Maintenance, Steve Claassen - Facilities, and Angee Sisco -Purchasing, reviewed each proposal submitted, shortlisted and interviewed vendors, and unanimously agreed on the recommendation.

After an initial review based on solicitation response completeness, qualifications and expertise, number and availability of staff, and cost - the review committee shortlisted Cherokee, Encore, Pinnacle, Sky and Van Asdale. Four interviews were conducted, and the committee further reviewed ADA specific qualifications, use of subcontractors, and cost including percentage mark up prior to a recommendation decision. Three vendors are being recommended for award to ensure best value and additional flexibility for resources. Each vendor recommended for award has satisfactorily completed work on County projects as a General Contractor or Subcontractor. Departments may choose one or all three vendors to obtain a quote.
