On the recommendation of Dallas Shaffer, on behalf of the Sedgwick County Facilities Department, Jennifer Dombaugh moved to **accept the bids from National Flooring, Inc. and Harry Street Carpet and establish contract pricing for one (1) year with two (2) one (1) year options to renew.** David Spears seconded the motion. The motion passed unanimously.

A review committee comprised of Robert Lawrence, Sandy Anguelov and Tania Cole, Facilities Project Services and Dallas Shaffer, Purchasing evaluated each bid. Two vendors are being recommended to ensure best value and additional flexibility in resources. Star Lumber was not recommended because of the long lead times on broadloom roll carpet which is about 80% of the carpet we use and a higher material costs markup.

The 2012 spend was approximately \$100,000.00.
