Shall the following be adopted?

Shall Unified School District No. 267, Sedgwick County, Kansas (Renwick), issue general obligation bonds in an amount not to exceed \$28,000,000, to pay the costs to: (a) at the existing Andale Elementary School, construct, equip and furnish additions to create a new multi-purpose classroom to also function as a storm shelter, new locker rooms for Gym B, renovate the second floor grade 6-8 classroom area, restrooms, and a portion of the gymnasium for improved storage and make other improvements to HVAC systems, entrances and upgrades for safety and security and educational purposes; (b) at the existing Andale High School, construct, equip and furnish additions to provide classrooms for Vo-Ag educational programs, a new Physical Education/Gym area, and other improvements to HVAC systems, the main entrance, office areas, and upgrades to address safety and security and educational purposes in the building: (c) at the existing Colwich Elementary School, construct, equip and furnish two new classrooms, upgrade the HVAC system, provide a new handicap accessible playground, and make other improvements to address safety and security and educational purposes in the building; (d) at the existing Garden Plain Elementary School, construct, equip and furnish additions to create a new band room to also function as a storm shelter, a new music room, a new controlled-access entrance, improvements to HVAC systems, and make improvements to locker rooms, restrooms, playgrounds, and other areas for safety, security, and ADA compliance issues; (e) at the existing Garden Plain High School, construct, equip and furnish additions to create four new classrooms to replace the FACS building, a new Fine Arts Auditorium, additional Industrial Arts space, and corridors to connect buildings, and make improvements to upgrade the HVAC system and improvements for enhanced safety and security and educational purposes; (f) at the existing St. Marks Elementary School, construct, equip and furnish a new addition to provide a new competition gymnasium as well as make improvements to upgrade the building entrance, HVAC system, parking areas and improvements for safety and security; (g) make all other necessary improvements appurtenant thereto (collectively, the "Project"); and (h) pay the costs of issuance and interest on said general obligation bonds of the District during construction of the Project; all pursuant to the provisions of K.S.A. 10-101 *et seq.*, K.S.A. 25-2018(f), K.S.A. 72-5457, and K.S.A. 72-5458 *et seq.*?
