On the recommendation of Britt Rosencutter, on behalf of Sedgwick County Fire District #1, Richard Powell moved to accept the low bid meeting specifications from Feld Fire in the amount of \$67,065.00. Linda Kizzire seconded the motion. The motion passed unanimously.

The Slip-in Pump and Tank units are used in the rear bed of the Fire Squad trucks for first response at grass fires and trash fires. These items are replaced when we replace the vehicle in which they are used.

Notes

Bid 2 from Danko Equipment Co. falls short in the pumping discharge rates and pressure. It also did not provide the foam system that was specified.

These are replacement units. Surplus will be sold on Purple Wave.

Questions and Answers

Richard Powell: Seeing that we are only buying the actual tank and pump unit itself, was this part of the overall project we had where we had bid for trucks earlier and approved the purchase several months ago?

Britt Rosencutter: Yes. These will be placed on the brush trucks.

Tim Kaufman: I'm going to ask a question about the bid from Danko.

Britt Rosencutter: Danko gave us two bids. One bid followed our specs and the second bid was for a unit they supplied, which falls short in the pumping discharge and the pressure rates we require for the pumping unit we use. They didn't provide a foam system that was specified. It differed a little and wasn't the quality we require.

Tim Kaufman: So their \$40,696.00 bid is non-responsive?

Britt Rosencutter: We accepted the bid because they gave it to us but the fact it didn't meet specifications it probably will not be chosen.

Linda Kizzire: How long will it take to get these in and get them installed?

Brian Richey: Typically, these pumps will be installed on the new trucks around September of this year. It's just a second piece of this vehicle to make it complete. It takes about a week to install them when we get the trucks but we haven't received the trucks as of yet. We're expecting September or October of this year.

Britt Rosencutter: The chosen vendor for this listed six to eight weeks after receipt of order.
