Linda Kizzire: So we don't have any idea of how much the spend is going to be on this since it's a new product and vendor?
Joe Thomas: Right. This originally came up in Finance as a request for a piece of software to track the requests being made for the CARES money. So based on that and knowing there might be possibly more needed solutions in the future, we decided to take advantage of the whole blanket cloud solutions, which would encompass a variety of various items. Some of those items are things we might not anticipate right now but maybe need in the future. We don't have a price as to what we would spend. Does that make sense?

## Linda Kizzire: Yes.

Jared Schechter: So the goal is to have stored information off sight? Is this what this is about. When I think cloud, that's what I think about.

Joe Thomas: Yes. So we don't have to buy any of the on premise servers? Am I right Joe?
Joe Currier: Yes.
Joe Thomas: Cloud solutions would mean we wouldn't have to buy on premise servers. We wouldn't have to spend large amounts of money for infrastructure. That's why they call these software as a service (SaaS). Some are the infrastructure service, which are servers. I'm not too sure what the platform necessarily is.

Joe Currier: Same thing.

Joe Thomas: So it would save money. As I mentioned, it allows you to not make a big investment but you could pay for what you need at this time and expand without a giant monetary investment.

Jared Schechter: So the individual departments will be picking what they want to use?
Joe Thomas: Yes. That's why it's hard for us to wrap our hands around the quantity or price because it's open to all departments. There may be some future needs we just don't anticipate at this time. We'll be covered by very competitive pricing with the State of Kansas participating with NASPO.

Russell Leeds: So to be clear, we are doing something new and different correct?
Joe Thomas: This is not so much on IT's part. Purchasing pushed this because we saw what happened with CARES and consultants. There's so many things we are not experienced with. We are just trying to get ahead of the curve and having this in place will fill the need.

Russell Leeds: Currently there is no costs associated with this contract correct?
Joe Thomas: Correct.
Russell Leeds: It will be a per purchase, per item evaluation? It will be based on existing budget authority within each department's budget?

Joe Thomas: Yes, sir. That's kind of the pay-as-you-go. As long as you have the budget, you can pay as you need it.
Russell Leeds: This is identified as a State of Kansas Cloud Solutions contract. It was initiated by the State of Utah but the State of Kansas adopted it and we're continuing to utilize it.

Joe Thomas: Yes, sir. NASPO stands for the National Association of State Procurement Officers. They have one state that is the lead agency and they create it for other states to participate in. So the State of Kansas does an agreement with the overall huge NASPO contract. Karen has worked with these types of contracts many times.

Karen Powell: Yes.
Joe Thomas: Does that explain it?
Russell Leeds: Yes. For me it does.
