Comments on 7/14/2020 staff meeting

## Comment:

"Dear Commissioners,

Today's meeting was enlightening. Since Commissioner Howell asked for a snapshot, a review of which underscores concerns I have previously shared with the Commission, here it is:

As of 6/1/2020 556 cases with 21 deaths and 411 recoveries was reported. As of 7/13/2020 2156 cases with 883 recoveries and 28 deaths was reported. A couple of points of interest: there were 1600 new cases during this period with only 7 deaths. Assuming no new cases since June 1, 7 people out of 556 cases were recorded. This would represent a concerning 1.3% fatality rate.

Next, as Commissioner Meitzner pointed out, as of 6/25/2020 28 deaths, 10 of which were from every from outside the county, was recorded, the same number reported today, 19 days later. As of 6/19/2020 846 cases with 523 recoveries and 25 deaths was reported. This means that with 1310 new cases reported since 6/19/2020, only 3 deaths have been recorded. The 6/1/2020

death total was 21, meaning that 7 deaths have been reported over the past 43 days. The 2-week cycle rule cited today doesn't present any numbers of statistical significance. As Commissioner Meitzner said, we are doing well percentage wise, having 18% of the state's population and only 10% of the state's recorded deaths. During this same period, how many traffic deaths have we had? How many murders have we had? How many suicides, domestic violence incidents, assaults, rapes, robberies, drug arrests, traffic injuries, worksite injuries have we had? It's time we stopped panicking and started looking at reality!

For years we spent countless hours in city-wide disaster drills, chemical, biological, radiological attacks, plane crashes, tornado recoveries, etc. It was always sadly apparent that our hospital capacity to address such disasters was woefully inadequate and almost impossible to correct. Triage was always a significant element in the exercises and the reality that a lot of people were not going to survive was an inescapable fact reflecting the risks of living. Why are we allowing ourselves to be stampeded into an irrational fear of something that has not proven to be the bubonic plague, small pox or any number of other human catastrophes we have historically faced and overcome? How many cases is a ludicrous measure to use to make decisions when the fatalities per 1000 cases doesn't justify the hysteria we are seeing?

The hospitals have demonstrated that money drives their decision making processes. Contemplating shutting down "elective surgeries" leads to elevated numbers of avoidable cancers, heart attacks, strokes, etc. Are these same hospitals, and governing bodies, prepared to handle the outrage, lawsuits and unnecessary deaths the foolish course upon which we are cruising will lead to? People will lose their trust in the medical community when they see the consequences of such absurd measures as have been advanced.

The hysteria we saw from some members of the Commission must be brought under control before the actions toward which we are being pushed result in a wrecked economy, a disgruntled populace and a potentially ungovernable condition in our community. Whatever true concern in this epidemic exists will surly be lost in the hysteria if we continue in the direction we are currently traveling.
