Question or Comment:

I am writing as a concerned citizen of Sedgwick county. My concern is regarding Sedgwick county EMS. It has come to my attention that Sedgwick county has an insufficient number of Paramedics/EMTs to service the county properly. I feel it is unsafe when EMS is called to an emergency and they are unable to respond in a timely manner because they do not have enough staff members to staff the ambulances. Additionally, it is unsafe to run the Paramedics/EMTs for twelve plus hours in a shift without a break to even sit down and eat. Is this even legal? How safe do you feel when EMS shows up knowing they haven't had anything to eat their whole shift functioning on fumes only? Do you know that food supplies our brains with nutrients needed for it to function properly and without it, sugar levels drop to insufficient levels and can cause confusion, dizziness, altered mental status, etc.? How would you like a paramedic/EMT who may not be thinking clearly to care for your loved one? Maybe they give a wrong medication and it harms your loved one for life or kills them? How come this has been

going on for so long? How come the county has not hired more paramedics/EMTs to staff the ambulances that are supposed to serve the county? Is it because the salary of a Sedgwick county paramedic/EMT is so far below the national average that the job no longer appeals to the younger generation? It is sad that the employees are paid such a low wage and are run ragged every shift they work. It is no wonder that this service is hemorrhaging employees left and right.
