RESOLUTION ESTABLISHING STOPPING, STANDING, AND PARKING RESTRICTIONS ALONG $55^{\rm TH}$ STREET SOUTH RIGHT-OF-WAY FROM MERIDIAN TO THE WEST CITY LIMITS OF WICHITA, AND PROVIDING FOR THE ENFORCEMENT THEREOF.

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, pursuant to K.S.A. 8-2001, et. seq., has the power and authority with respect to streets and highways under their jurisdiction and within the reasonable exercise of the police power to enact and enforce resolutions regulating traffic, said resolutions relating to those subjects enumerated in K.S.A. 8-2002; and

WHEREAS, pursuant to K.S.A. 8-2002(a)(1), the Board of County Commissioners of Sedgwick County, Kansas, is authorized to regulate or prohibit stopping, standing and parking; and

WHEREAS, pursuant to K.S.A. 8-2002(a)(1), the Board of County Commissioners of Sedgwick County, Kansas, determines, on the basis of an engineering and traffic investigation performed by the County Engineer of Sedgwick County, Kansas, that stopping, standing, and parking along 55th Street South from Meridian to the west city limits of Wichita be regulated or prohibited.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

SECTION ONE:

Stopping, as defined within K.S.A. 8-1472, is prohibited at all times on both sides of 55th Street South east of the intersection of 55th Street South and Meridian until 55th Street South is located within the western city limits of the City of Wichita.

SECTION TWO:

Standing, as defined within K.S.A. 8-1469, is prohibited at all times on both sides of 55th Street South east of the intersection of 55th Street South and Meridian until 55th Street South is located within the western city limits of the City of Wichita.

SECTION THREE:

Parking. as defined within K.S.A. 8-1444, is prohibited at all times on both sides of 55th Street South east of the intersection of 55th Street South and Meridian until 55th Street South is located within the western city limits of the City of Wichita.

SECTION FOUR:

The prohibitions shall be signed as directed in Sections One through Three, thereof, and the prohibitions shall be for the public right-of-way in its entirety.

SECTION FIVE: The County Engineer is hereby directed to erect official traffic control

devices as may be most appropriate, giving notice of the prohibitions established by this resolution; and that said traffic control devices be in conformity with the most recent edition of the Manual on Uniform Traffic

Control Devices for Streets and Highways.

SECTION SIX: All law enforcement officers with jurisdiction in Sedgwick County, Kansas,

are hereby authorized to enforce the parking prohibitions contained in Sections One through Three, hereof, which have been properly signed as

directed in Section Four, hereof.

SECTION SEVEN: Any person who shall violate any prohibition in this resolution shall

be guilty of a traffic infraction or other offense as provided pursuant to

Kansas law.

SECTION EIGHT: This resolution shall be published once in the official county newspaper.

This resolution shall become effective upon such publication.
