



# Wichita/Sedgwick County Stormwater Facility Inspection & Maintenance Guidance Extended Dry Detention Ponds



Regular inspection and maintenance is critical to the effective operation of this stormwater management facility so that it can function as designed. In the City of Wichita and Sedgwick County, local regulations (City of Wichita Code Chapter 16.32 and Sedgwick County Resolution 196.10) require that property owners maintain all stormwater facilities on their properties to ensure they are fully functioning to treat and control stormwater runoff, and to document facility inspections and maintenance activities. This documentation must be kept by the property owner and must be made available to Stormwater Management staff upon their request.

This page provides guidance on inspection and maintenance activities that must be performed for extended dry detention ponds. Some facilities may have more, or less, frequent maintenance needs, depending upon a variety of factors including the occurrence of large storm events, overly wet or dry (i.e., drought) regional hydrologic conditions, and any changes in the land (e.g., development, landscaping, etc.) that drains to the facility.

Inspection Activities	Suggested Schedule
<ul style="list-style-type: none"> <li>After several storm events or an extreme storm event, inspect for: bank stability; signs of erosion; and damage to, or clogging of, the outlet structures and pilot channels.</li> </ul>	<b>As needed</b>
<ul style="list-style-type: none"> <li>Inspect for: trash and debris; clogging of the outlet structures and any pilot channels; excessive erosion; sediment accumulation in the basin, forebay and inlet/outlet structures; tree growth on dam or embankment; the presence of burrowing animals; standing water where there should be none; vigor and density of the grass turf on the basin side slopes and floor; differential settlement; cracking; leakage; and slope stability.</li> </ul>	<b>Semi-annually</b>
<ul style="list-style-type: none"> <li>Inspect that the outlet structures, pipes, and downstream and pilot channels are free of debris and are operational.</li> <li>Note signs of pollution, such as oil sheens, discolored water, or unpleasant odors.</li> <li>Check for sediment accumulation in the facility.</li> <li>Check for proper operation of control gates, valves or other mechanical devices.</li> </ul>	<b>Annually</b>
Maintenance Activities	Suggested Schedule
<ul style="list-style-type: none"> <li>Clean and remove debris from inlet and outlet structures.</li> <li>Mow side slopes (embankment) and maintenance access. Periodic mowing is only required along maintenance rights-of-way and the embankment.</li> </ul>	<b>Monthly or as needed</b>
<ul style="list-style-type: none"> <li>Repair and revegetate eroded areas.</li> <li>Remove vegetation that may hinder the operation of the pond.</li> <li>Repair damage to pond, outlet structures, embankments, control gates, valves, or other mechanical devices; repair undercut or eroded areas.</li> </ul>	<b>As Needed</b>
<ul style="list-style-type: none"> <li>Monitor sediment accumulations, and remove sediment when the pond volume has become reduced significantly.</li> </ul>	<b>As Needed</b> <b>(typically every 15 to 50 years)</b>

Please use this checklist or other form(s) of maintenance documentation when and where deemed necessary in order to ensure the long-term proper operation of the stormwater management facility.

*Note - Condition should be marked as Satisfactory (S) or Unsatisfactory (U). An explanation of corrective actions must be provided for all items marked as Unsatisfactory. The completion date of any corrective actions taken must also be documented.		
<b>Inspect the embankment (the dam/berm that holds water in the pond) and the emergency spillway (the location where water exits the facility in the event that the embankment is overtopped).</b>		
1. Does the vegetation appear to be healthy and adequately covering the embankment to prevent erosion? <b>Yes = Satisfactory</b>		
2. Are there signs that soil is eroding (washing away) on/from the embankment? <b>Yes = Unsatisfactory</b>		
3. Are there signs of animal burrows in embankment? <b>Yes = Unsatisfactory</b>		
4. Are there signs of cracking, sliding and/or bulging of the berm/dam? <b>Yes = Unsatisfactory</b>		
5. Are the drains (if any) blocked or malfunctioning? <b>Yes = Unsatisfactory</b>		
6. Are there signs of leaks or seeps on the embankment? <b>Yes = Unsatisfactory</b>

Inspection Items	Condition*	Comments/Corrective Action
7. Are there any obstructions of the emergency spillway(s)? <b>Yes = Unsatisfactory</b>		
8. Are there signs of erosion (washing away of soil) in or around the emergency spillway? <b>Yes = Unsatisfactory</b>		
9. Other (describe)?		
<b>Inspect the inlet and outlet structures and channels – these are the locations/structures where water enters and exits the pond.</b>		
10. Are the inlets and outlets and channels clear of debris and functional? <b>Yes = Satisfactory</b>		
11. Are trash racks clear of debris and functional? <b>Yes = Satisfactory</b>		
12. Has sediment accumulated at any of the inlet and outlet structures? <b>Yes = Unsatisfactory</b>		
13. Does the concrete/masonry appear to be in good condition? <b>Yes = Satisfactory</b>		
14. Do the pipes appear to be in good condition? <b>Yes = Satisfactory</b>		
15. Is the slide gate (if any) operating properly? <b>Yes = Satisfactory</b>		
16. Is the pond drain valve operating properly? <b>Yes = Satisfactory</b>		
17. Are there signs of erosion (washing away of soil) in the outlet channels? <b>Yes = Unsatisfactory</b>		
18. Other (describe)?		
<b>Inspect the bottom of the dry pond.</b>		
19. Is the vegetation healthy and adequately covering the dry areas to prevent soil erosion? <b>Yes = Satisfactory</b>
