- During the month of May, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 5 residential program visits.
- The SCDDO hosted an extended Affiliate Directors meeting to discuss how agencies are operating as
 vaccinations are available and the pandemic seems to be lessening. At the time of this meeting, mask mandates
 were just beginning to change. Most affiliates indicated they were taking a very conservative approach and not
 just returning to pre-pandemic practices. Most still required staff and persons served to wear masks if social
 distancing could not be maintained.
- SCDDO's new electronic medical record, Medisked, went live May 6. Staff are excited by the potential of this new software but are still in the process of working out all the bugs to get it functioning properly.
- The BOCC budget hearing for the SCDDO and other human services departments was held May 10th. SCDDO Director, Dee Nighswonger, presented the SCDDO budget to the County Commissioners. The budget is basically flat, no significant increases were requested. The County will adopt the final budget for calendar year 2022 in August.
- Contract negotiations with KDADS ended with a few victories for community developmental disability organizations (CDDO's). KDADS agreed to reorganize the workgroups to be more efficient; each workgroup will also have to develop a charter and priorities. KDADS will develop a vision for the IDD system to include stakeholder input. There will be a taskforce developed to work on CDDO Administration funding to develop a plan by August. Issues related to electronic signatures were worked out. State timelines were changed to business days, rather than calendar days. And, importantly, KDADS committed to addressing issues with the BASIS manual and policies on eligibility
