- During the month of January, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 2 residential program and 1 day program visit.
- Dee Nighswonger, SCDDO Director, was trained to administer COVID – 19 tests through Wichita State University’s Molecular Diagnostic Laboratory. Dee will serve as a back-up option for testing of staff, if they are unable to secure a test timely from other sources.
- The three Project SEARCH programs in Sedgwick County returned in-person in January. During the last semester, the Derby Project SEARCH site at McConnell Airforce Base had to switch to remote programming. The two Wichita Project SEARCH programs, at Sedgwick County government and Via Christi St. Joseph, have been operating in-person; although, the Sedgwick County site has struggled to find and maintain internships because so many County departments are working remotely.
- In January, clinical consultation service contracts were completed with Dr. James Vincent and Jody Patterson, LCP. The contracts will allow SCDDO staff to access clinical expertise when evaluating complex cases for eligibility determinations or ongoing development of appropriate community supports to address all identified needs of persons served.
