On the recommendations of Lee Barrier, on behalf of Public Works, Jennifer Blasi moved to accept the quote from Rural Water District No. 4, (RWD #4) in the amount of \$50,524.90. Tim Myers seconded the motion. The motion passed unanimously.

Sedgwick County is actively engaged in a road reconstruction project on 95<sup>th</sup> St. S. between 119<sup>th</sup> and 135<sup>th</sup> Sts. W. (CIP Project R359). As is typical, the reconstruction requires utilities to relocate outside the impacted work area. In this case, Rural Water District #4 has a waterline in a private utility easement that county work encroaches upon. The county is required by law to pay the utility their cost and reasonable overhead to relocate the line because it lies in an existing private easement obtained prior to the acquisition of extended public right-of-way.

The water district utilizes their own contract forces to maintain, construct, and relocate their waterlines and appurtenances.

### **Questions and Answers**

Brandi Baily: So it says projects that qualify will be funded by ARPA money. These are just on-call services that are specifically for ARPA projects?

Joe Thomas: They are for all projects but in particular we're needing to establish this on-call remodel services again with as many vendors as we can because of all of the new projects being funded by ARPA. They are for both the ARPA and non-ARPA projects. We just don't know how many of each we will have.

Anna Meyerhoff-Cole: How will they determine which vendor to use? Will they price them out with all of them?

Joe Thomas: What they'll do is look at pricing, their scheduling, and then each of these may have a specialty to a particular project that is being done. So these factors will be considered.
