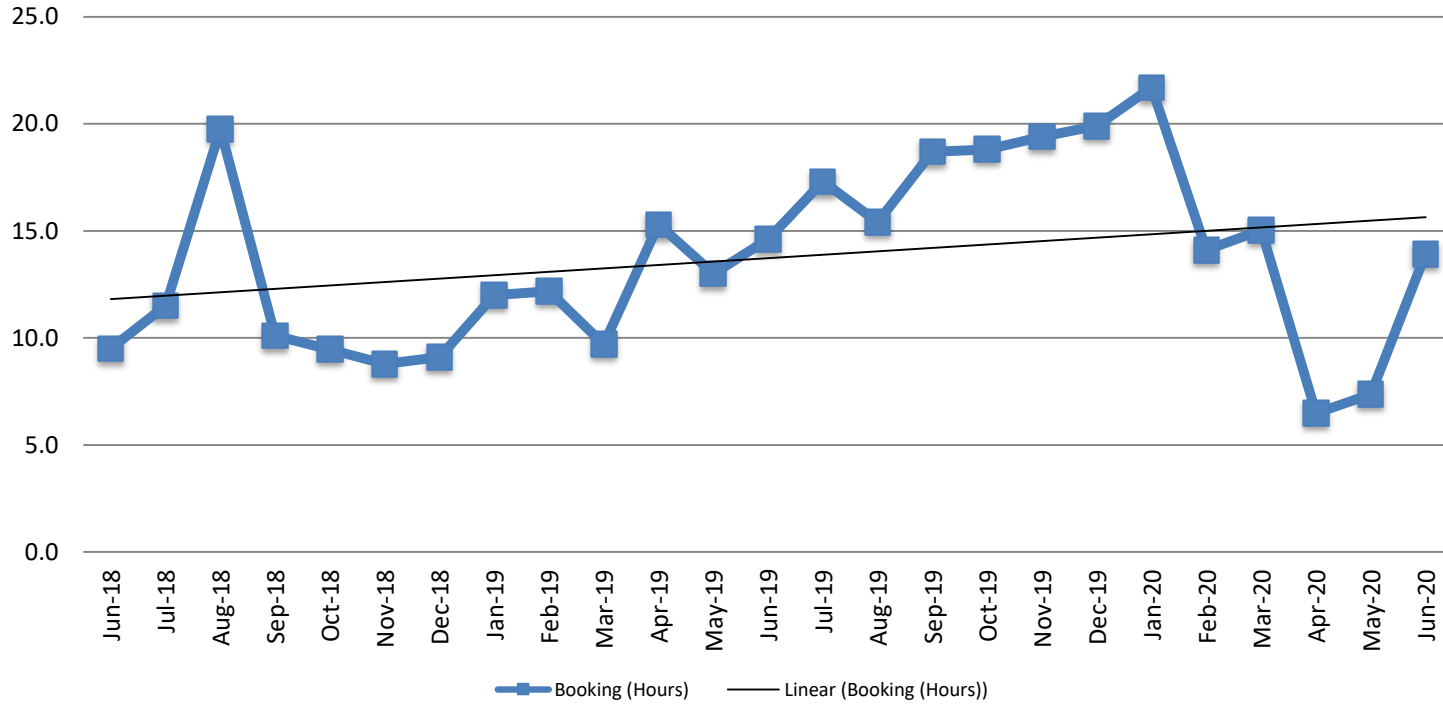

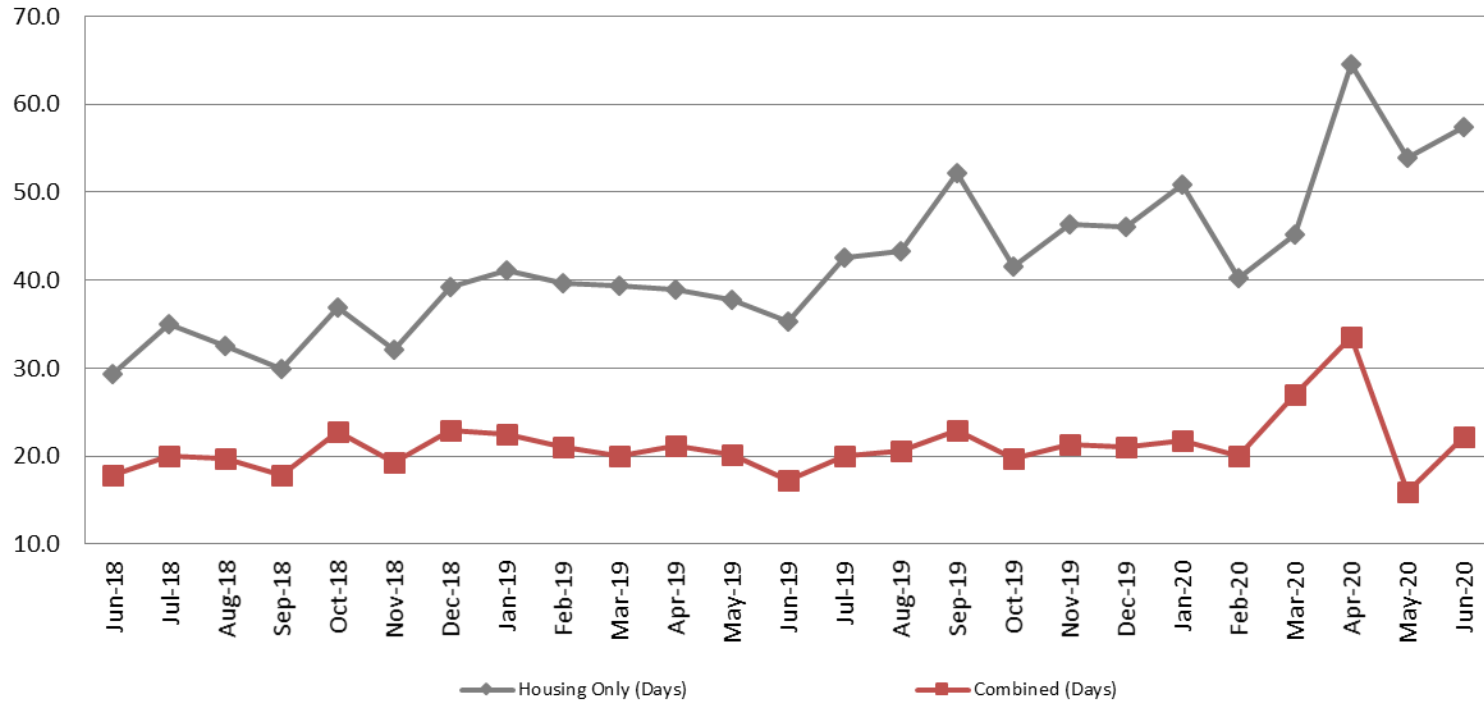

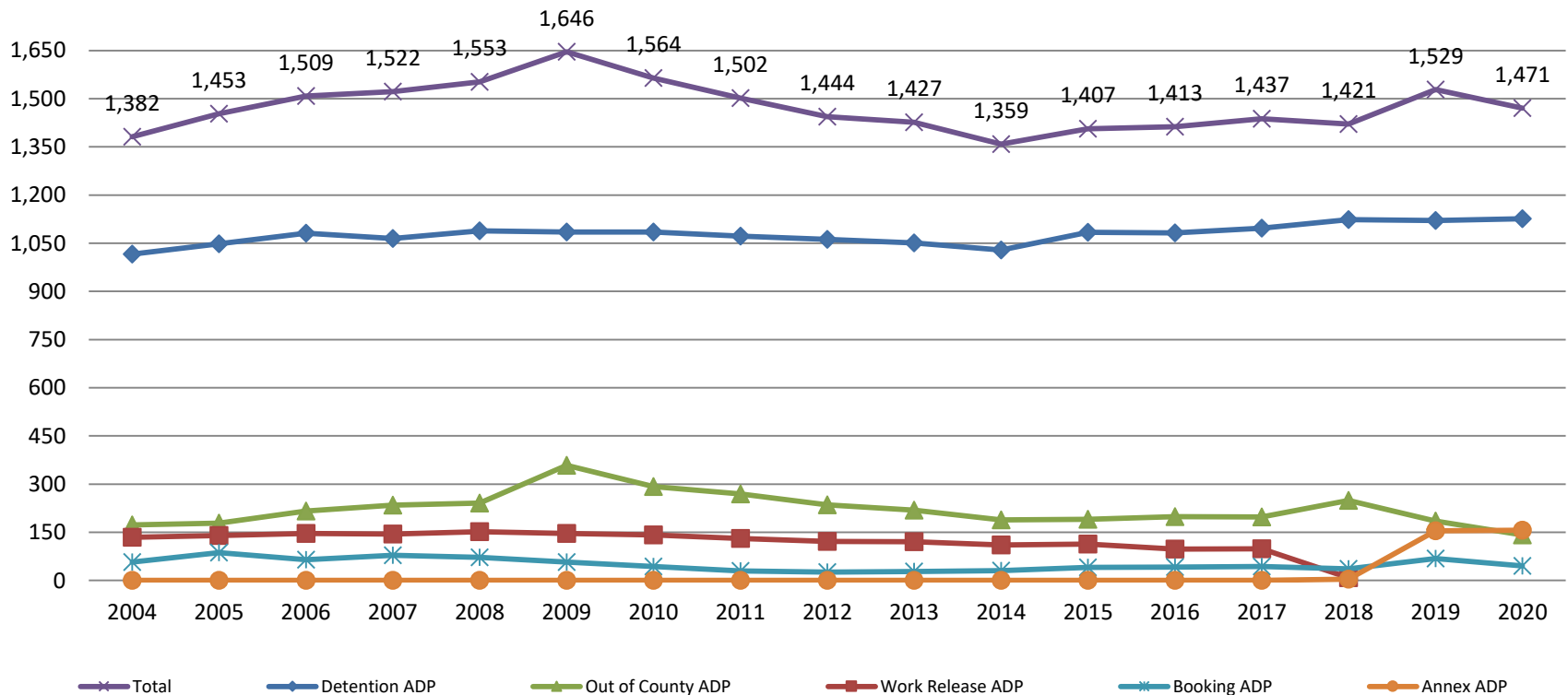

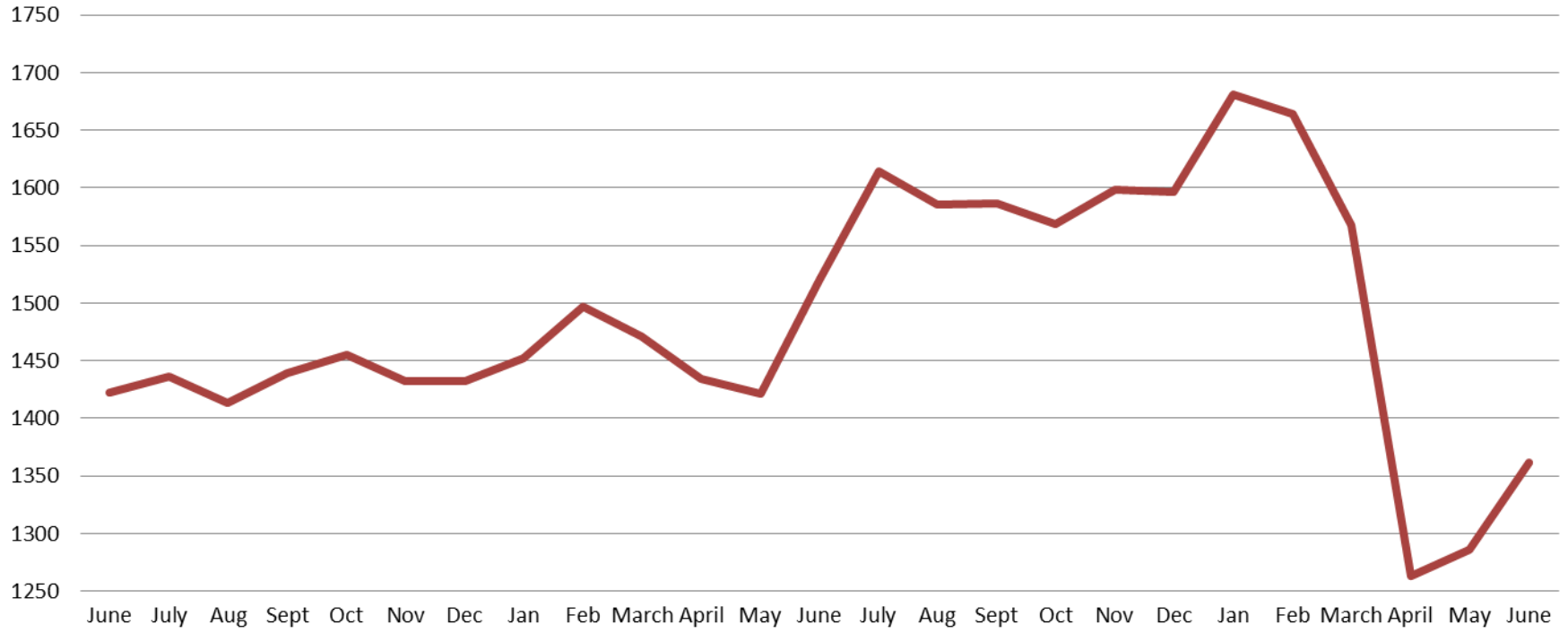

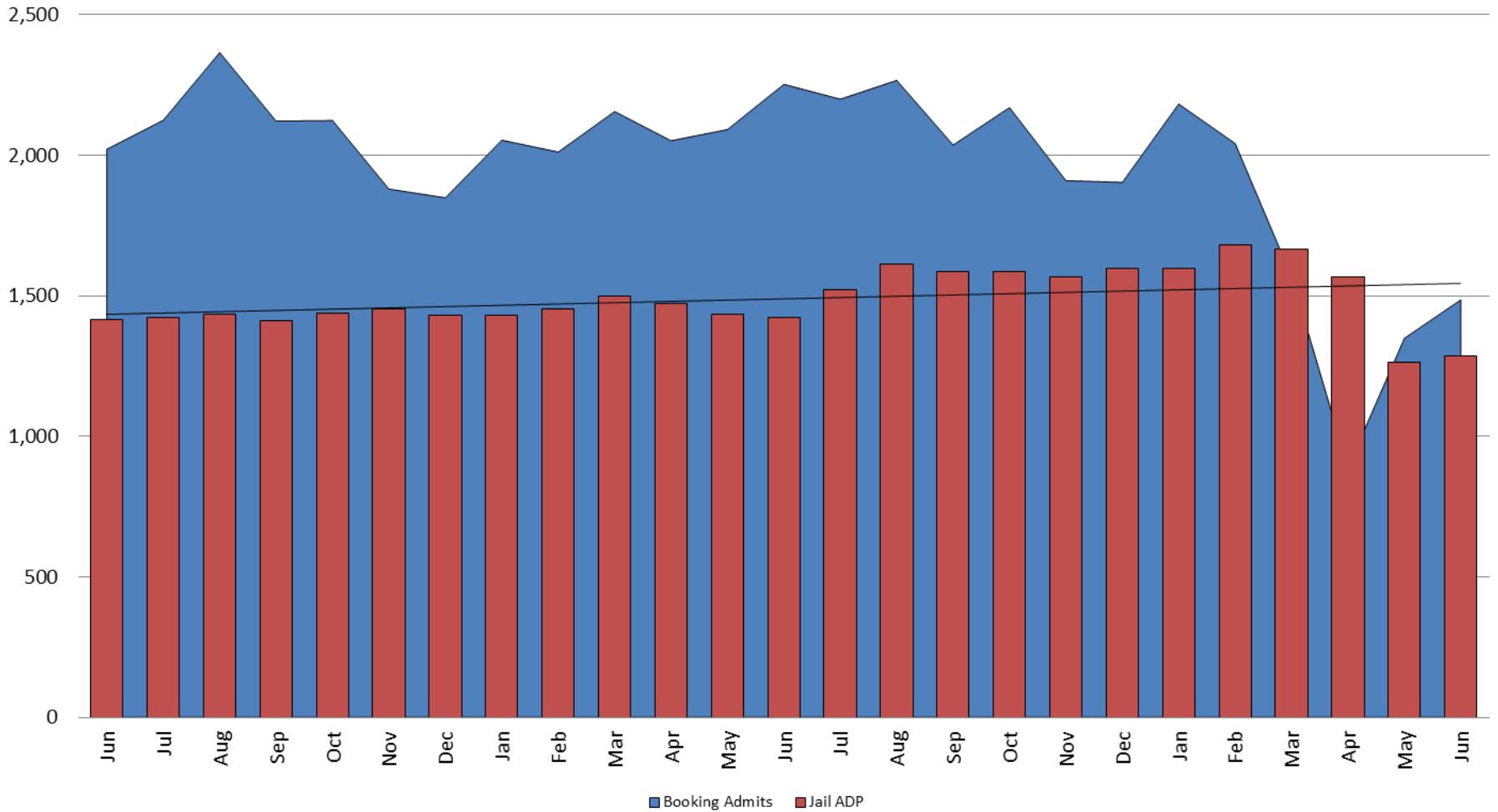


## TOTAL MONTHLY ADP: JAIL (Booking, Detention Facility, Annex, & Out of County) June 2018 - present



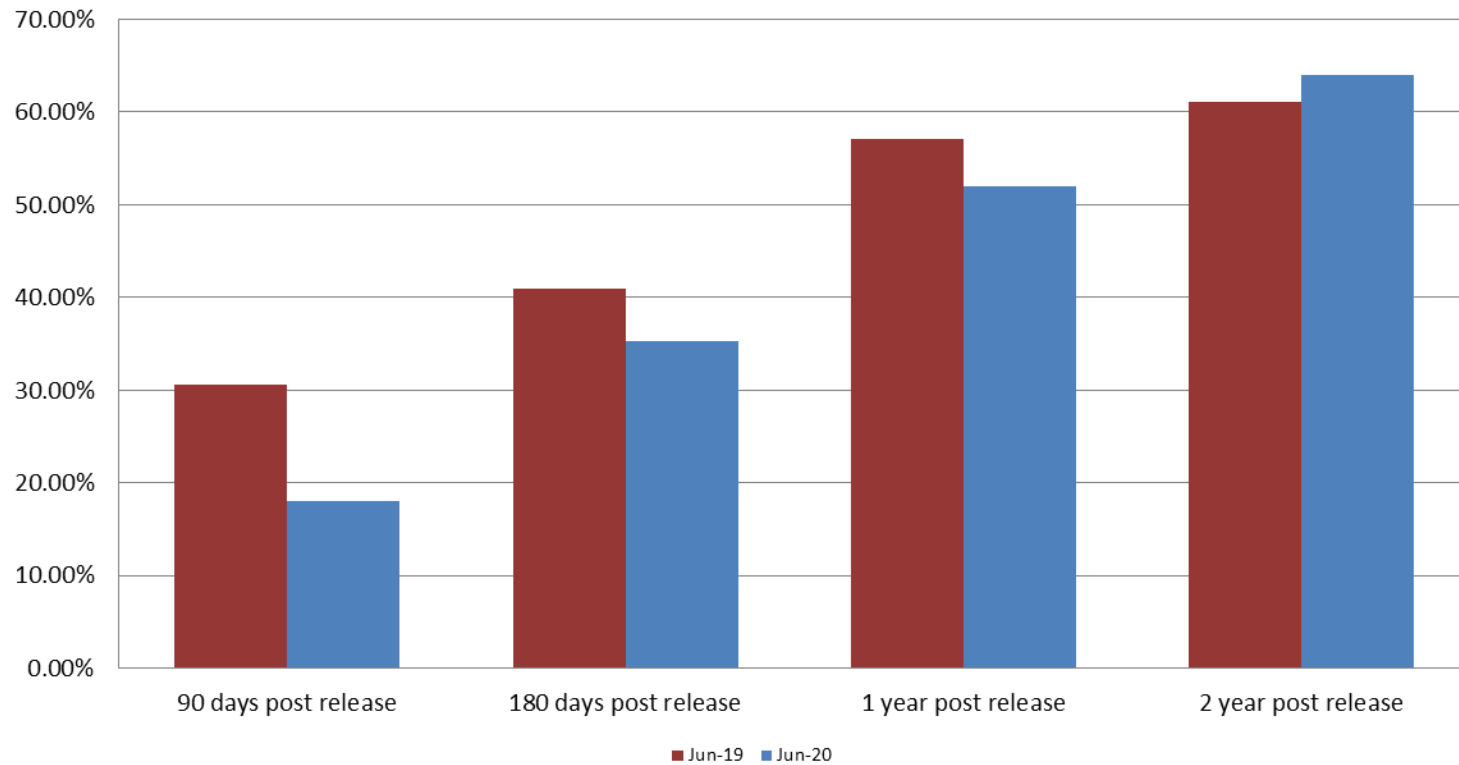

## Percent of released inmates rearrested June

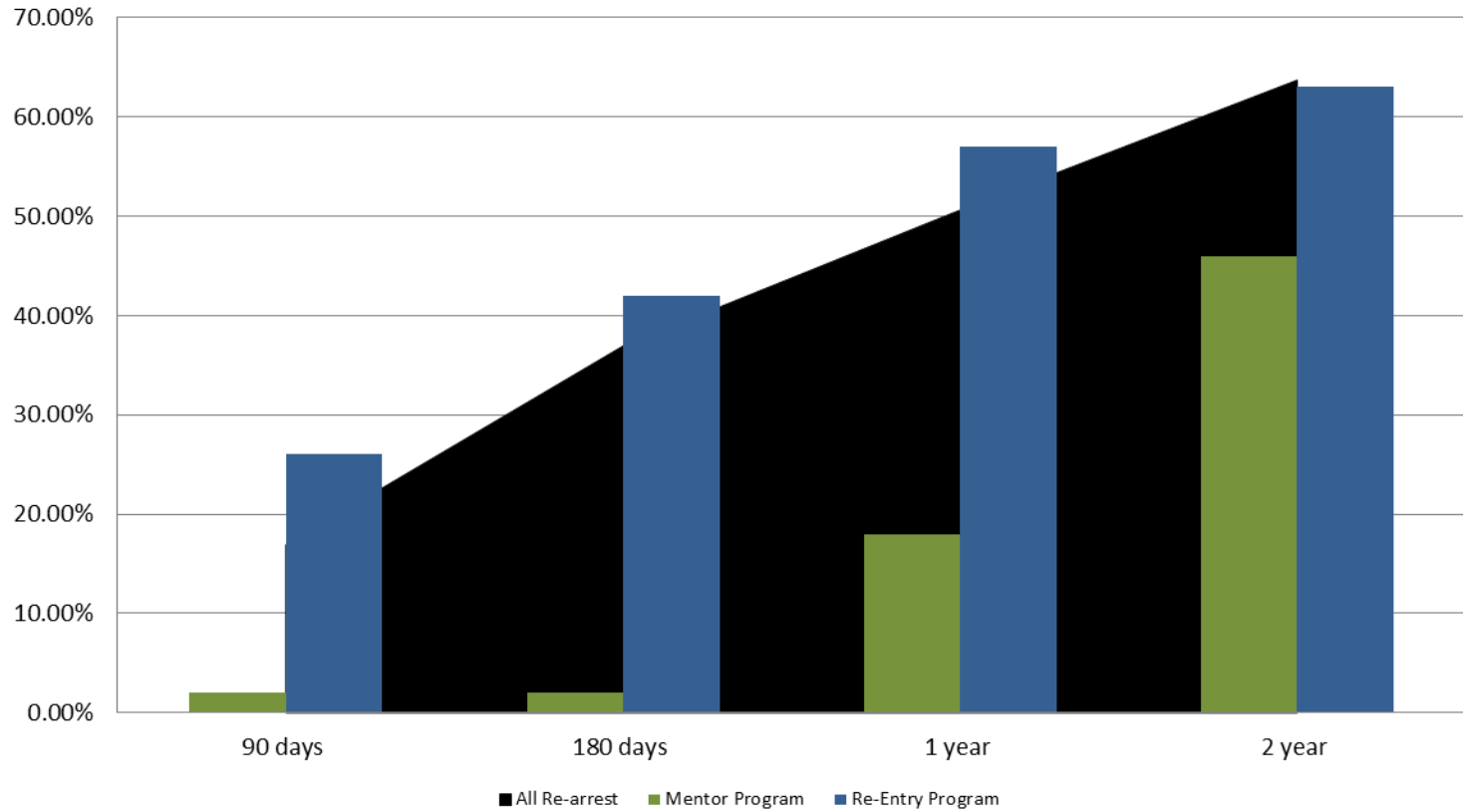

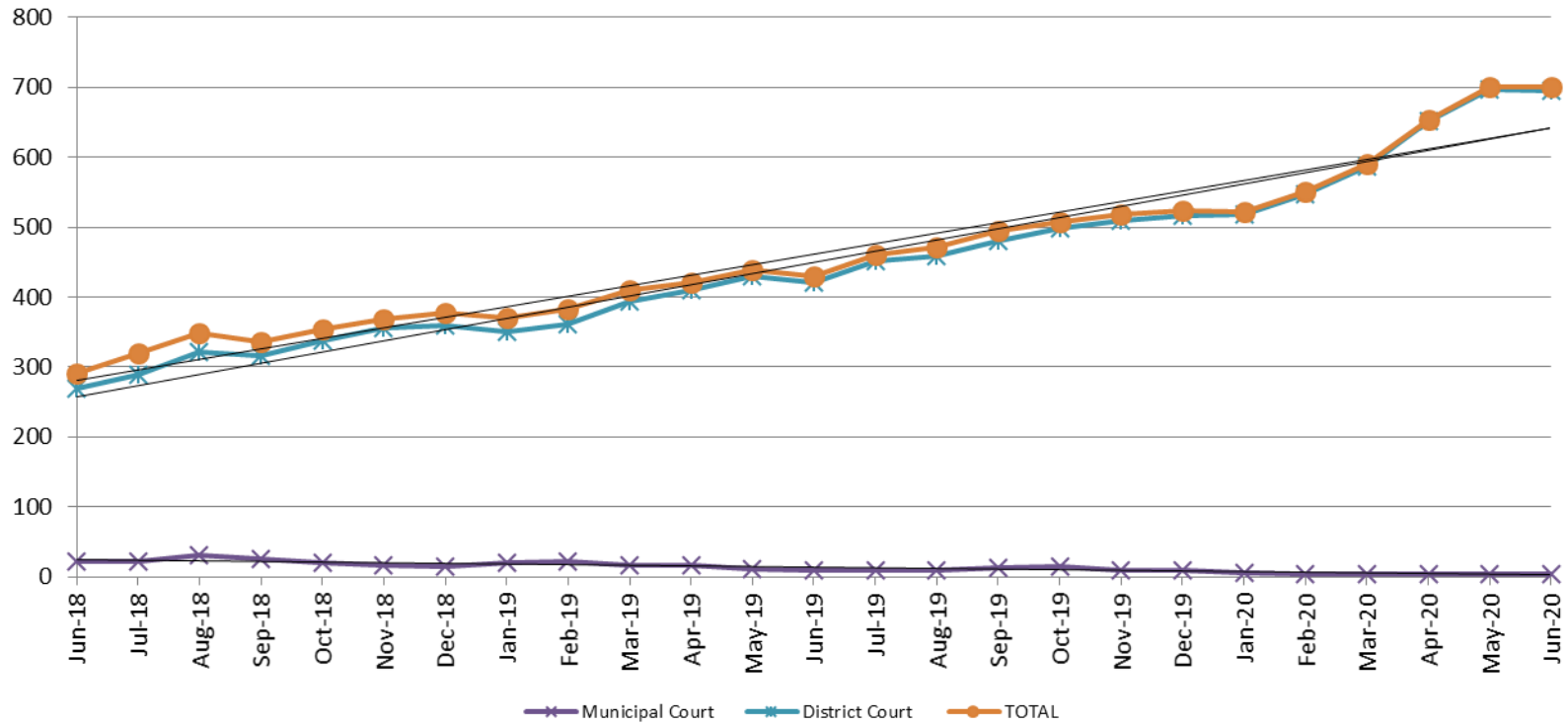

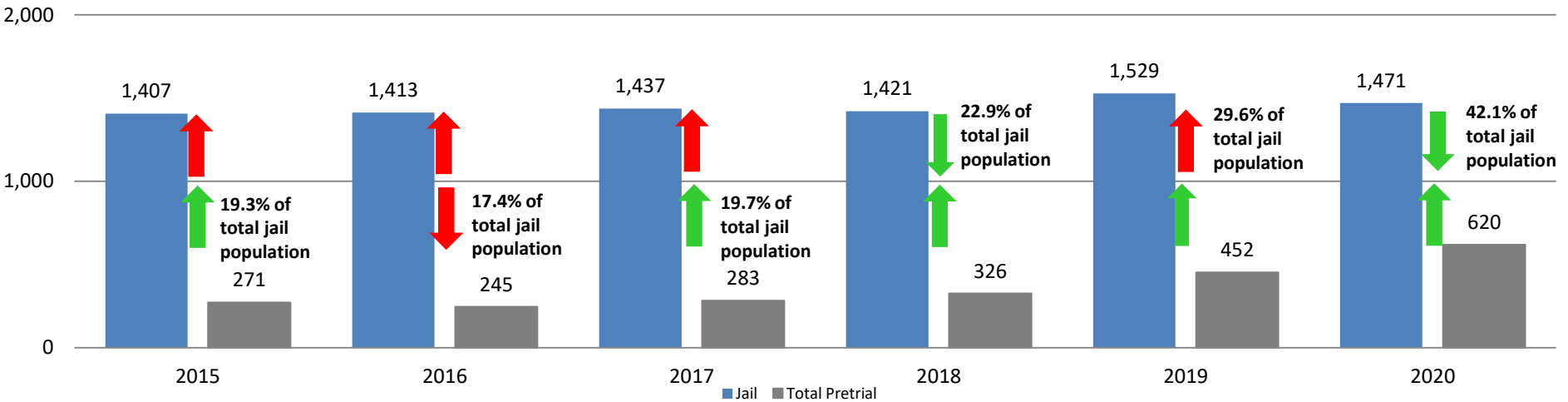

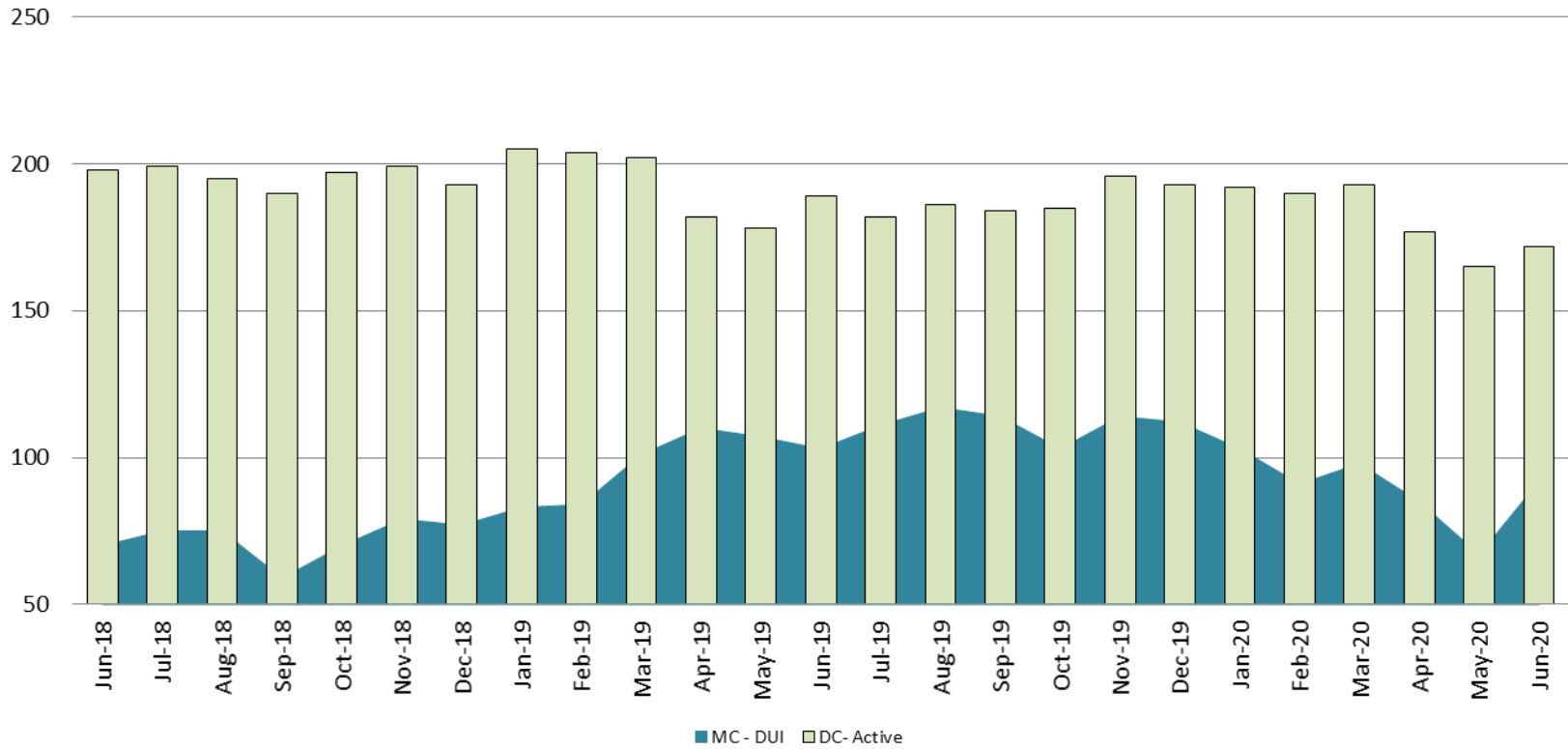

## Total Annual ADP: 2015 - present



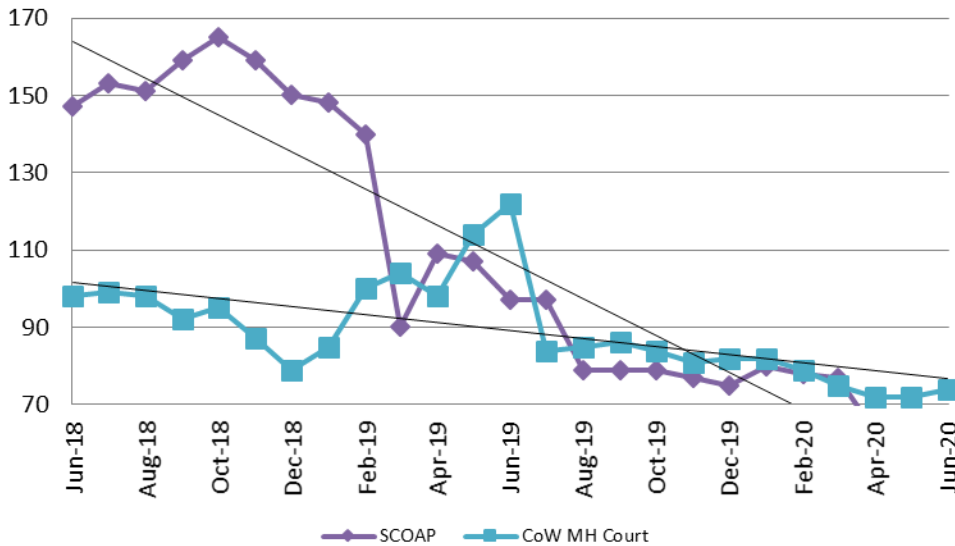

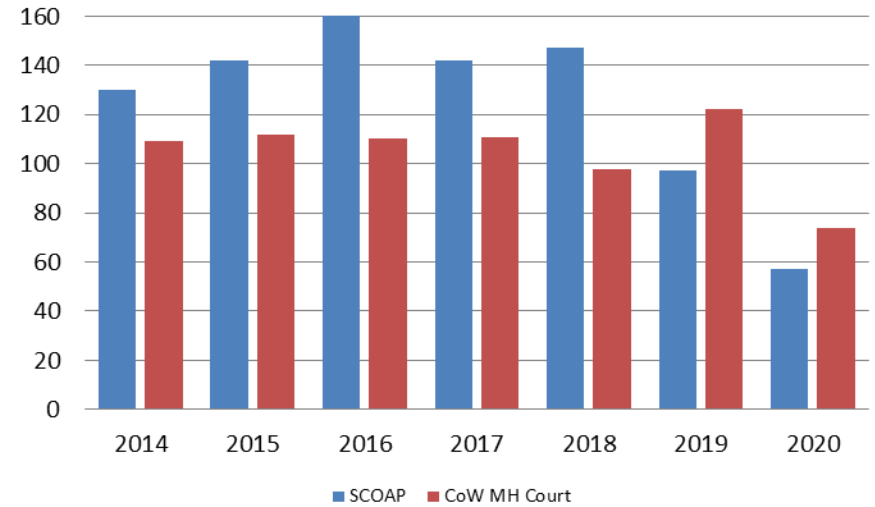

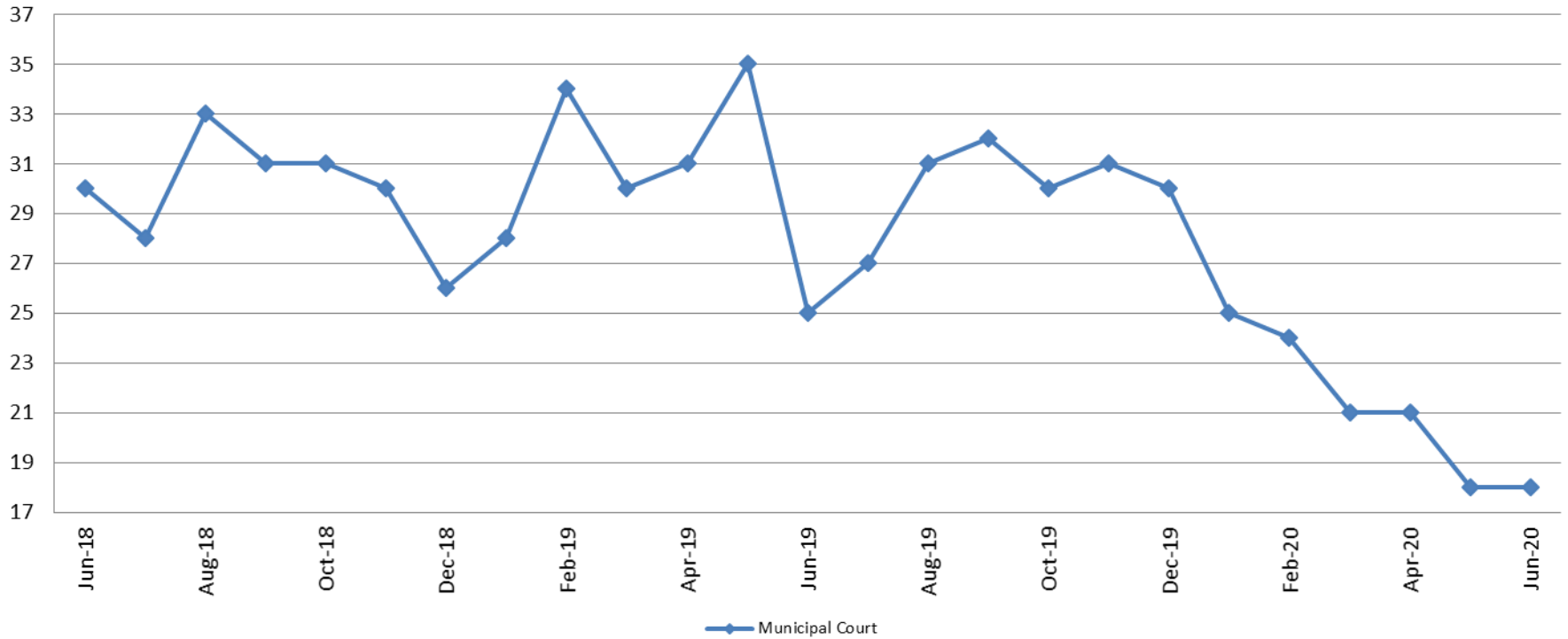

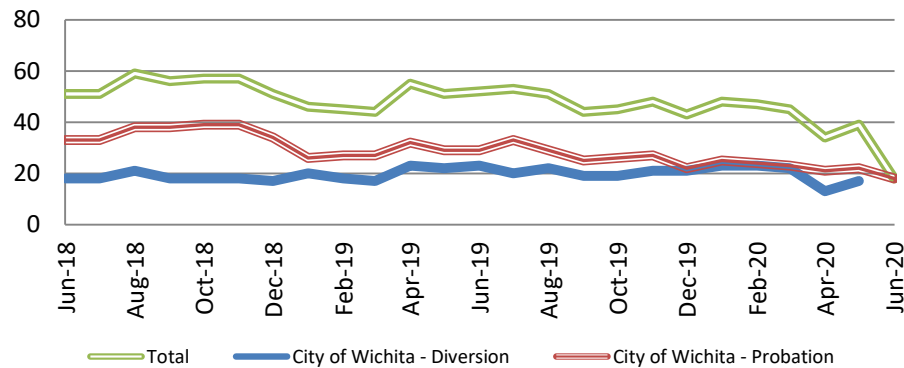

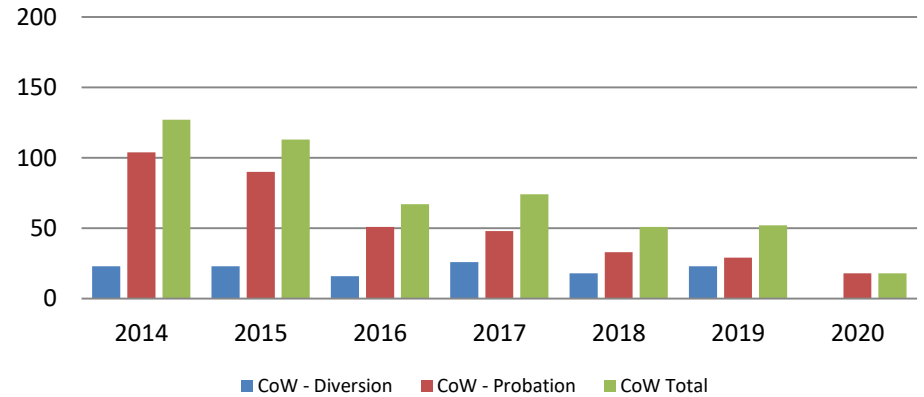

## Drug Court - City of Wichita ADP: June 2018 - present



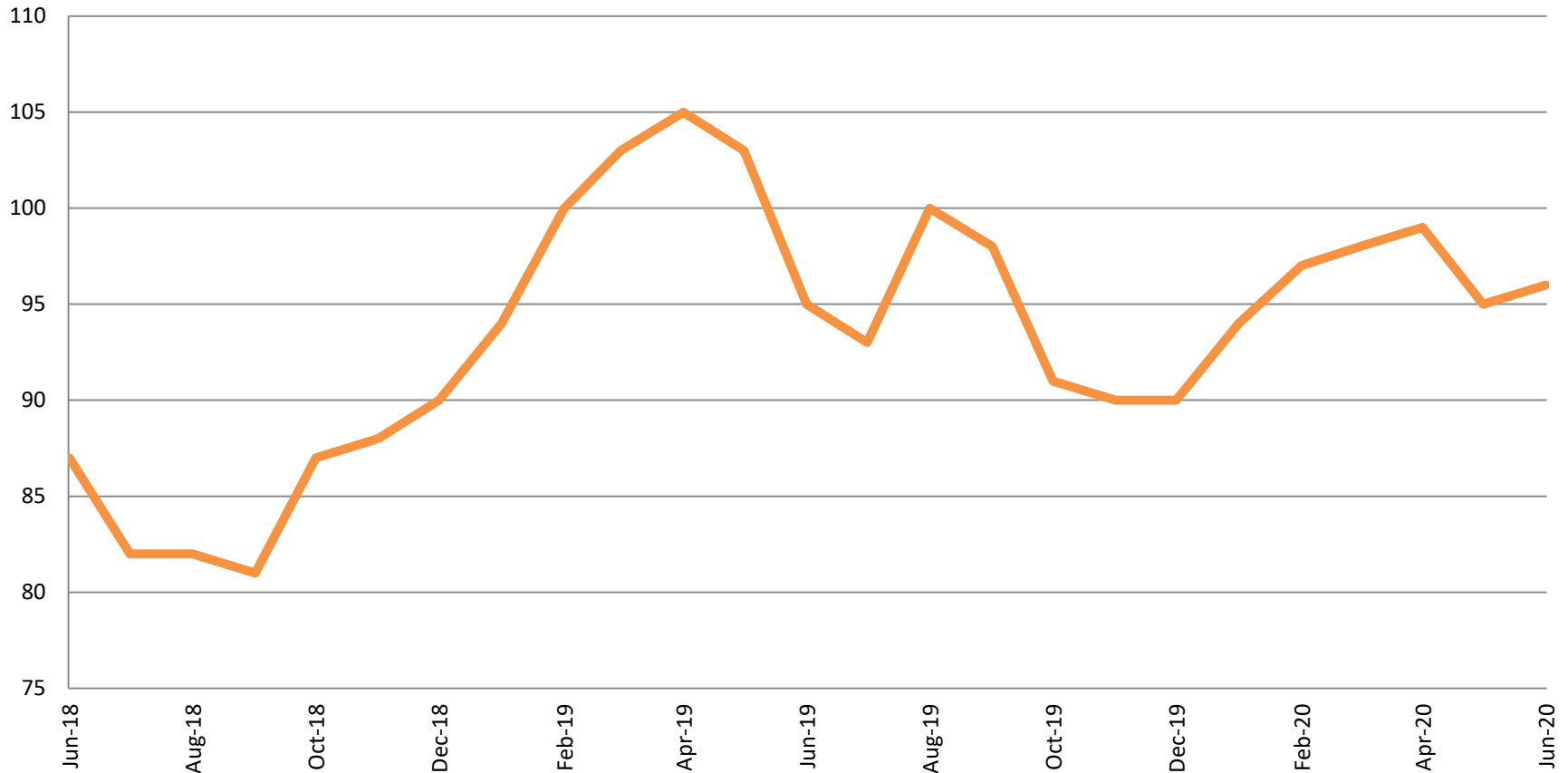

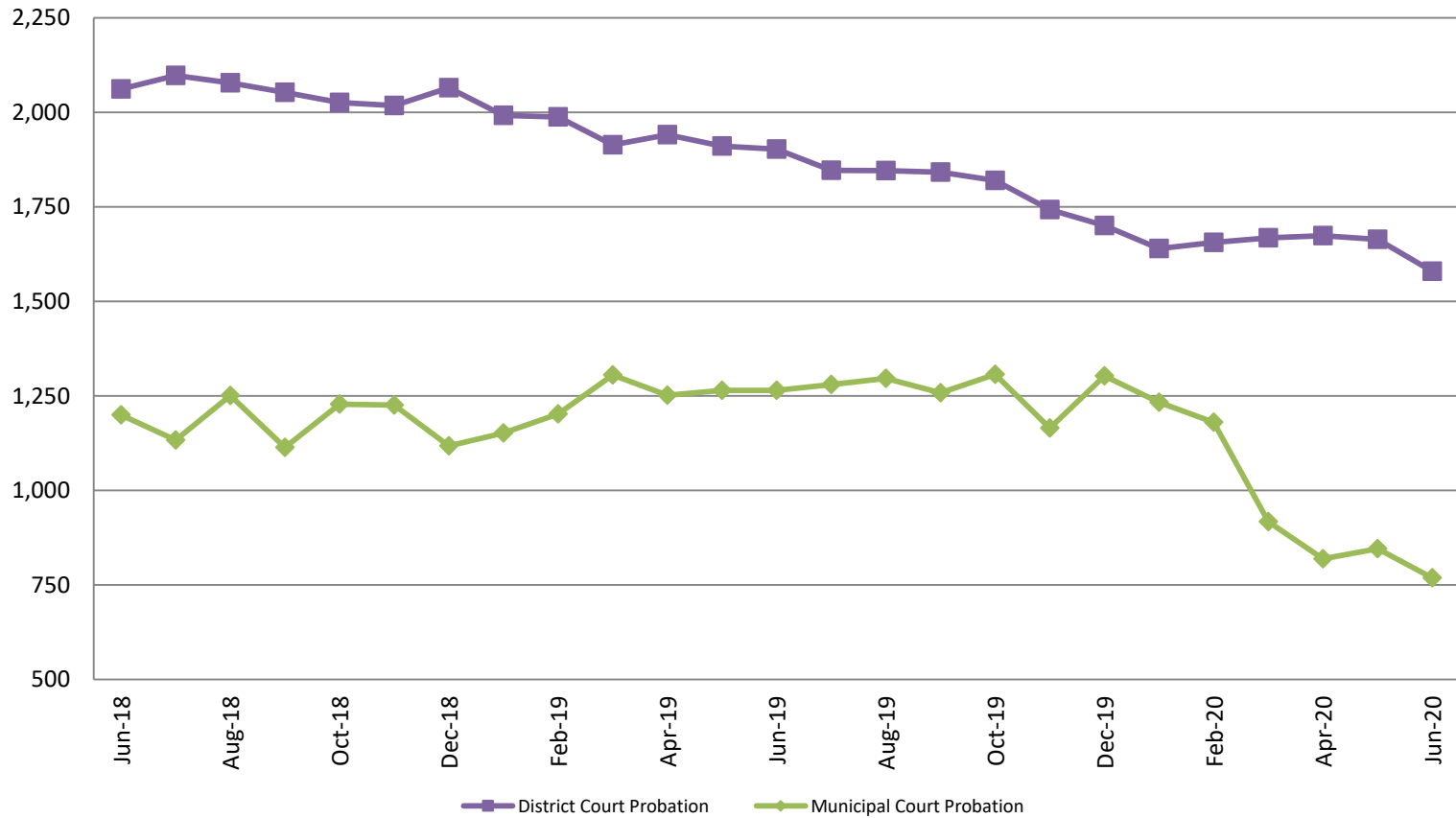

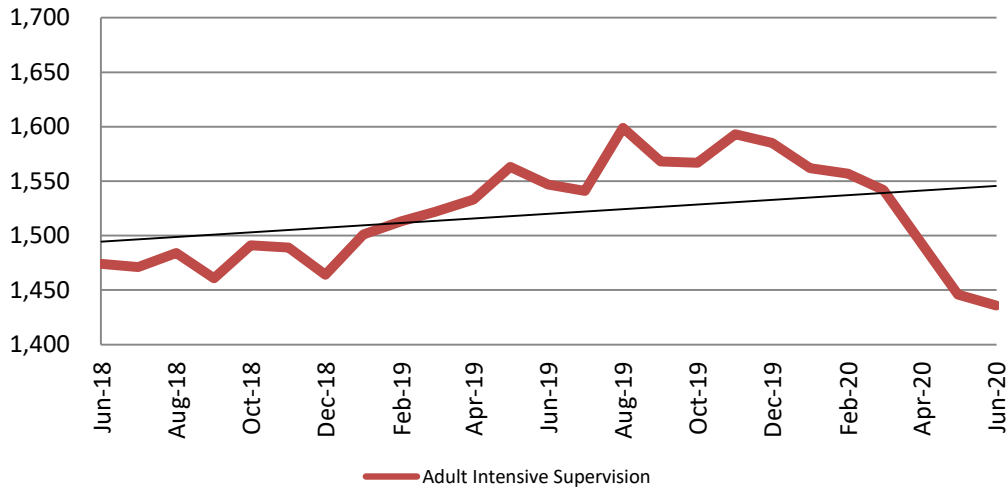

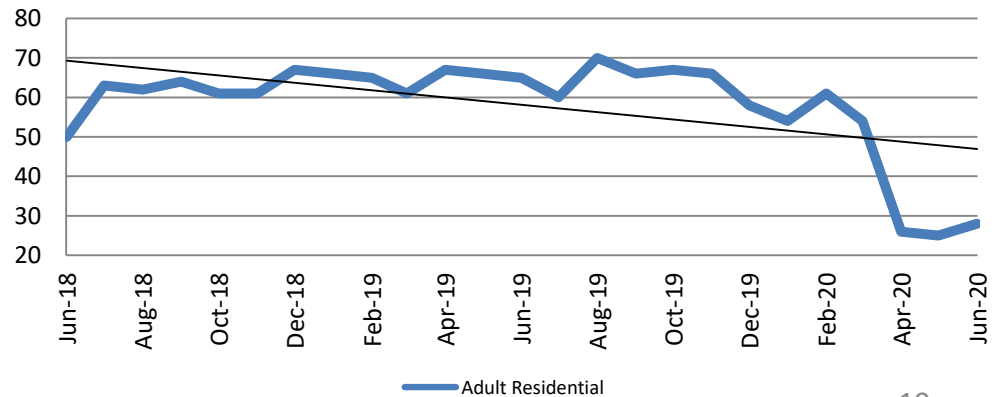

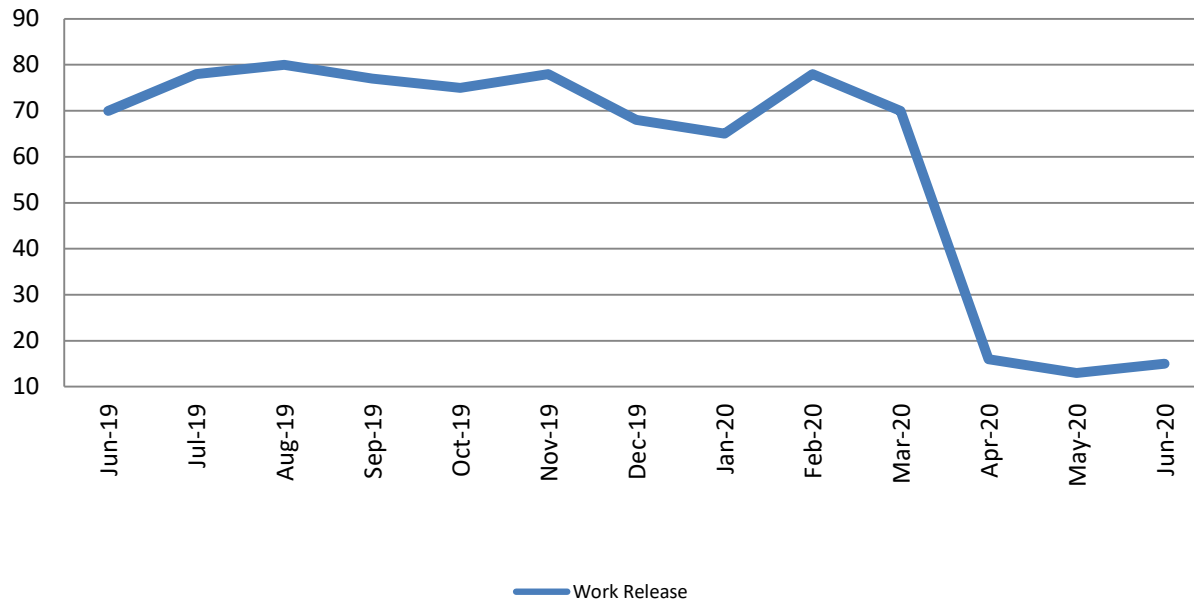

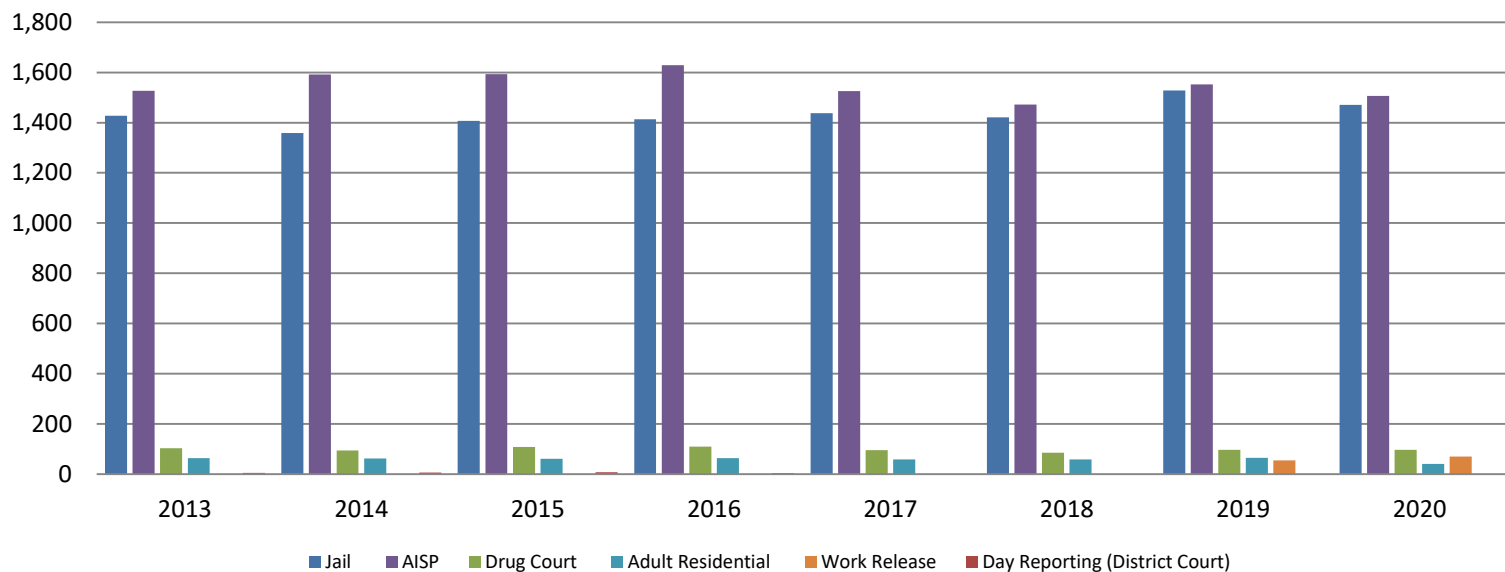

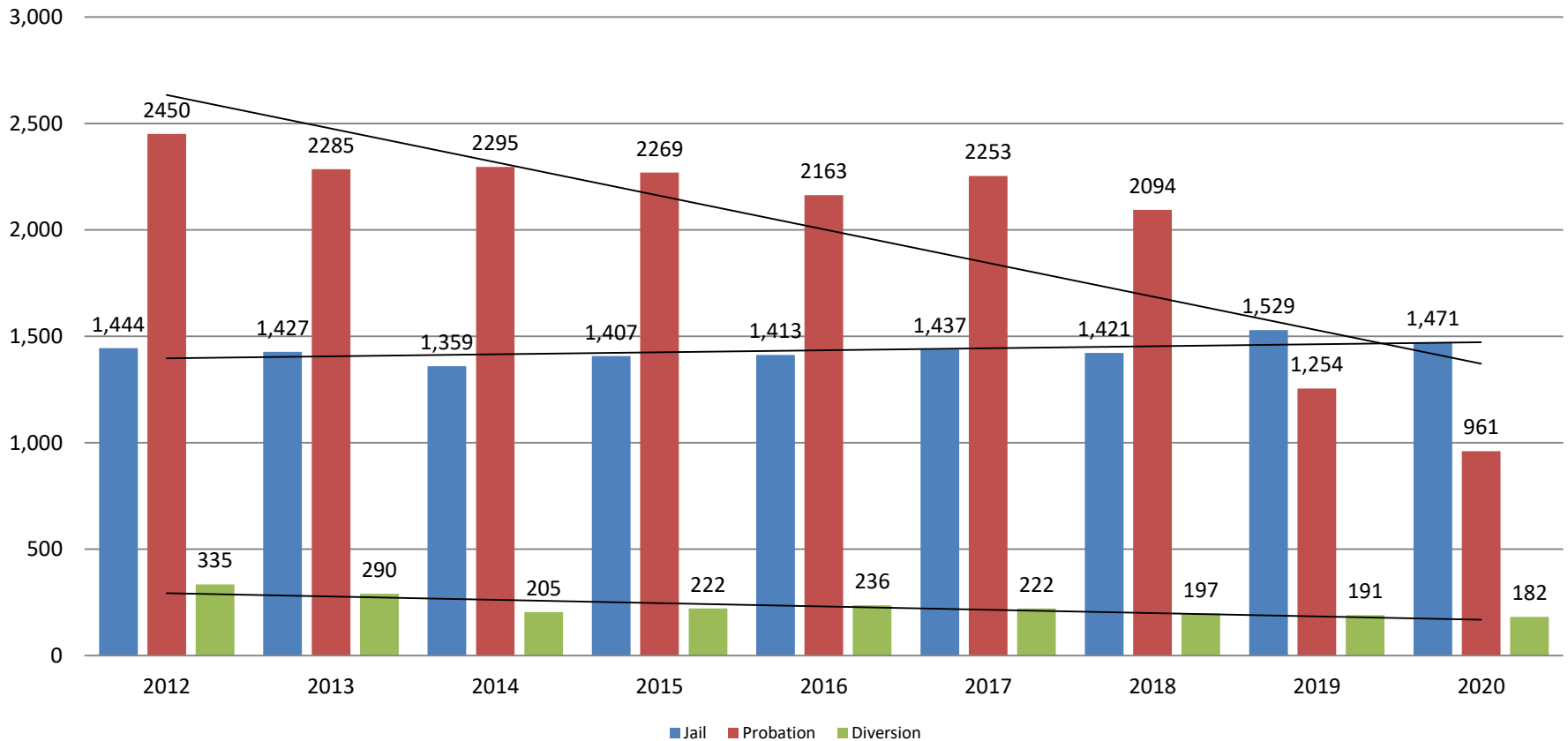

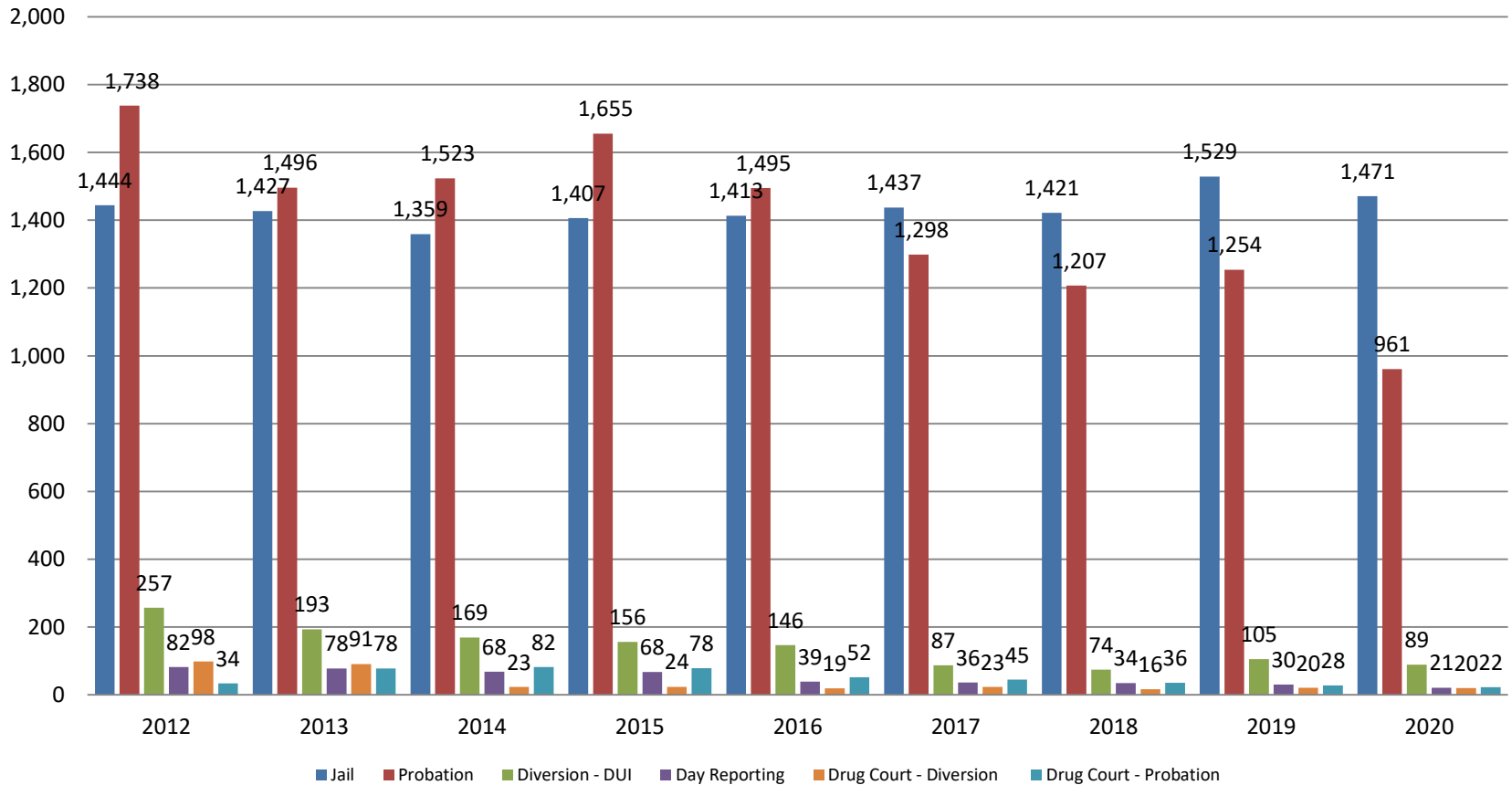
## Total Annual ADP: 2012 - present

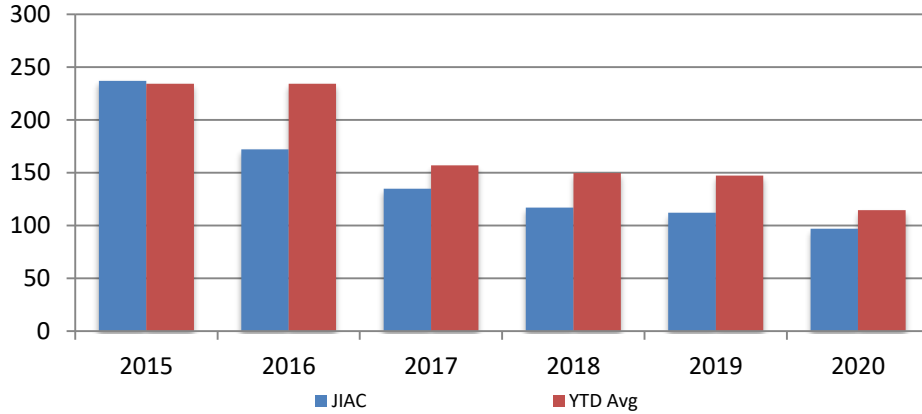
