On the recommendation of Tammy Culley on behalf of Fire District 1, Anna Meyerhoff-Cole moved to accept the bids at the rates listed above for a contract period of two (2) years with two (2) one (1) year options to renew from the following vendors:

Casco Industries (Cade Smith) for Item 1;

Shinka, LLC dba Jerry Ingram Fire & Rescue for Item 2;

Ed. M. Feld Equipment Co., Inc. dba Feld Fire Equipment for Item 3;

1st Due Emergency Response Solutions LLC dba 1st Due ERS for Items 4 and 9;

Casco Industries, Inc. (Mark Riddle) for Item 8; and

Municipal Emergency Services for Item 10.

Jennifer Blasi seconded the motion. The motion passed unanimously.

The personal protective equipment (PPE) for this bid contract includes the following structural firefighting accessories: structural protective boots, gloves, helmets, hoods, and suspenders. These items are designed to be worn in conjunction with structural firefighting coat and pants to provide firefighters with the maximum protection against heat and particulates per NFPA 1971 standards. These items are in constant need of replacement during the course of a firefighter's career due to normal wear and tear and useful life expectancy of the PPE.

Sedgwick County Fire District 1 has learned from conversations from regional vendors and sales associates that the Bullard UST6F Helmets (Items 5-7) are being phased out of service. The Bullard replacement model was wear tested by our people here at Sedgwick County and the decision was made to switch to the Cairns Model 880 Helmet. The Cairns 880 Helmet is a very durable and comparable to the Bullard brand and the crews have determined this helmet to be more comfortable and lighter, which on extended emergency scenes, is very important. The Cairns 880 is very competitive in price to the Bullard. Also, this information was discovered after the bid process was initially started.

## Notes

Sedgwick County Fire District 1 has worked with each of these vendors in the past and they continue to provide Fire District 1 with the most current safety equipment to keep the firefighters as safe as possible.

The average annual spend was \$30,500.00.
