2. ROOF TOP UNIT 2:

The Roof Top Unit 2 was replaced during the summer. Any Work or notes associated with the replacement of this unit will no longer be included in the Scope of Work for this project.

The existing system controller for the Time Clock will temporarily be relocated to Room 219, and then shall be relocated to the Property Room when the work is complete. The county will move the Time Clock; the General Contractor will be responsible for providing electrical service at each time clock location.
