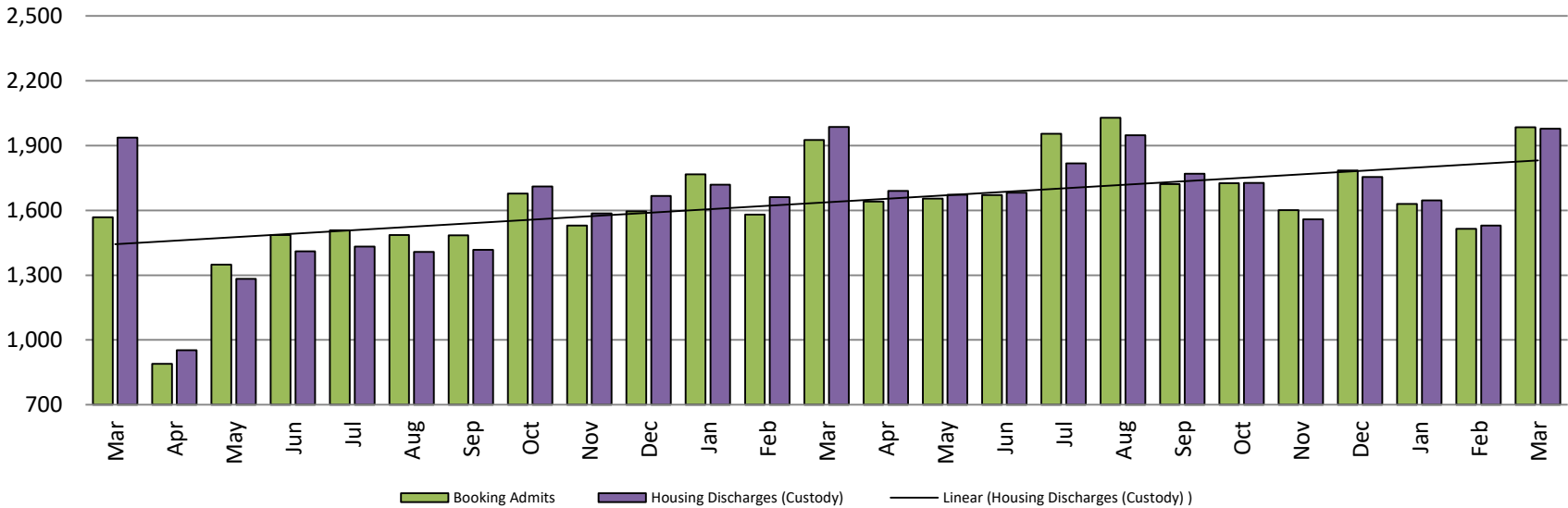

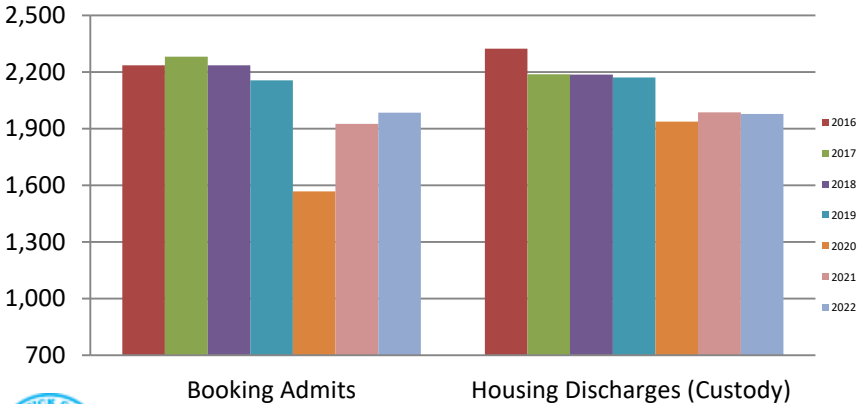

### Bookings Year over Year: Month of March



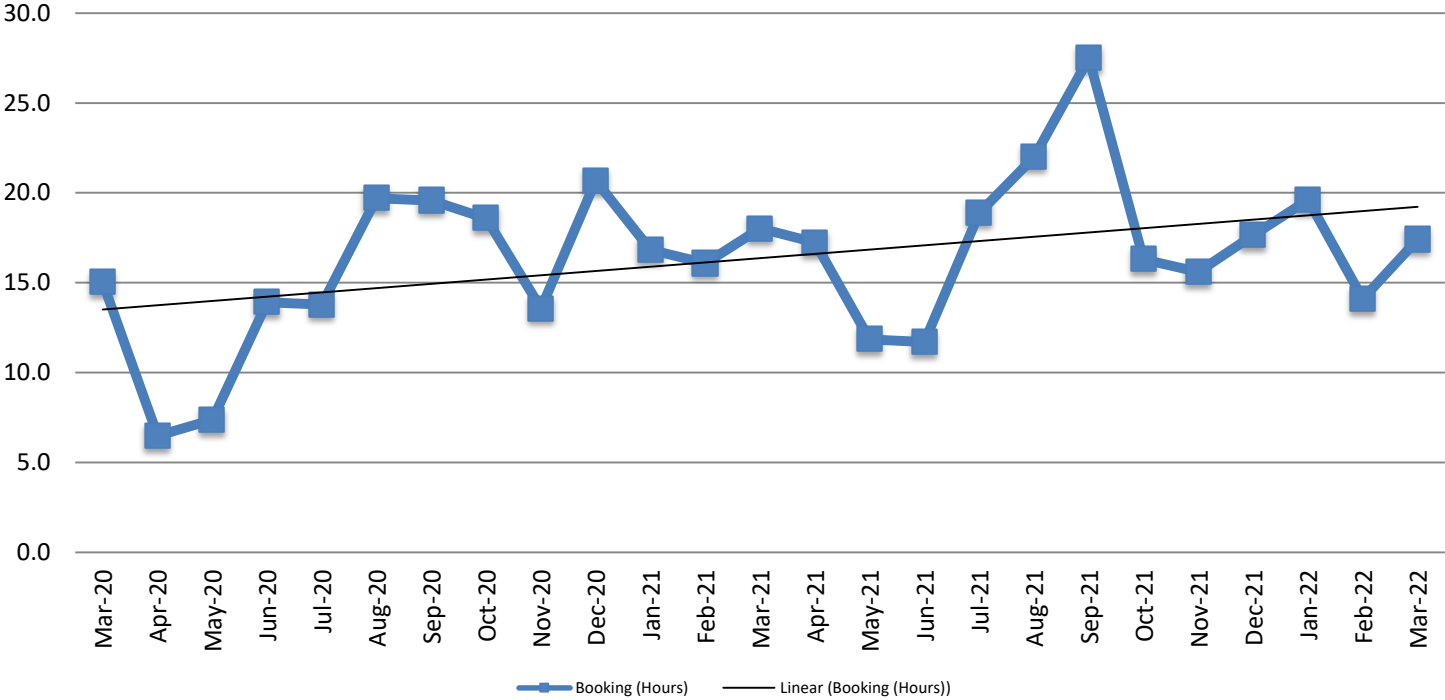

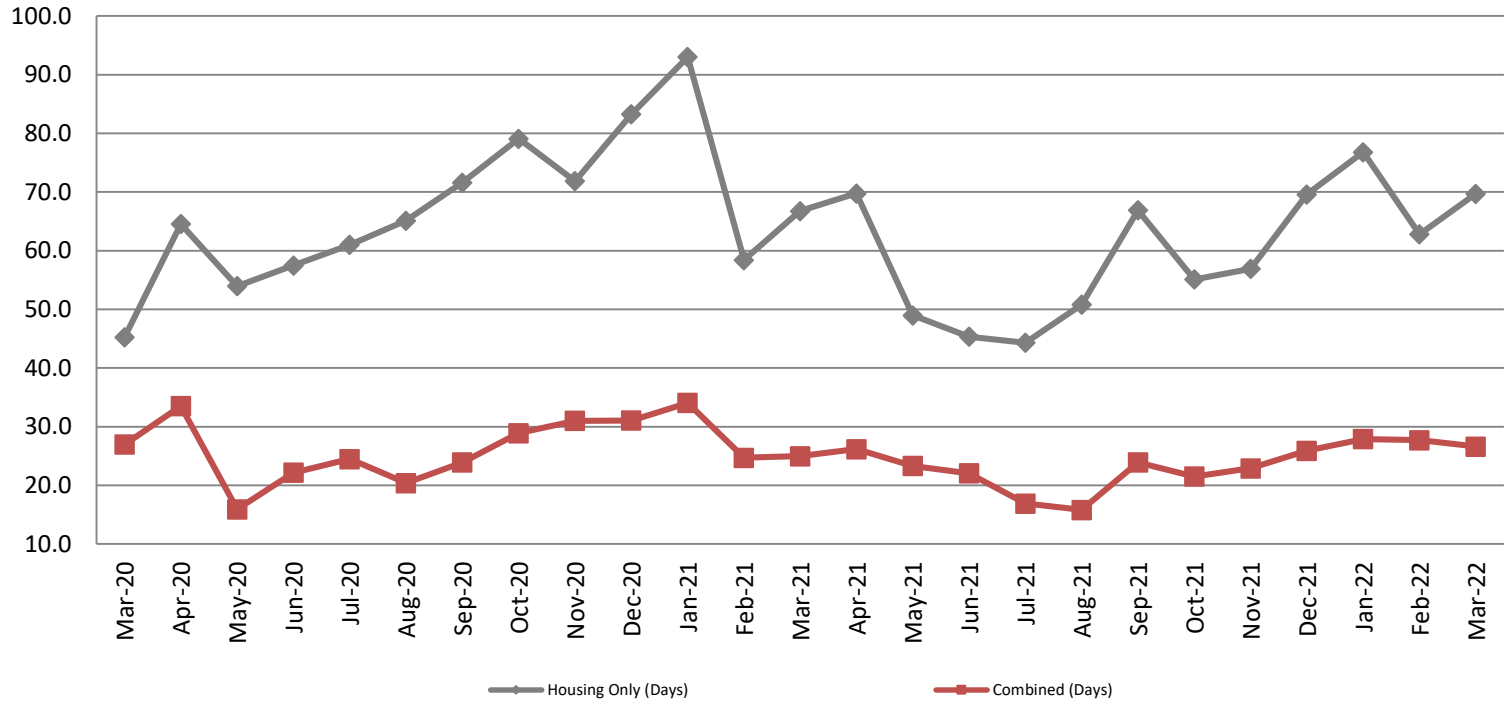

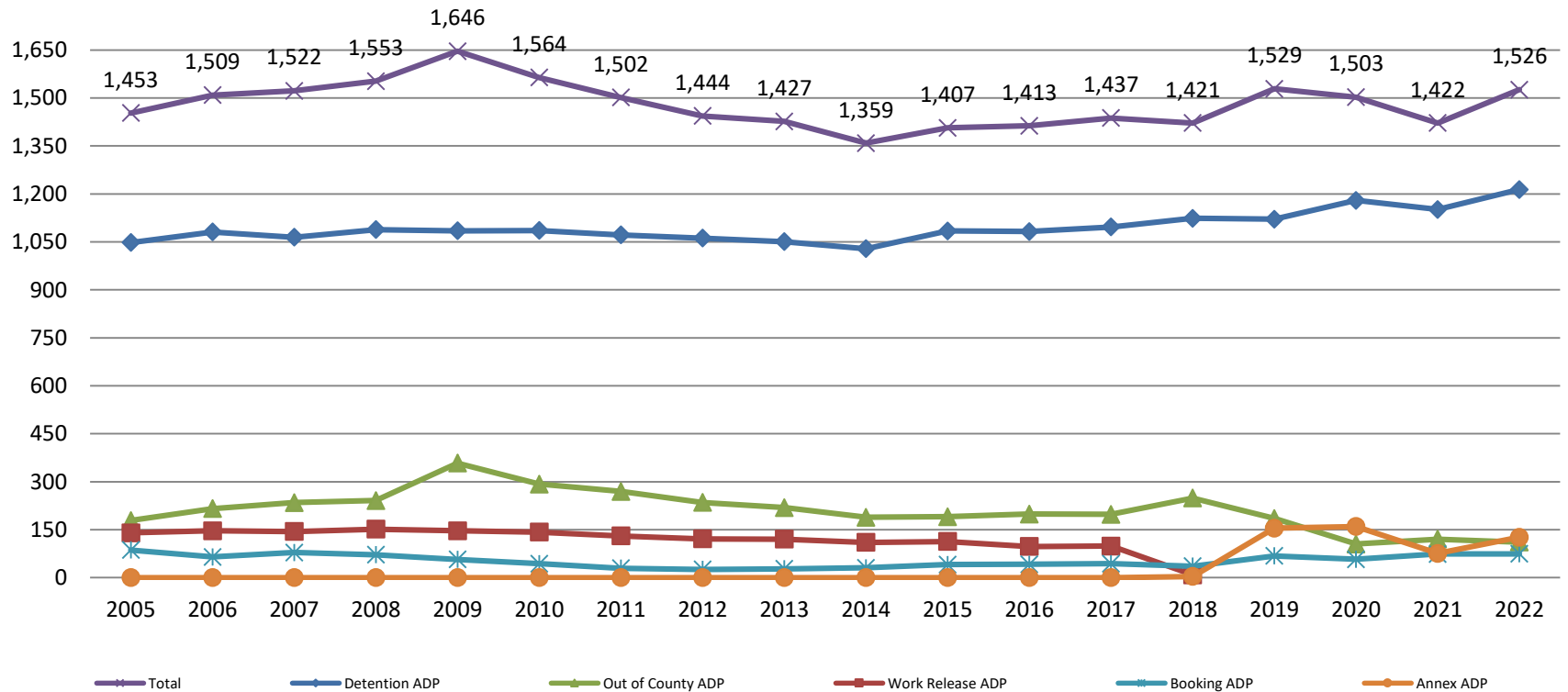

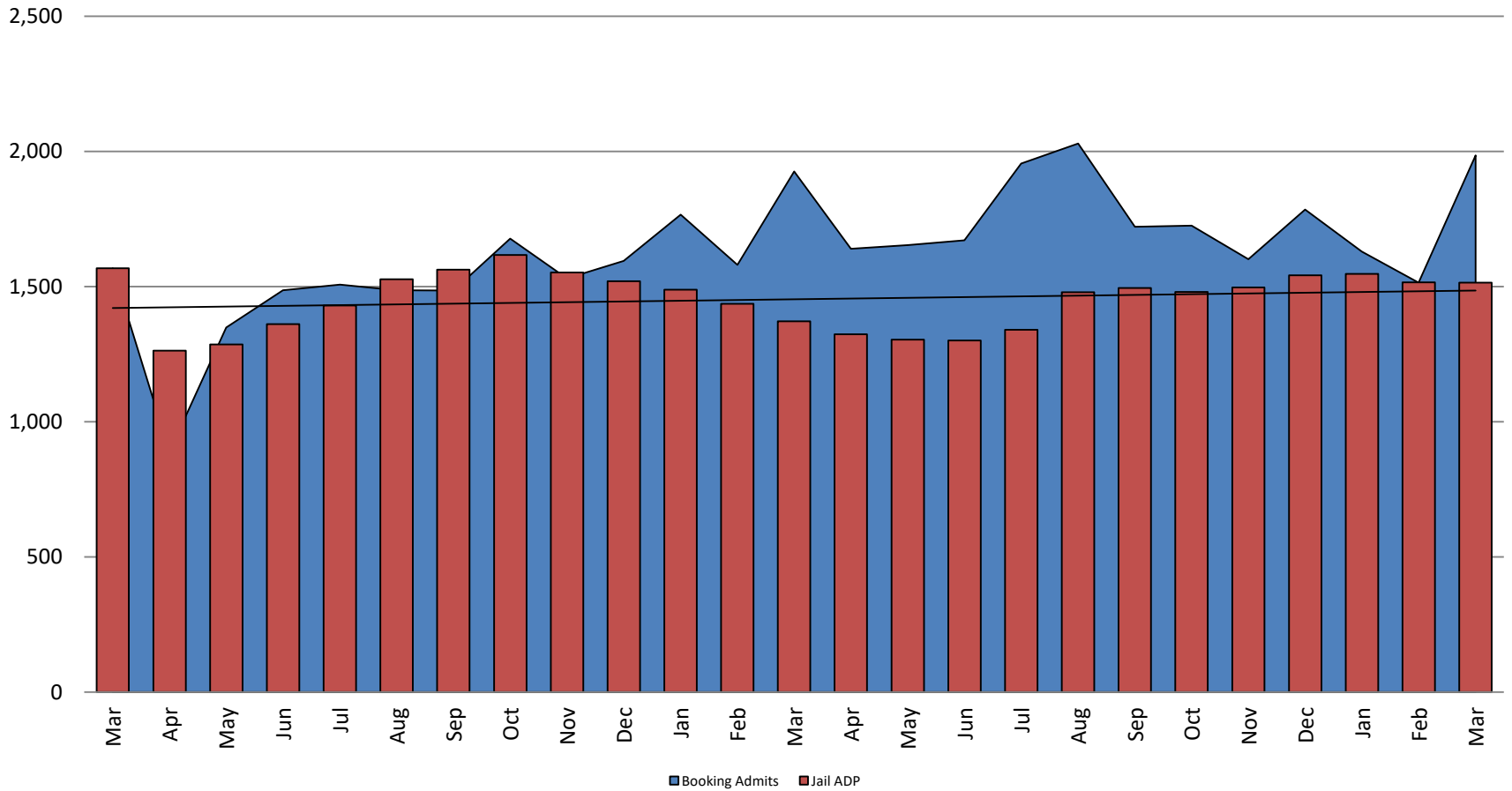


# TOTAL MONTHLY ADP: JAIL (Booking, Detention Facility, Annex, & Out of County) March 2020 - present



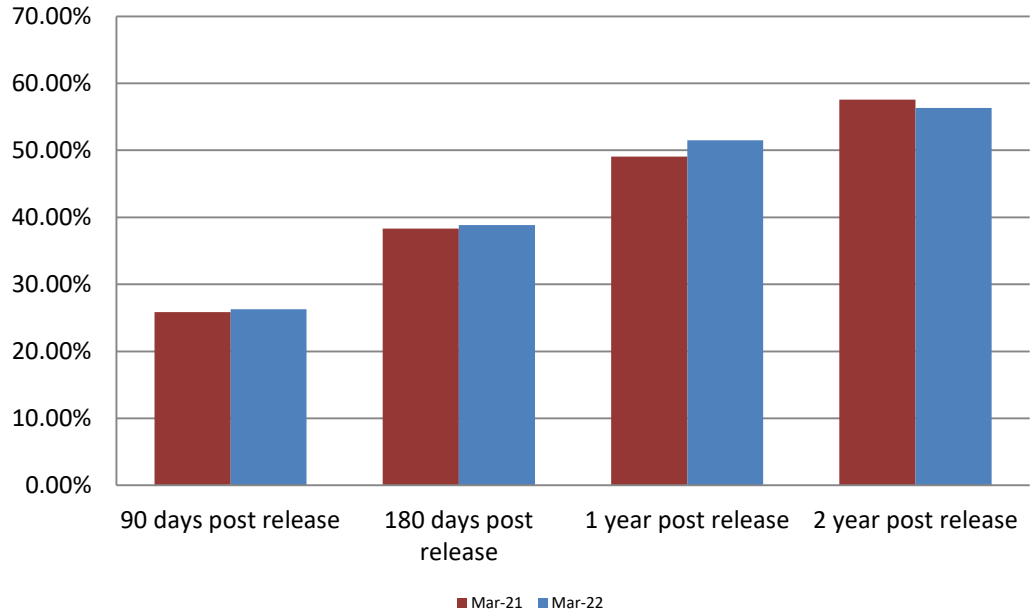

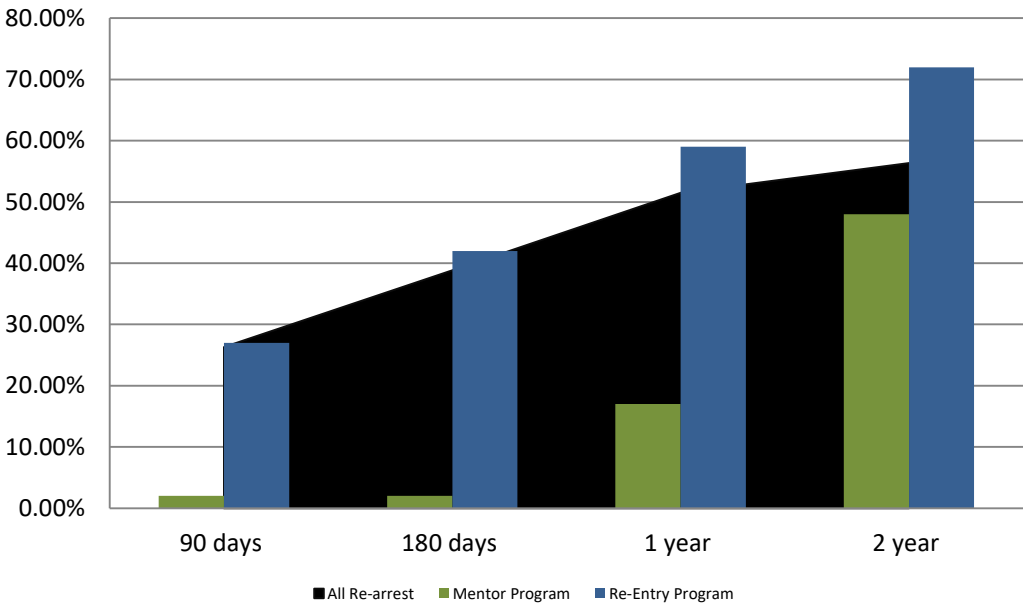

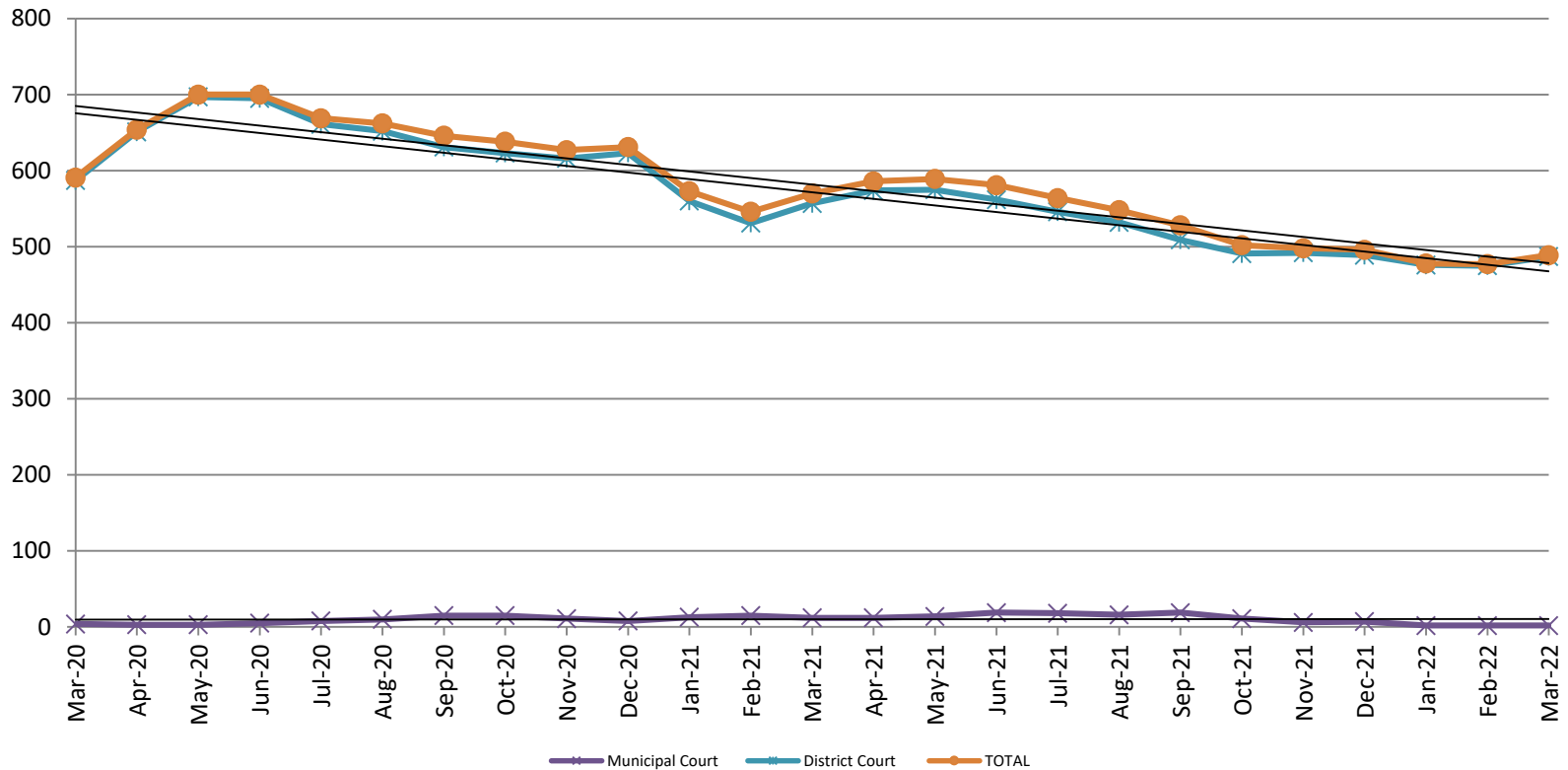

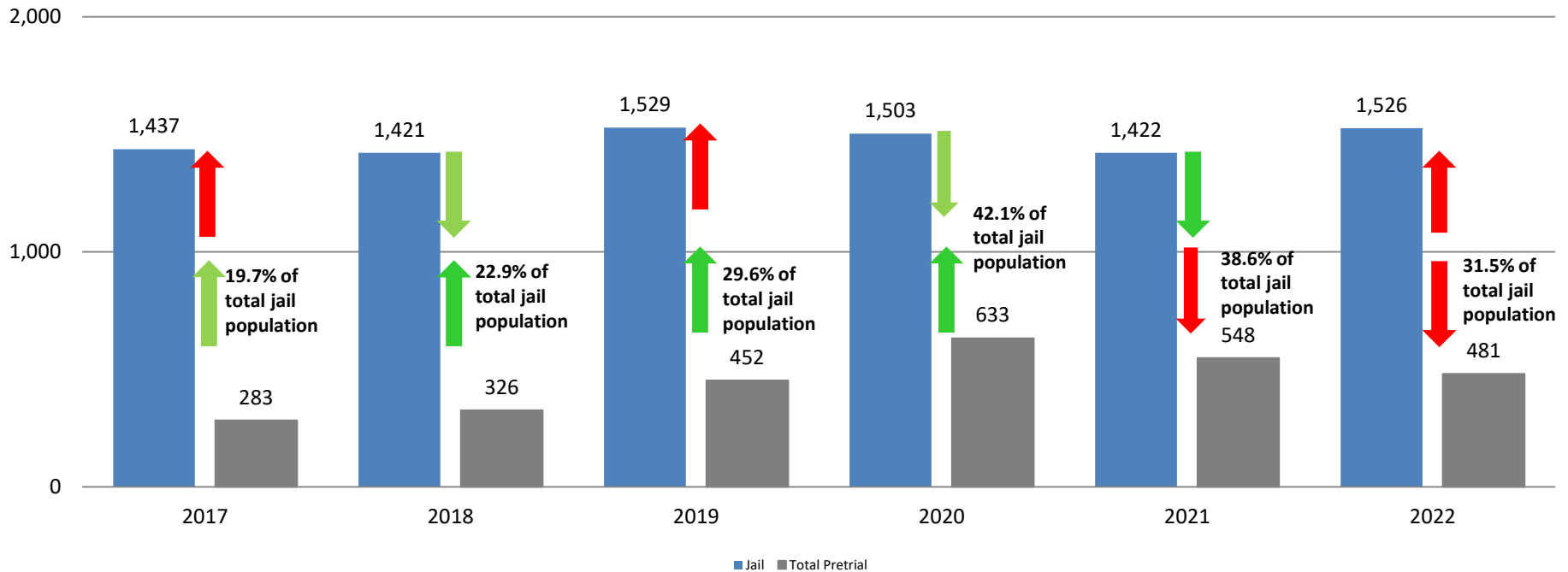

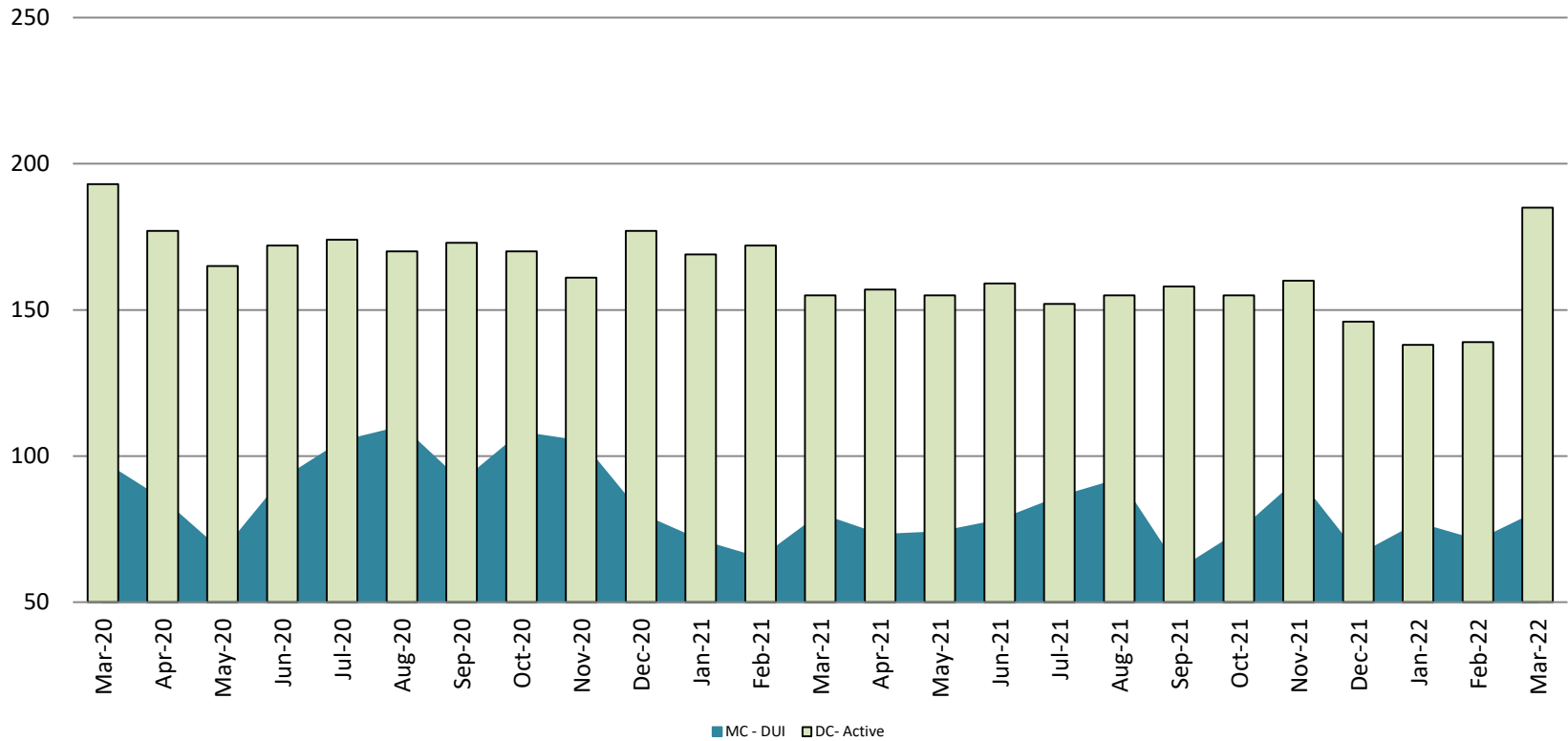

## Total Annual ADP: 2017 - present



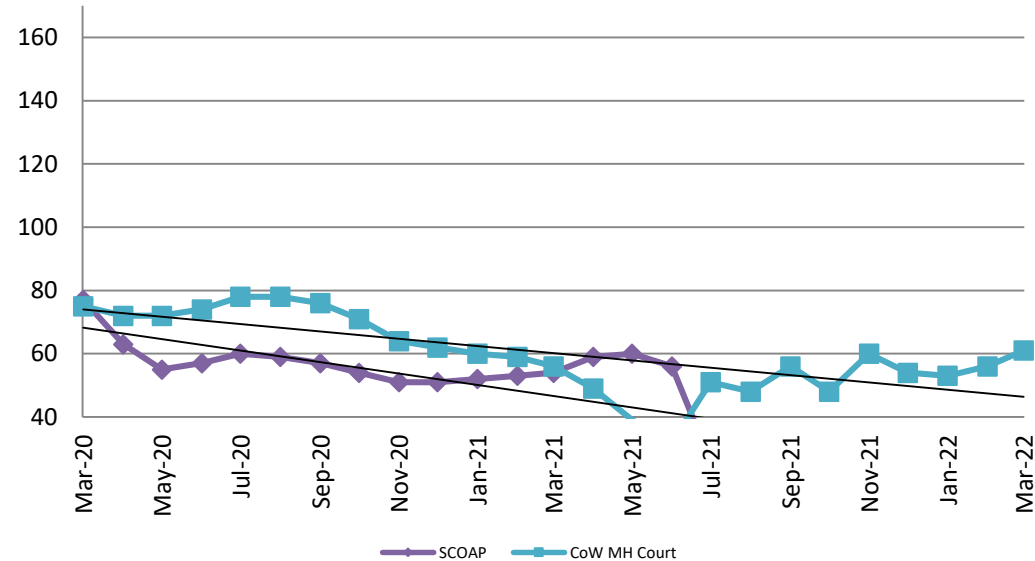

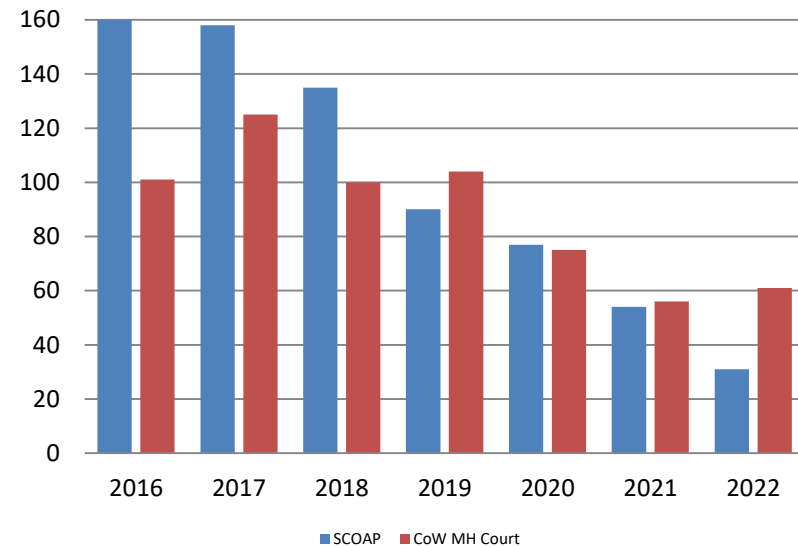

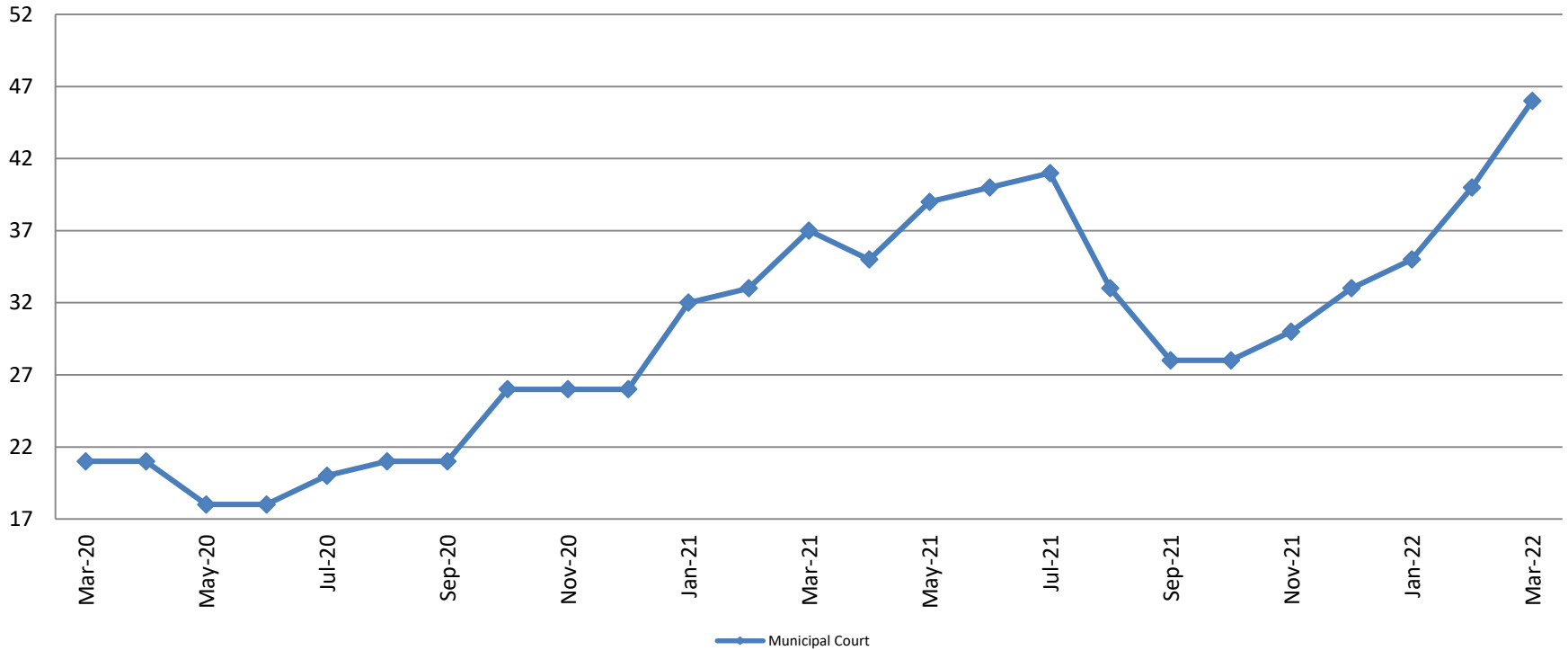

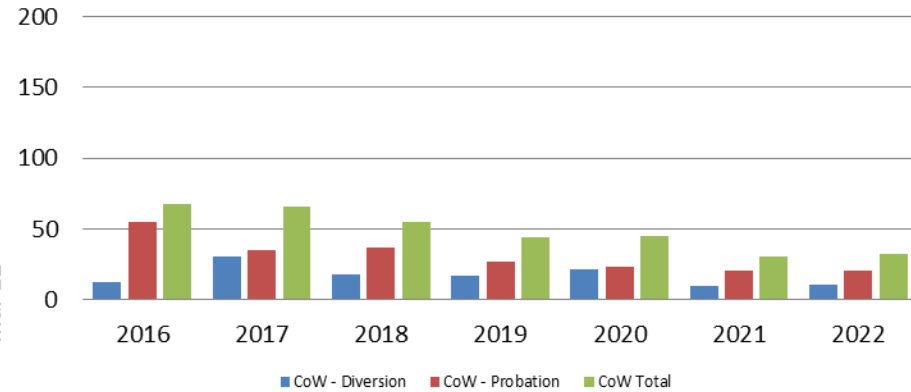

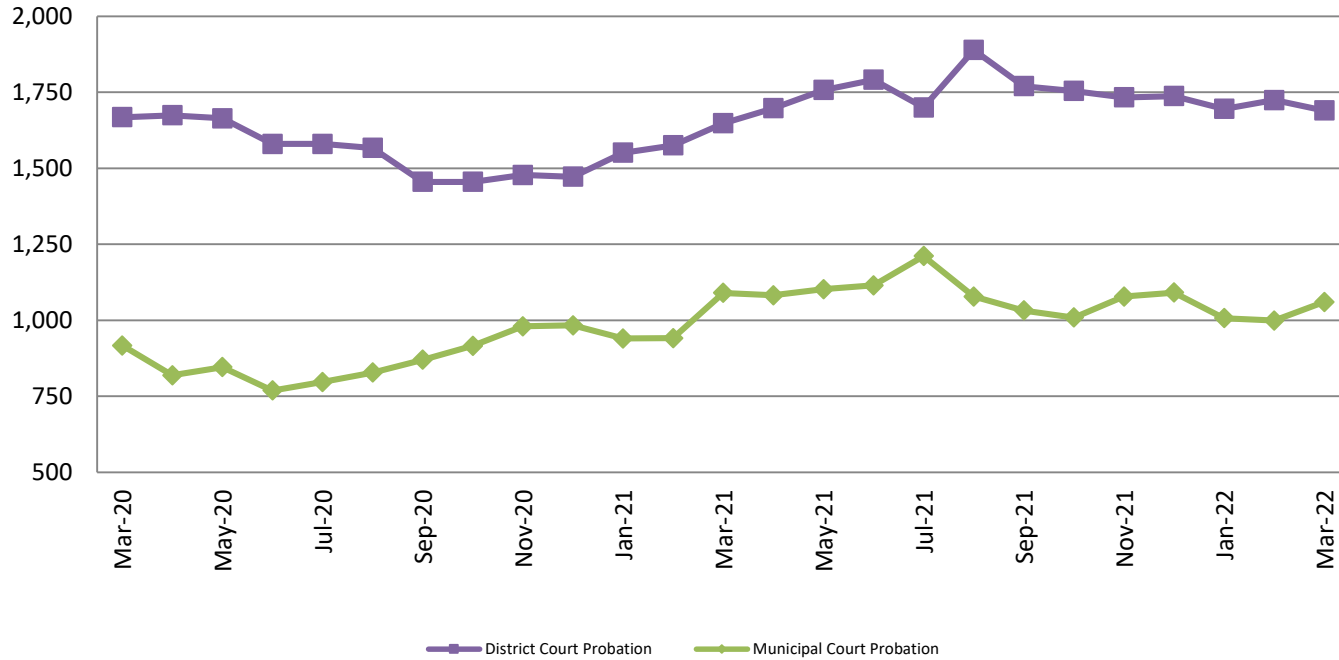

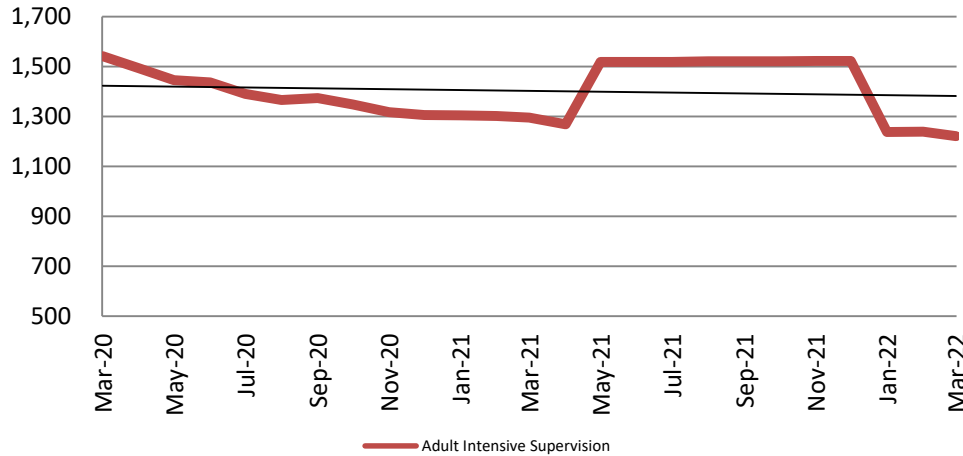

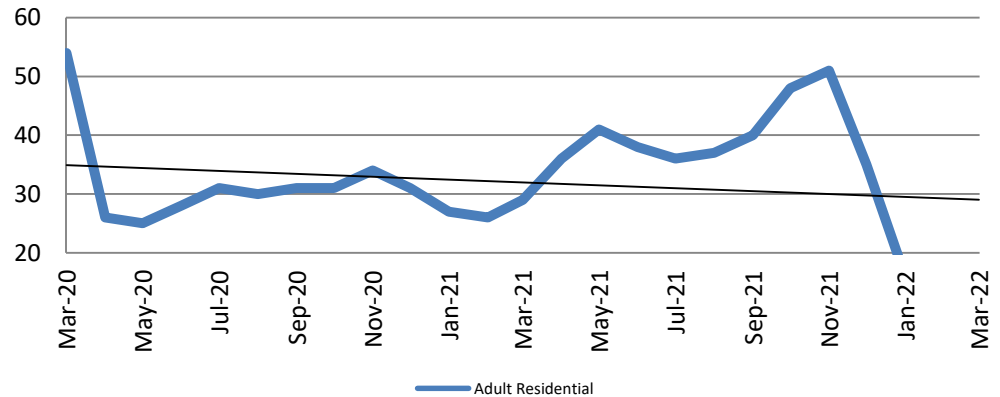

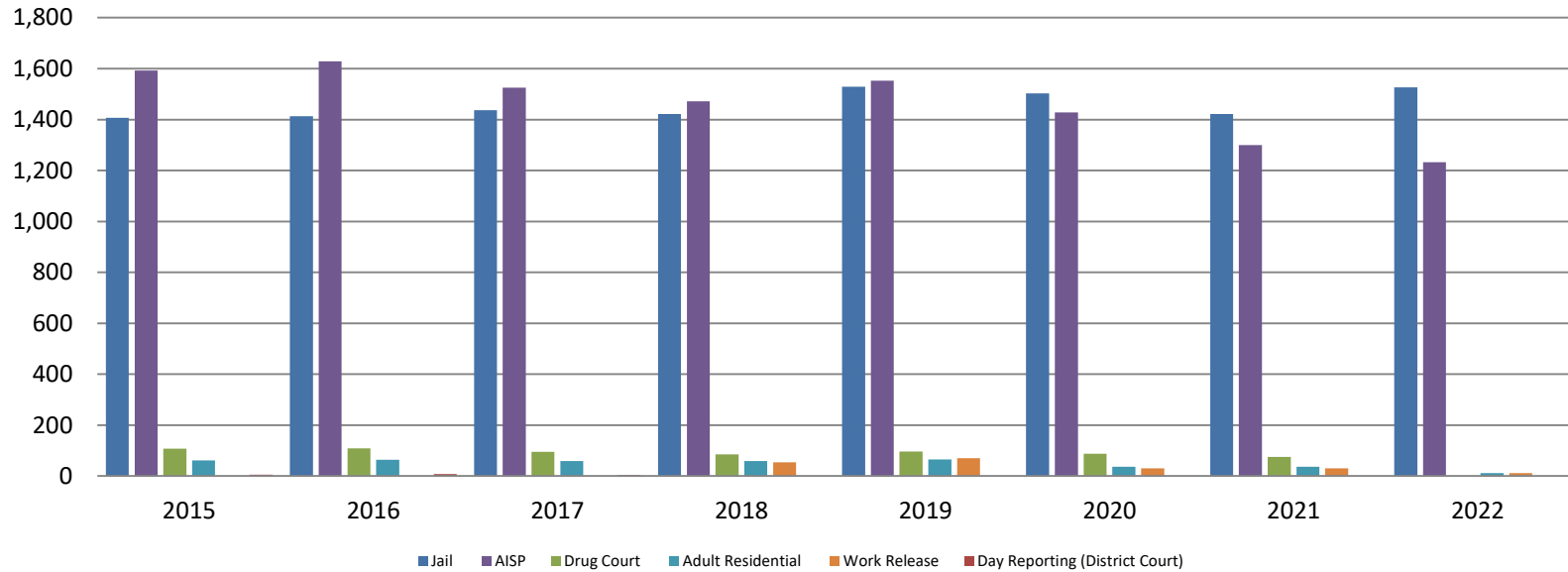

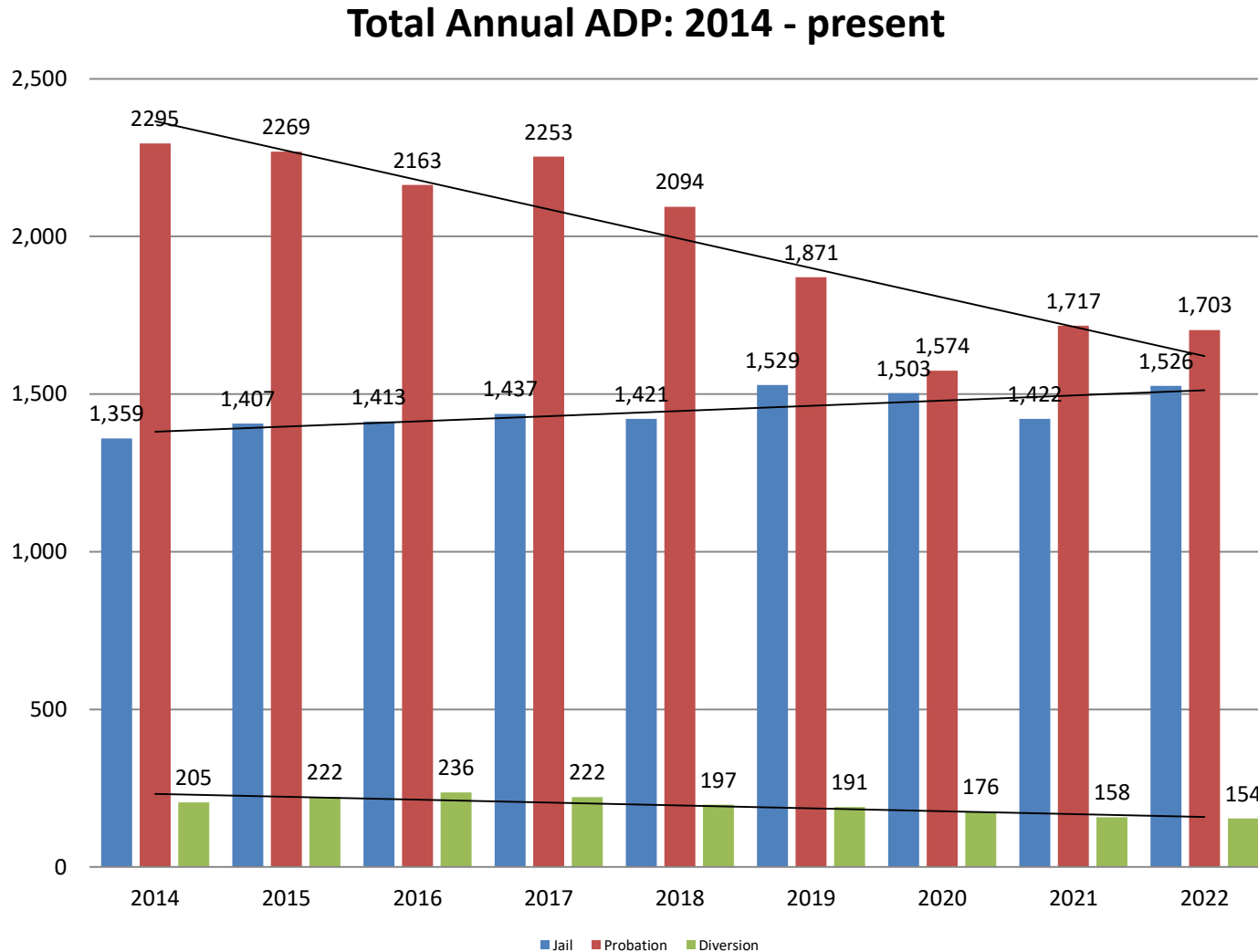

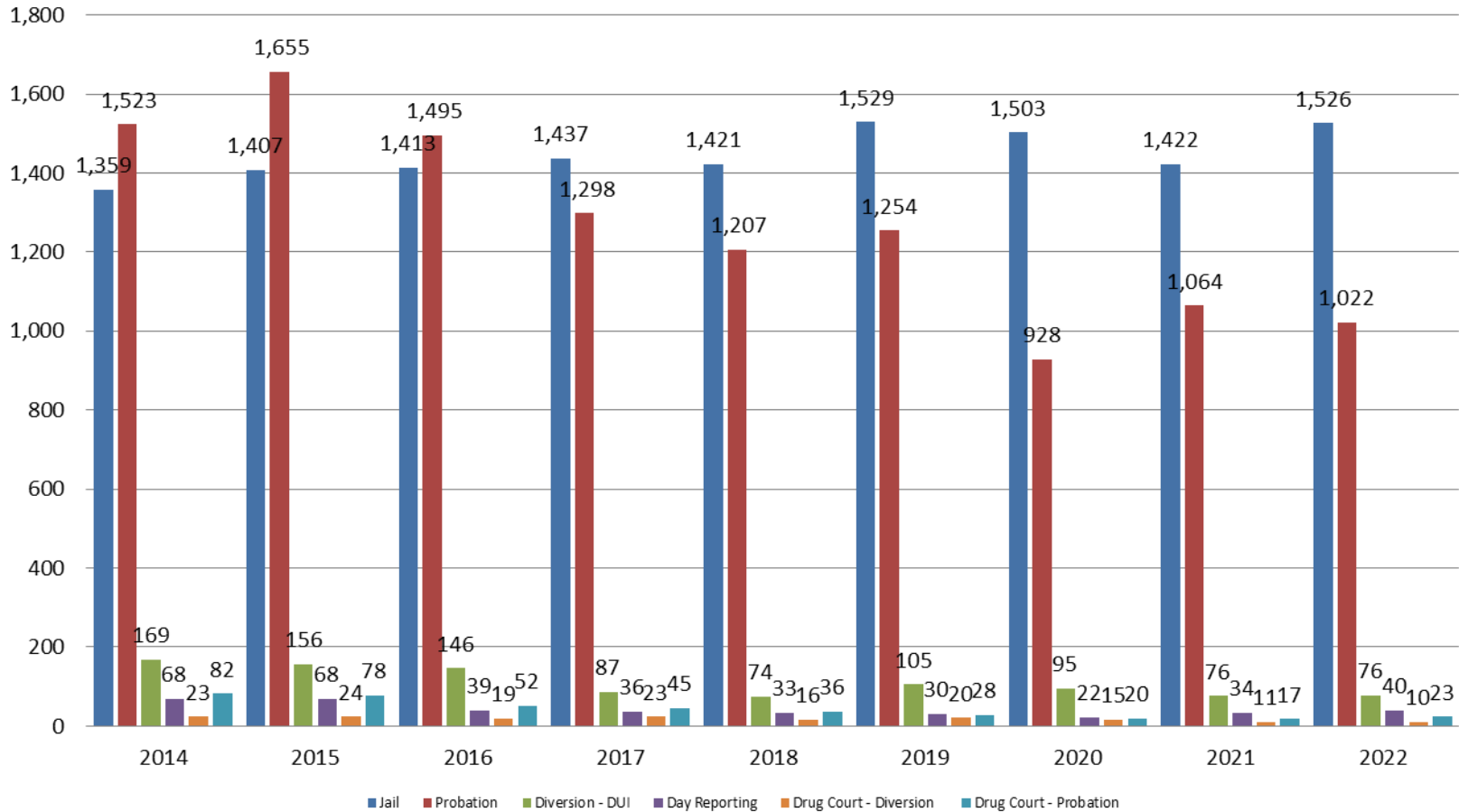


# Correlation: Total & District Court Programs



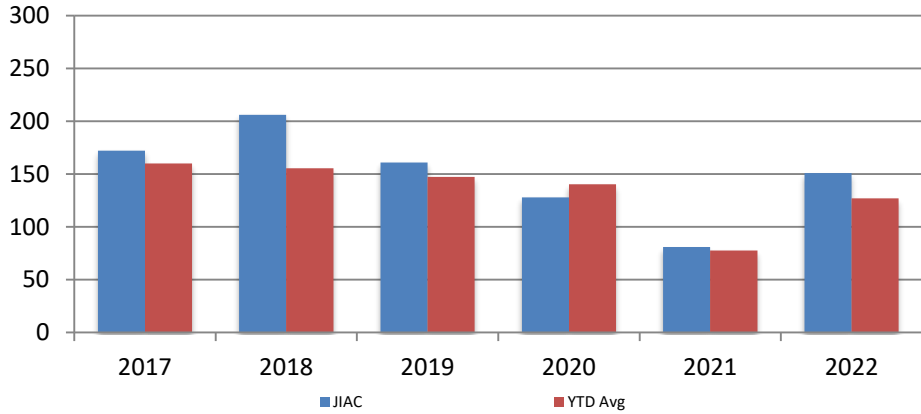
# Correlation: Total & City of Wichita / Municipal Court Programs
