This bridge repair includes grading, surfacing, pavement marking, seeding, and retaining wall repair.

Note: Bridges, Inc. chose not to bid on this bridge project because it would not have been a good fit for the crews they had available. Bettis Asphalt & Construction, Inc. chose not to bid because of the small size of the project.

This is a bridge rehabilitation which includes deck repair and pier remediation.

Note: The bid from Bridges, Inc. is 103.1% of the engineer's estimate. K.S.A. 68-1115 allows the letting of contracts within 110% of the engineer's estimate.
