- During the month of April, Quality Assurance staff have adapted reporting of incidents to include COVID-19 testing. Tracking began March 23, 2020 which has allowed for trending of data to shape conversations with providers and our local health department. Quality oversight continues by engaging around complaints/concerns from guardian and other stakeholders during program closures and continued shelter in place.
- As was the case for March, much of April was spent responding to issues related the COVID 19 pandemic. We continued our daily e-mail updates and weekly affiliate directors meetings. At the April 16<sup>th</sup> meeting we had the two capacity grant recipients, GoodLife and Disability Cocoon, provide information on what technology exists to assist providers during the pandemic. Staff also continue to collaborate with InterHab to advocate for the needs of Affiliate providers and to monitor the impact on local system capacity.
- April 8<sup>th</sup>, LINK, Inc. became an affiliate with the SCDDO. LINK provides financial management services including self-directed person care services, enhanced care and overnight respite. LINK has provided these services to western Kansas for about 30 years. They decided to expand to Sedgwick County when a client moved here.
- SCDDO has been working closely with the Health Department to coordinate support to the IDD system through
  expanded testing for all Direct Support Professionals and contact tracing for those persons receiving residential
  services. The department is also actively engaged with the Health Department's new Housing Branch created to
  support Continuity of Care for those impacted by COVID-19 but need alternative settings for
  isolation/quarantine.
- During April, the department initiated a workgroup with representatives from affiliate organizations to begin developing a local system approach to the "re-opening" of the State anticipated for May.

•	SCDDO continues to work on meeting the needs of individuals with dual diagnosis. The KDADS/CDDO Complex Needs Workgroup launched the "Assessing Community Capacity" survey in April and received over 1,300 responses from across the state. The group is looking forward to digging into the results and developing recommendations to KDADS to address identified gaps. At first glance, the results seem to be consistent with the needs identified by the SCDDO Behavioral Health Advisory Workgroup.
