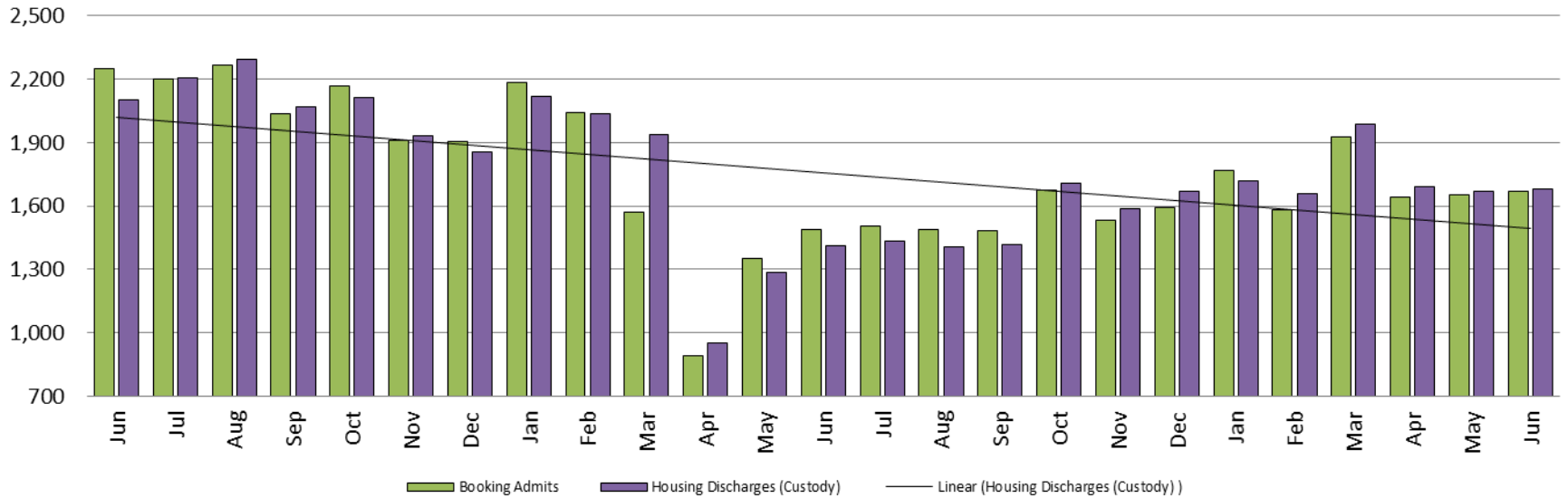

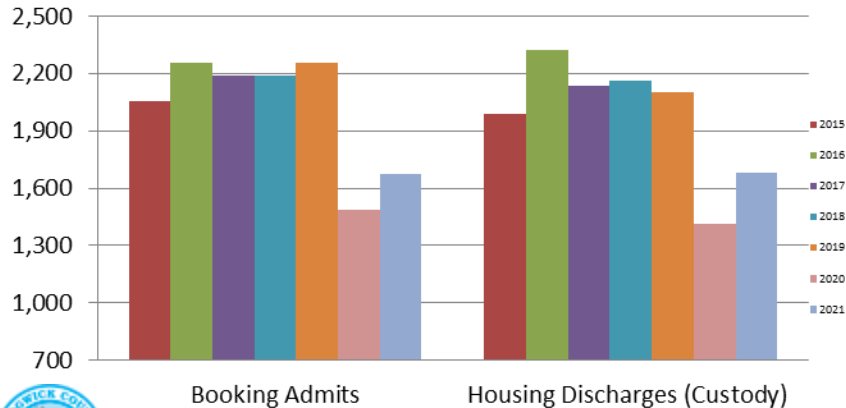

### June 2019 - present

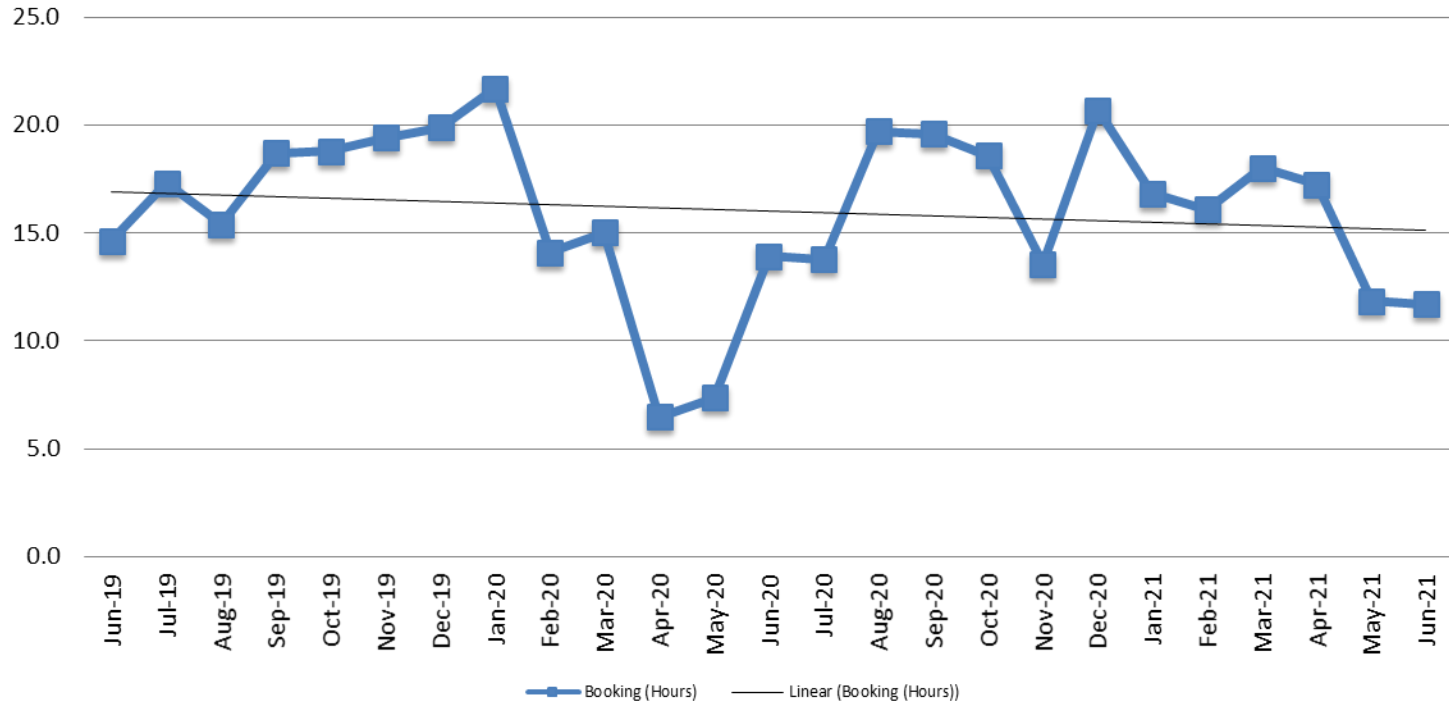

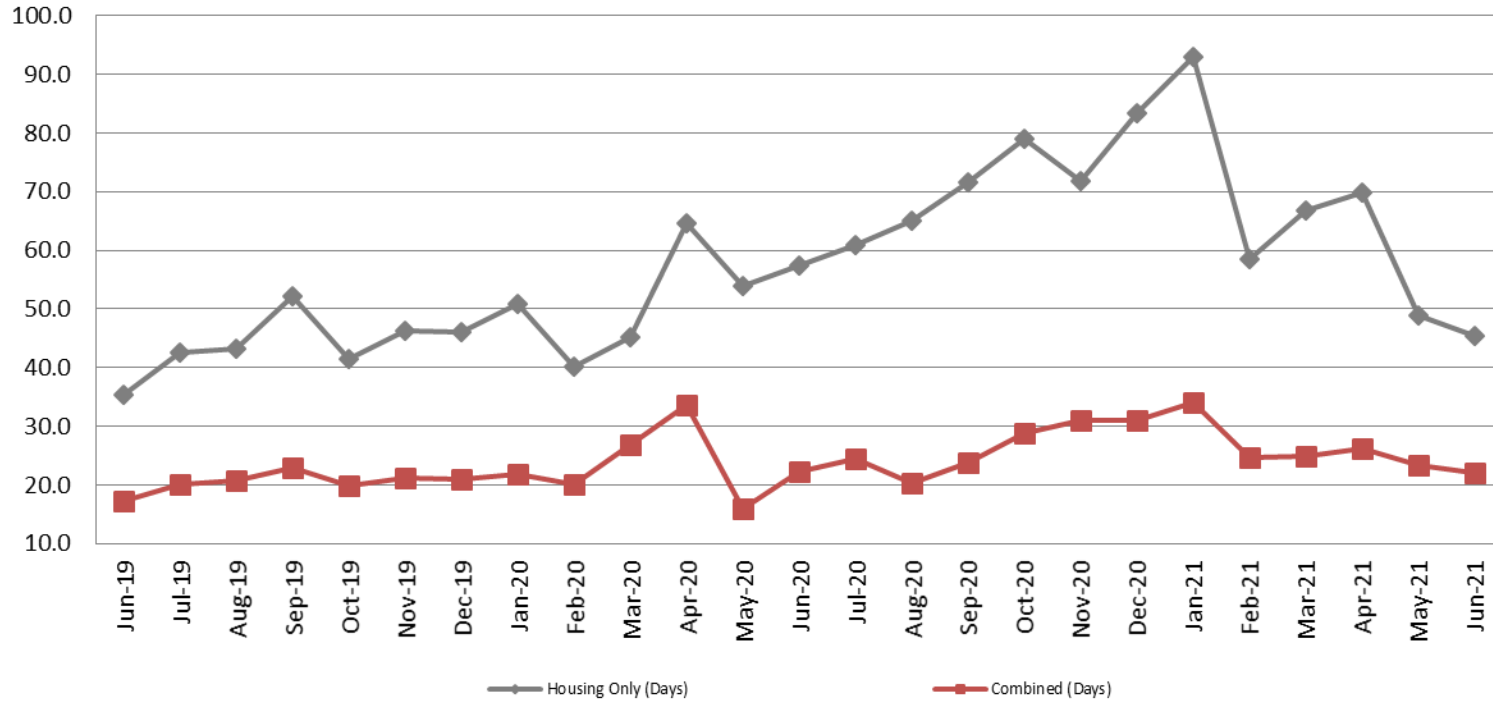

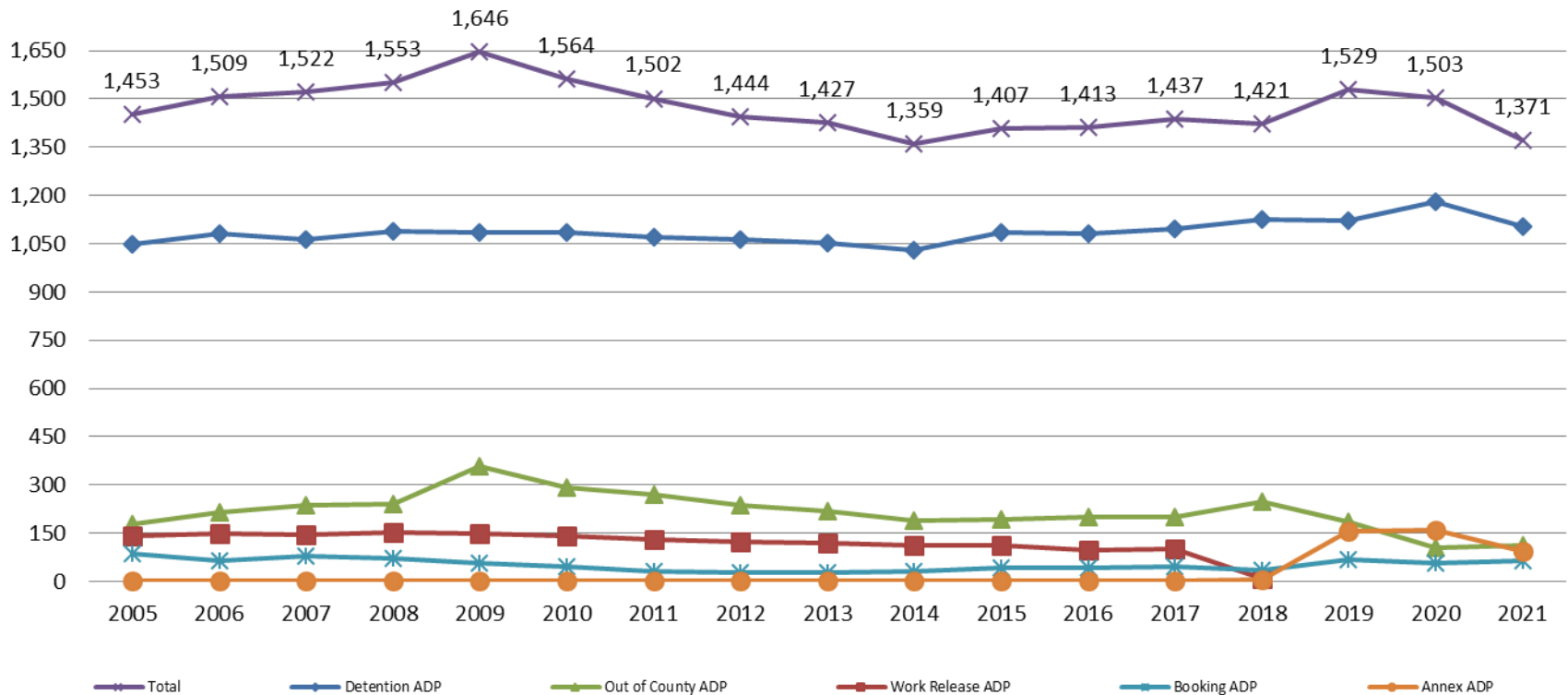

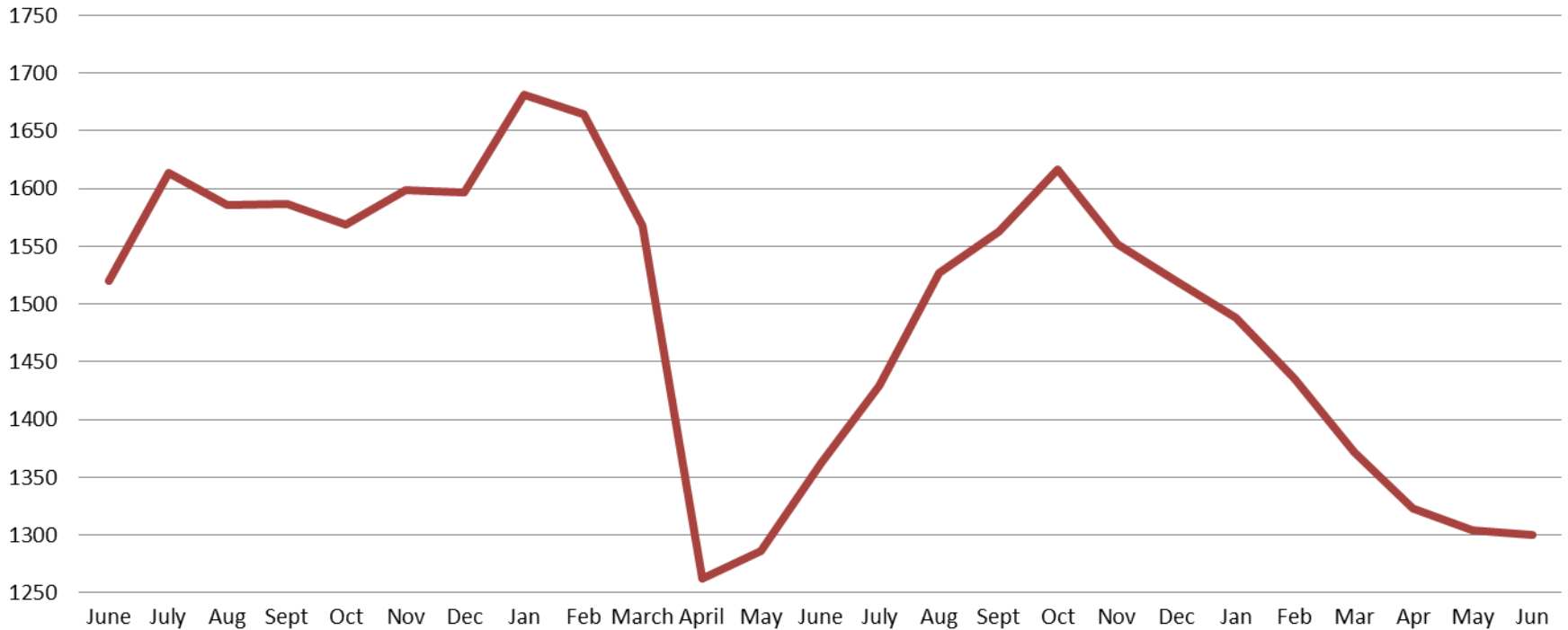


# Jail: Annual Average Daily Population (ADP)

**TRENDS: Booking, Detention, Work Release, & Out of County Annual ADP: 2005 - present**



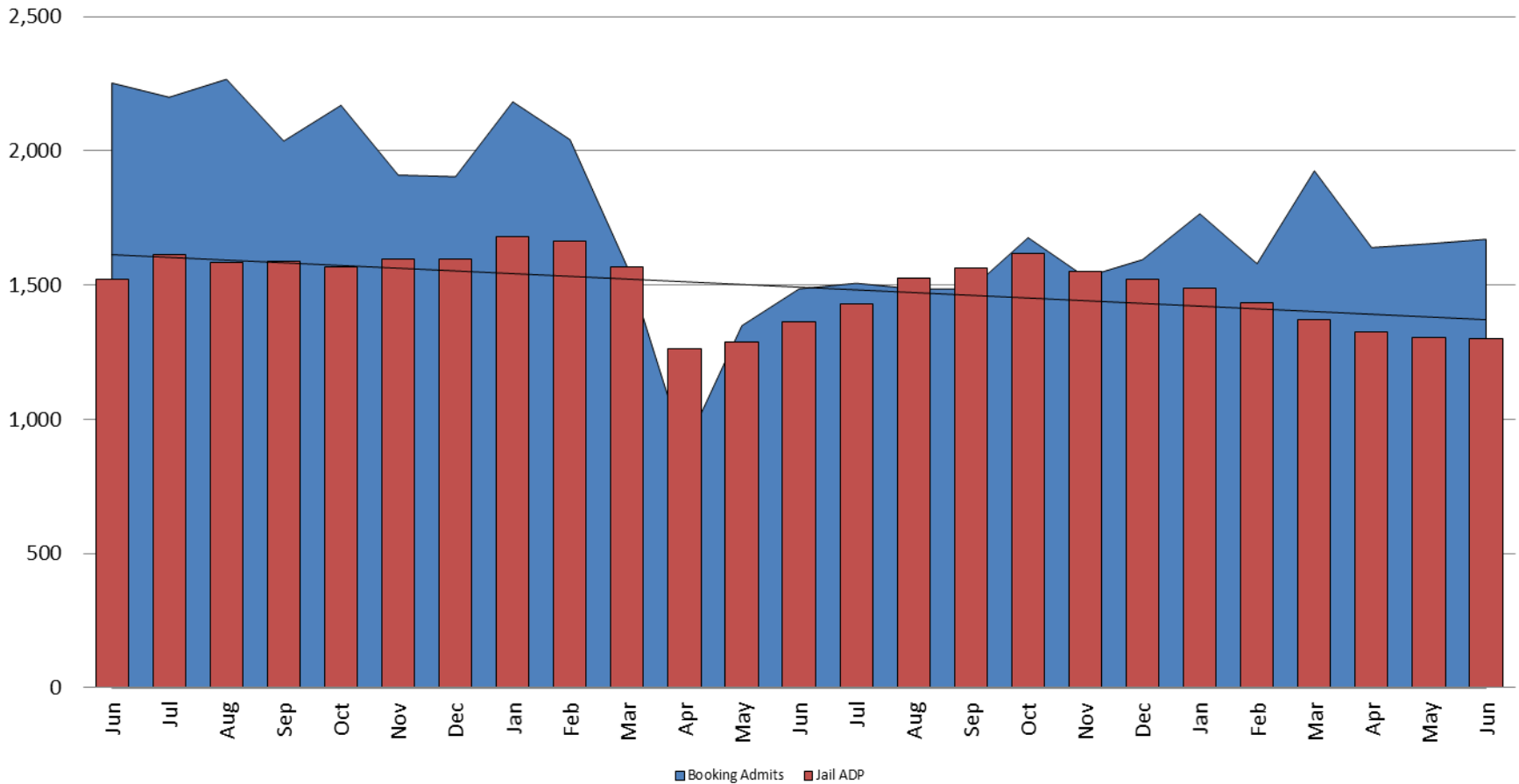
# TOTAL MONTHLY ADP: JAIL (Booking, Detention Facility, Annex, & Out of County) June 2019 - present



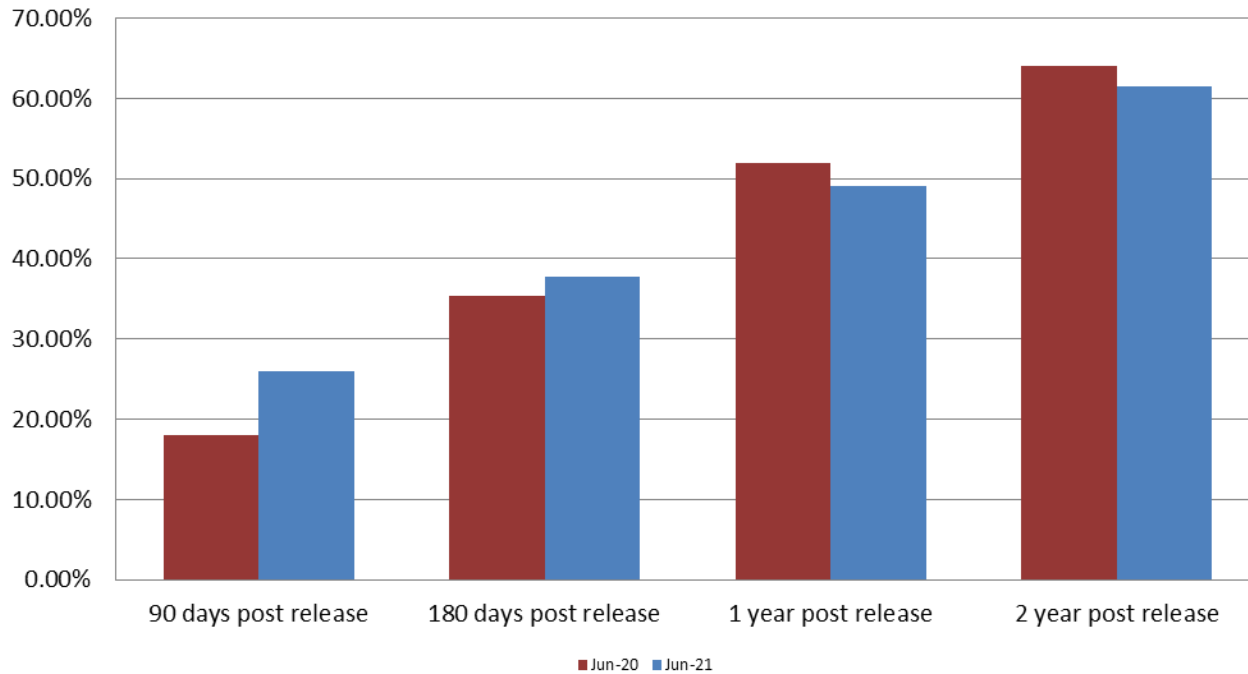

## Percent of Released Inmates Rearrested June

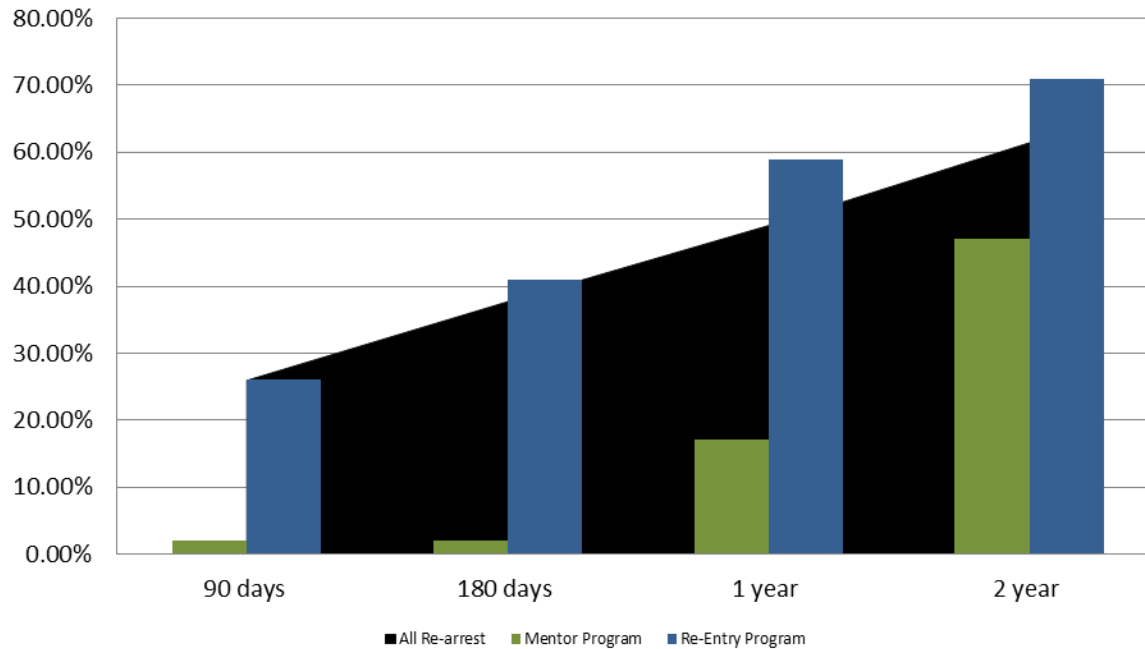

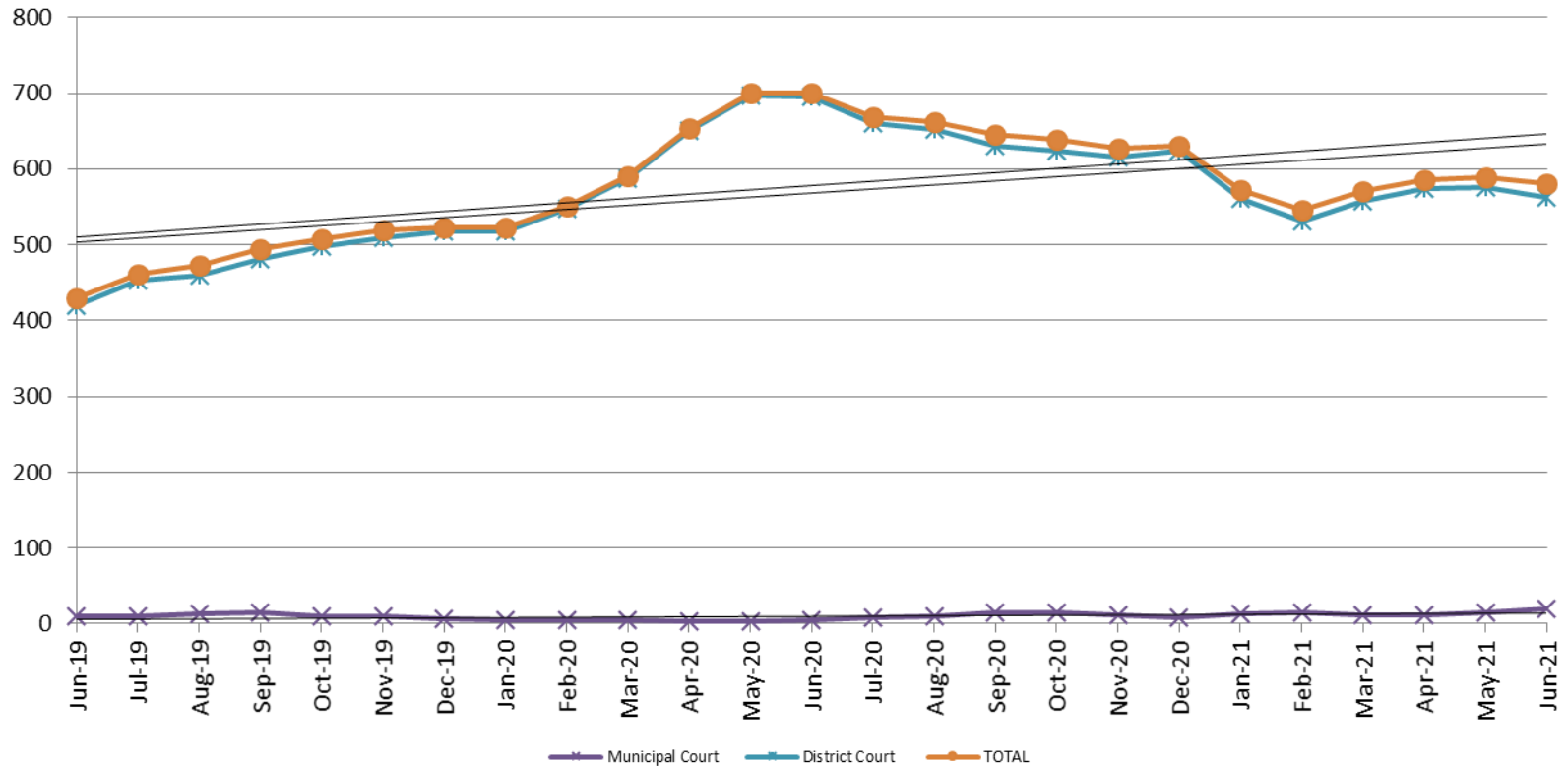

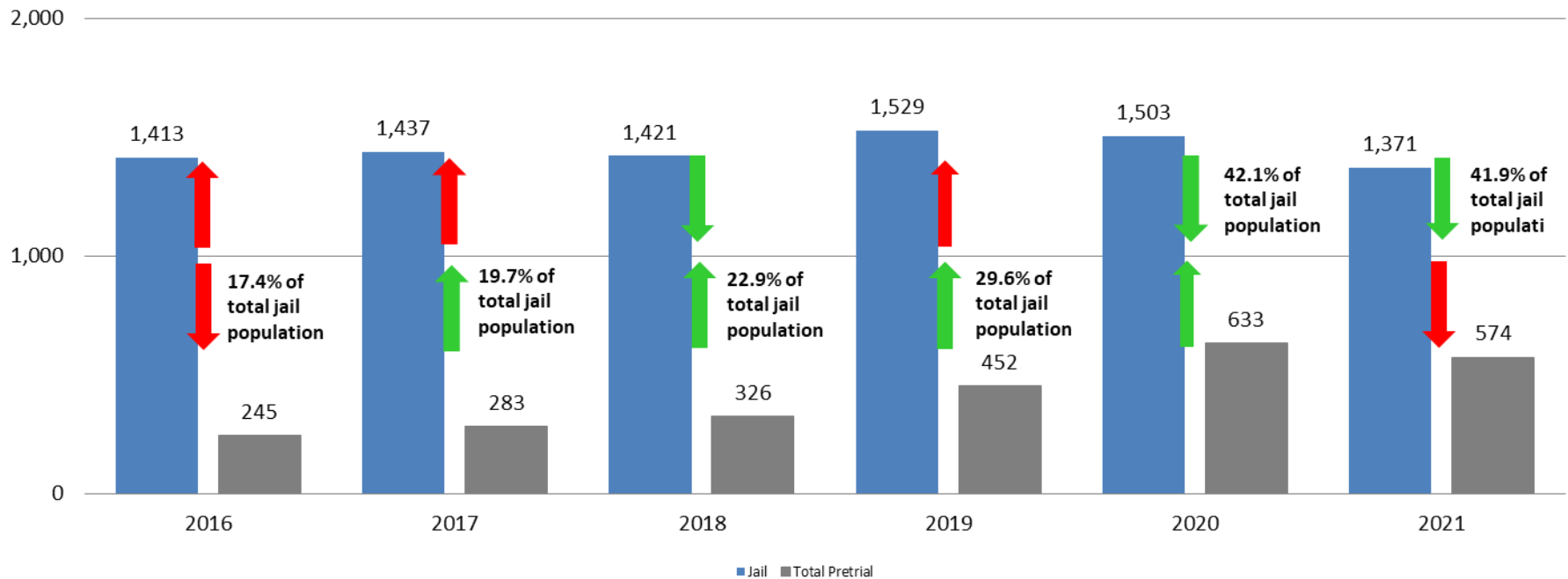

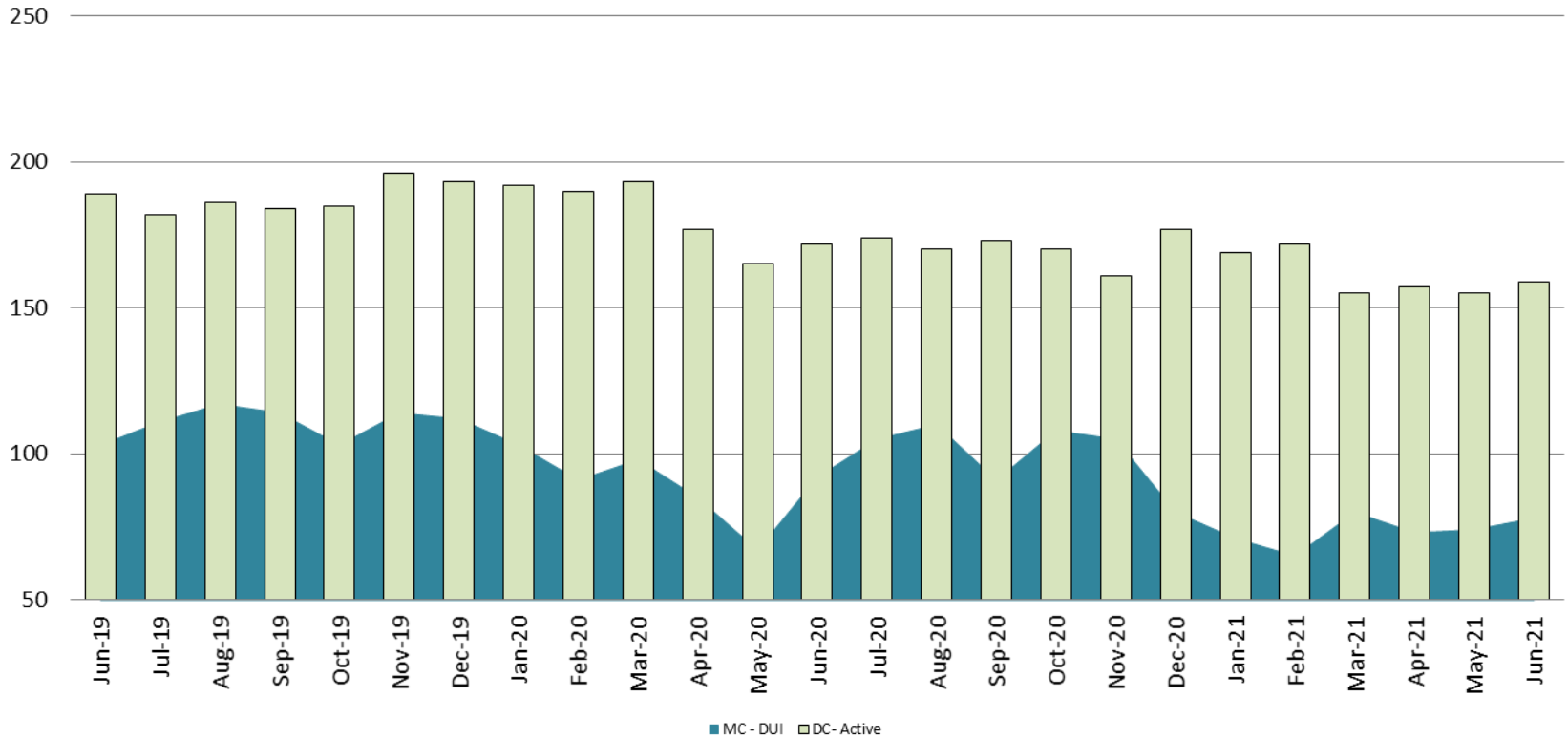

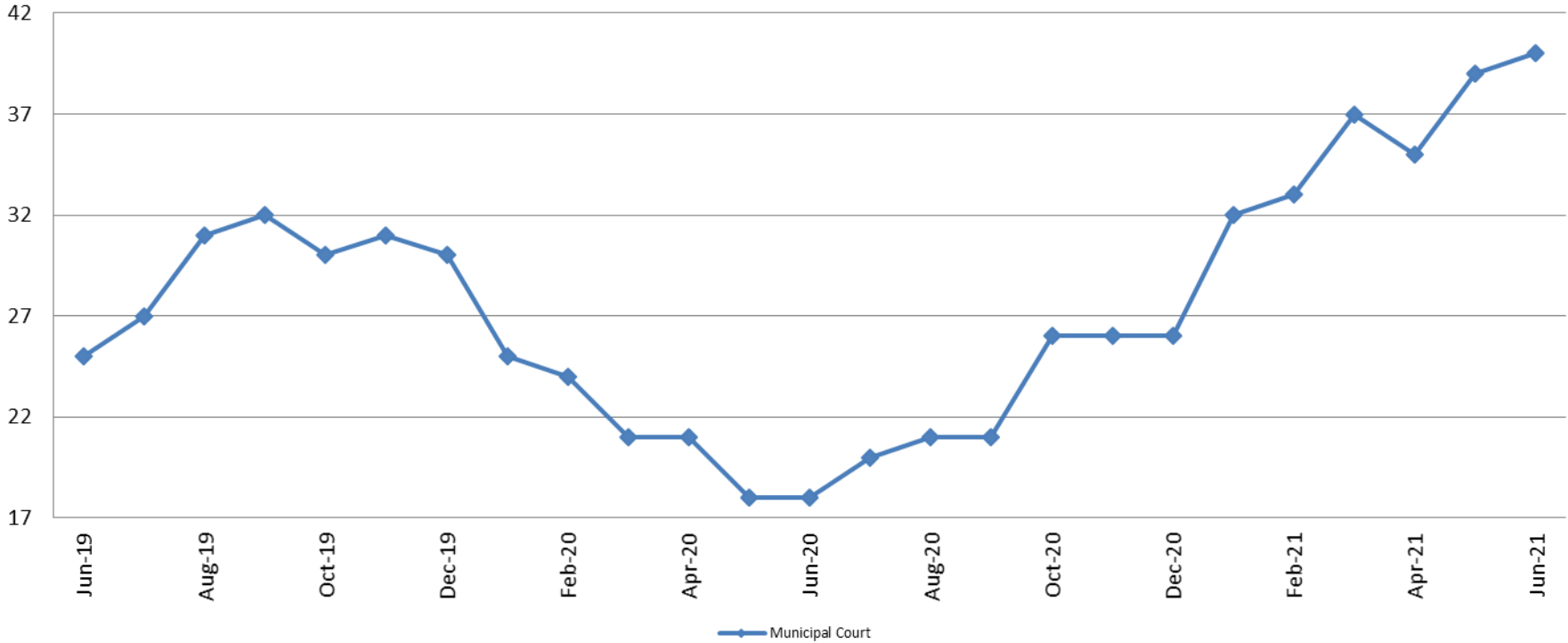

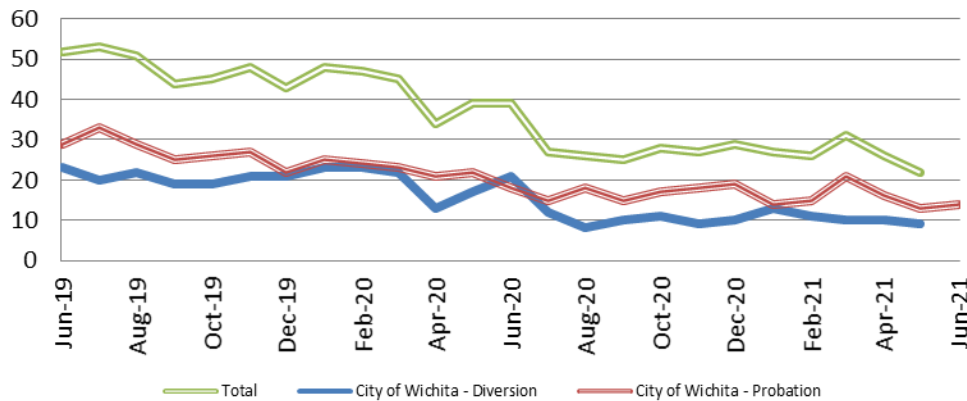

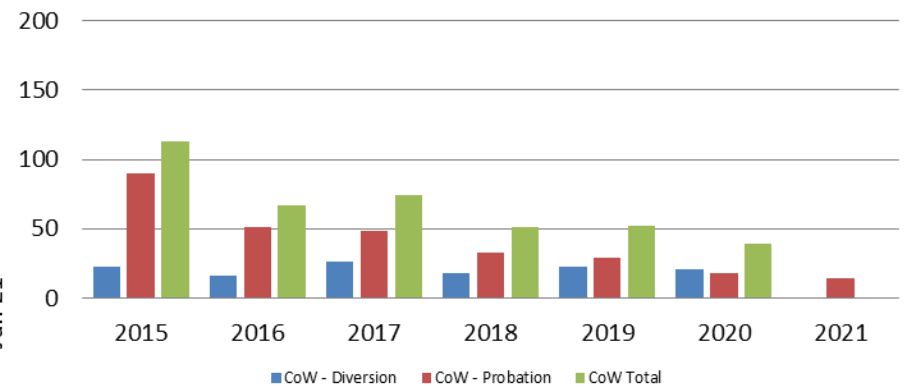

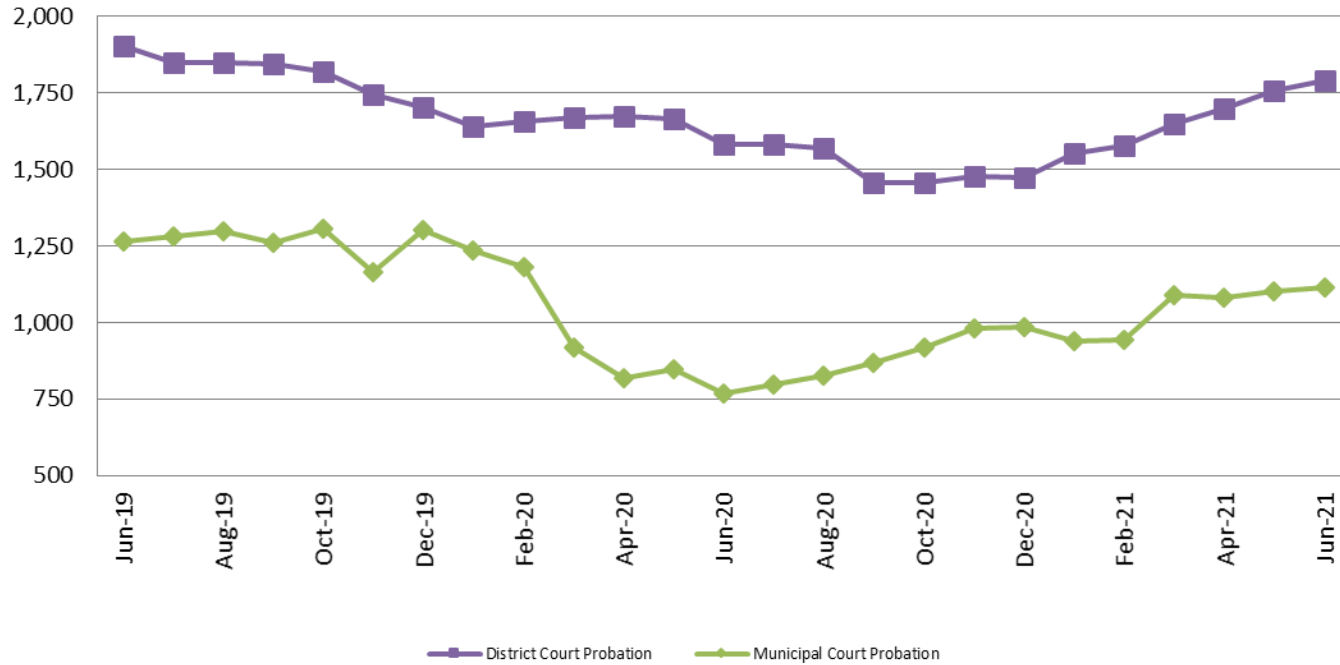

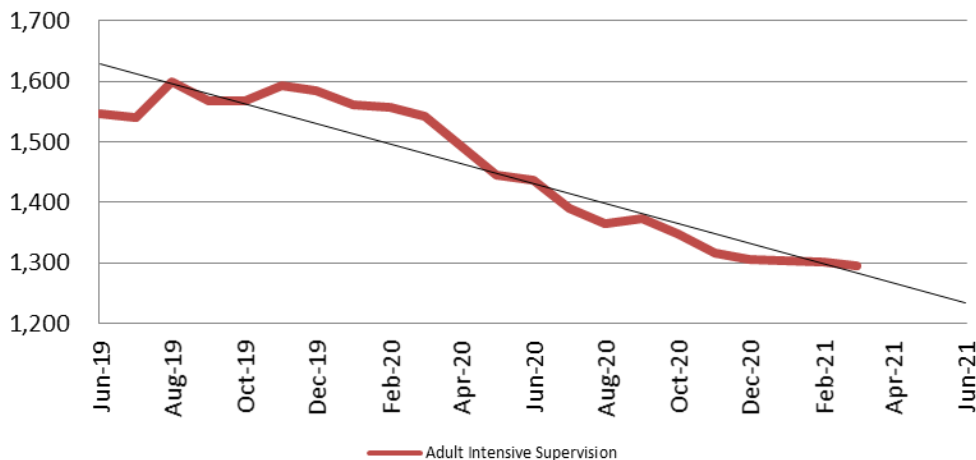

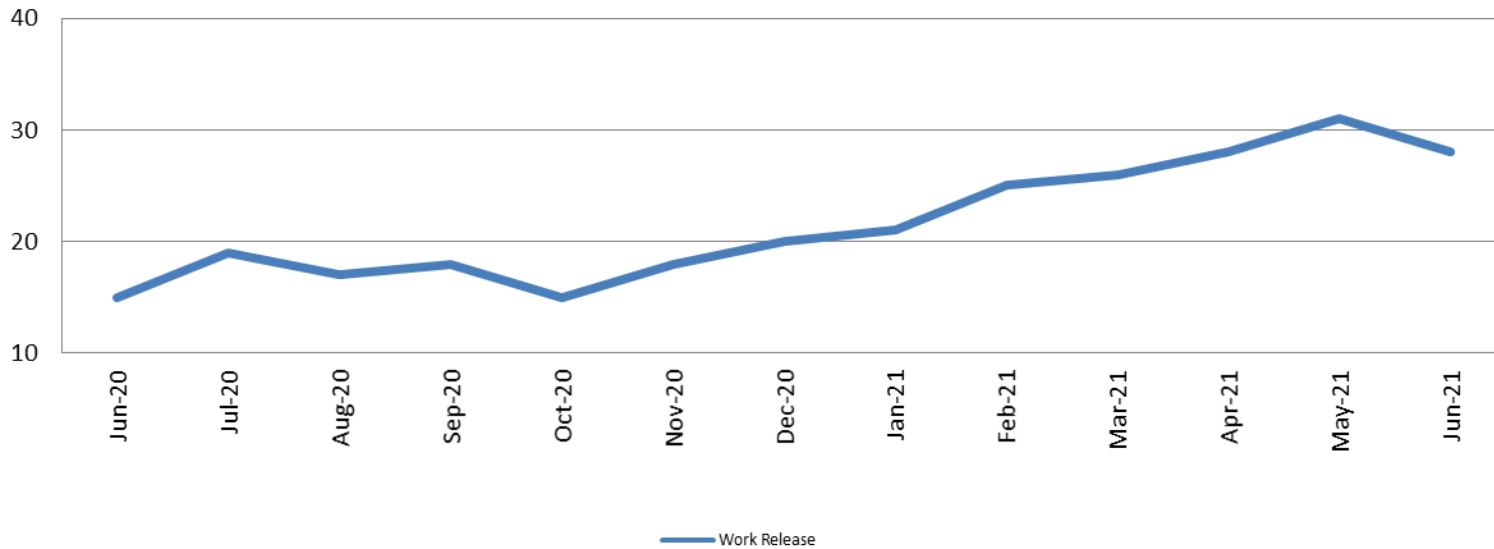

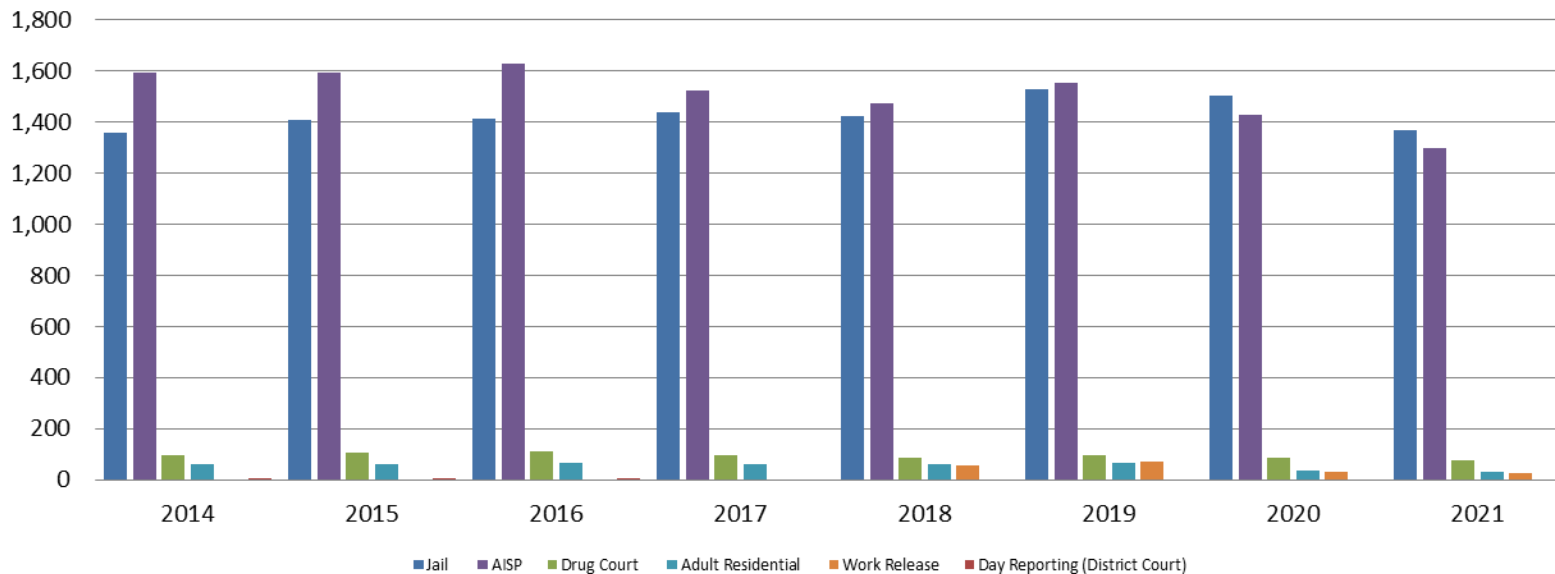

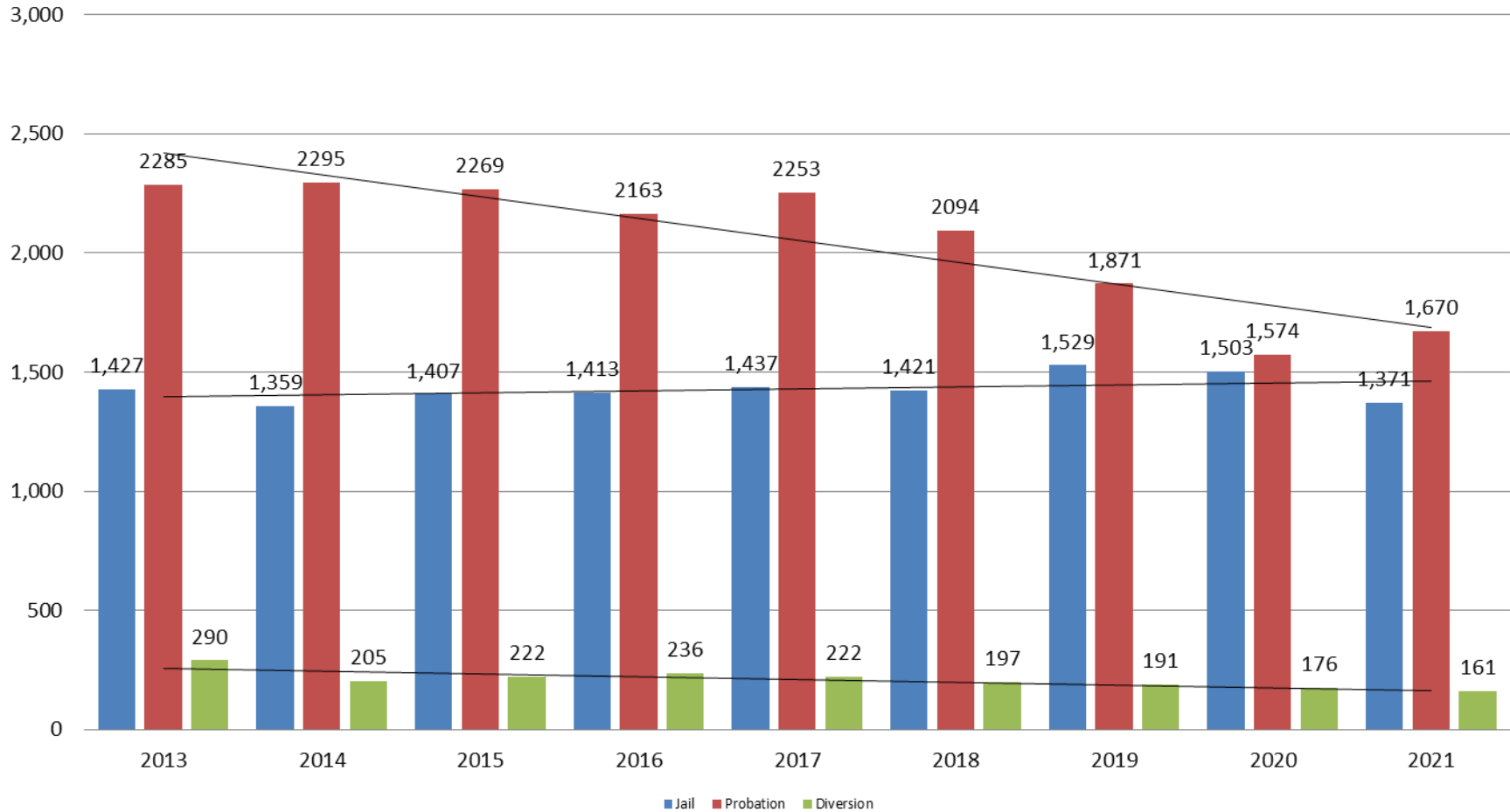

# Correlation: Total & District Court Programs

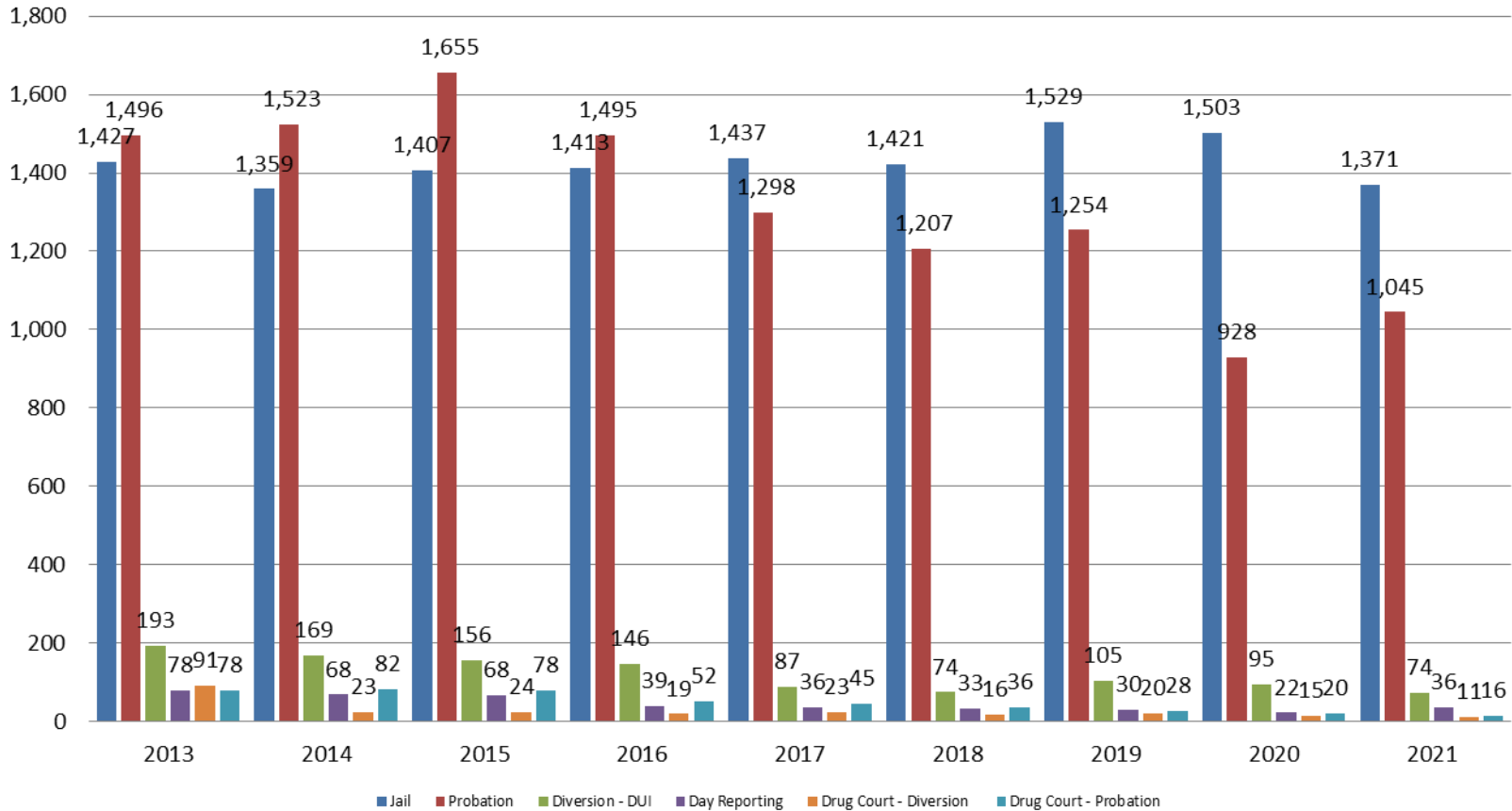
## Total Annual ADP: 2013 - present

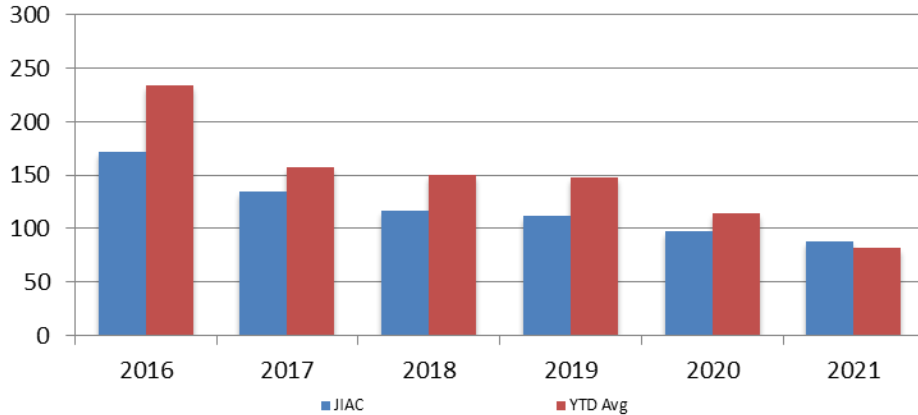

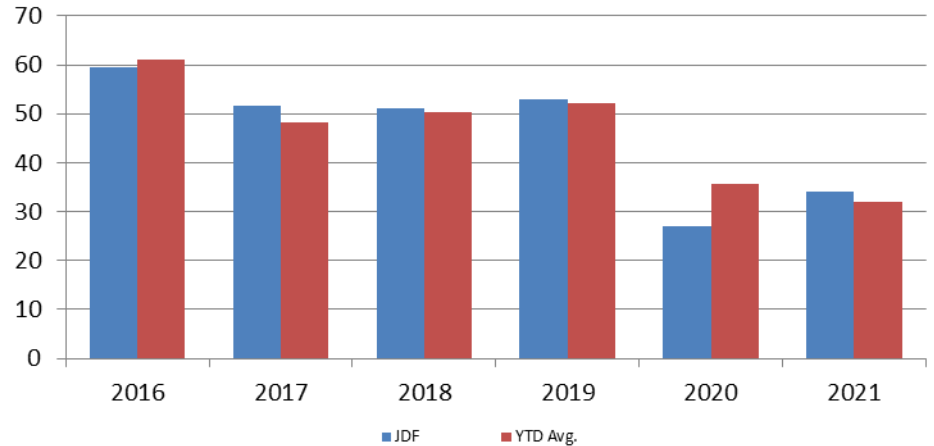

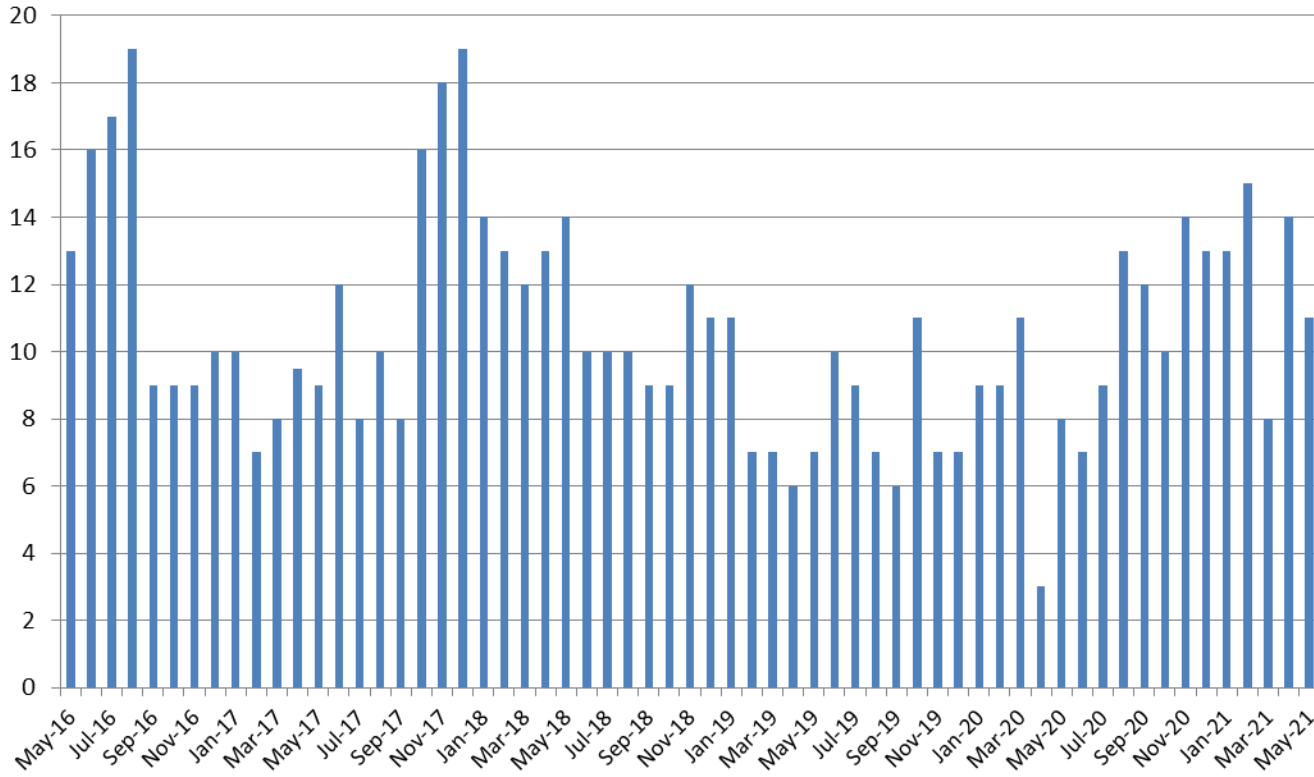
