367.

The new **Supporting Community Organizations in Improving Outcomes for Juvenile offenders and Families Grant** is now open for applications from community-based non-profit organizations to provide services to juvenile offenders, juveniles experiencing mental health crisis and their families. The award period is for May of 2023 through June of 2025 and **applications are due March 17, 2023**. - * Evidenced-Based (EB): means practices, policies, procedures, and programs demonstrated by research to produce reduction in the likelihood of re-offending (K.S.A. 38-2202)
- * Supports programs related to intake, diversion, probation, and conditional release
