On the recommendation of Kimberly Evans, on behalf of the Facilities Department, Tim Kaufman moved to **accept the bids from Van Asdale Construction and Cherokee Construction, Inc. at the rates listed for one (1) year with two (2) one (1) year options to renew.** Linda Kizzire seconded the motion. The motion passed unanimously.

Under this contract, vendors will provide on-call remodel services on an as needed basis. Services may include, but are not limited to, general demolition, framing walls and partitions, finishing work, and modifications to existing space to accommodate ADA standards.

The previous vendors for these services were Encore Construction, LLC, Sky Contracting Company, Inc., and Van Asdale Construction, LLC.

Total three year spend on the expiring contract was approximately \$250,000.00. Average rate increase for business hour rates for this contract will be \$0.17, less than one percent, compared to the previous contract.

Tim Kaufman asked if the county has done business with Cherokee Construction, Inc. previously. Joe Thomas responded that Cherokee Construction, Inc. has done some work on SCKEDD projects in the past with favorable results. David Spears asked if one vendor had priority over the other on our On-Call contracts. Kim Evans answered that neither vendor takes precedence over the other and that it is within the departments' discretion to choose whom they wish to work with on their projects.

On the recommendation of Britt Rosencutter, on behalf of Fleet Management, David Spears moved to **accept the low bid from Landmark Dodge in the amount of \$191,981.00**. Tim Kaufman seconded the motion. The motion passed 3 to 1, with Linda Kizzire voting no.

These are replacement vehicles for the Sheriff's Office, surplus will be sold on Purple Wave, Inc.

Chairman of Bid Board, David Spears asked if there are any questions from bid board members.

Linda Kizzire stated, "I have no questions but I have a few comments. Davis-Moore is a local dealership, for a \$5,152.00 difference, I feel we should go ahead and use the Davis-Moore bid simply because they pay over \$300,000.00 in property taxes on their buildings here in Wichita. They have over 250 employees that also pay taxes in Sedgwick County not only on their homes but their vehicles. They are one of our bigger employers as a car dealership. Landmark Dodge is not located in Sedgwick County and for that low of a difference I think we should change our minds and go with Davis-Moore."

Chairman asked , " Any further questions from bid board? Any further discussion?"

Tim Kaufman asked, "Can we clarify under the current purchasing rules we cannot make that change and does the Purchasing Charter (65) allow for any special consideration of a local vendor?"

Joe Thomas, Purchasing Director stated, "yes, thank you for asking Tim. Under the current Charter 65 we do not have a local preference policy. The state of Kansas on tie bids does allow the bid to go to the domicile vendor if there was a tie bid, also a reciprocity statute. Since Landmark Dodge is in the state of Missouri if Missouri had any preferential policy we could adopt their preferential policy but they do not have one. So in this case based on those two statutes our Charter we go with the lower bid."

"Currently Charter 65 does not have any provision for local preference. The State of Kansas, however, allows for cases of a tie-bid between a local and out-of-state vendor, that the award would go to the bidder within the state (K.S.A. 75-3740). Also the State of Kansas allows for reciprocity with an out-of-state bidder that is low bid, meaning if that bidder's state has a preference policy, it can be used in favor of the in-state or local bidder (K.S.A. 75-3740a). Neither of these cases apply in respects to this bid award recommendation."

On the recommendation of Kimberly Evans, on behalf of the Sheriff's Office, Jennifer Dombaugh moved to **accept the overall low bids from Armcor Cartridge Inc. and Accuracy Inc. dba Ultramax Ammunition and establish contract pricing for two (2) years at the rates listed above.** Tim Kaufman seconded the motion. The motion passed unanimously.

In 2015 Sheriff's Office spent \$61,151.00 with Armcor Cartridge Inc. and Accuracy Inc. dba Ultramax Ammunition for duty and practice ammunition.

\*The original bid submitted by Armcor Cartridge Inc. for the Winchester 12 gauge ammunition was determined to be a non-judgmental error for the quoted case price. The submitted bid listed the unit packing as 1,000 per case, however, the actual unit packing was 250 per case. K.S.A .75-6904 states if there is a suspected error by the bidder, a request for verification can be made. After verification, the bidder can withdraw submission within two days. If the bidder does not respond within two days it is considered to be "verified" and accepted "as is". Armcor chose to leave the bid "as is" and sell at the stated price per 1,000.

On the recommendation of Kimberly Evans, on behalf of Department of Corrections, Tim Kaufman moved to **accept the overall low proposal from Core Monitoring, LLC and establish contract pricing for one (1) year with two (2) one (1) year options to renew.** Linda Kizzire seconded the motion. The motion passed unanimously.

A committee comprised of Lori Gibbs, Jennise Jenkins, Karla Seymore, Mario Salinas and Tom Struble-Corrections and Kara Kingsley-Purchasing evaluated the proposals for content, qualifications, experience and methodology. Greenfeather Monitoring, LLC, Core Monitoring, LLC and Premier Monitoring were shortlisted and demos were given. Core Monitoring, LLC was chosen for recommendation.

The electronic monitoring devices will be used in conjunction with the county's house arrest electronic monitoring programs and will be paid by Sedgwick County. Core Monitoring, LLC is located in Wichita, Kansas.

BI, Inc. is the current vendor; 2015 spend was \$72,525.00.

Note: GPS-Global Positioning System

Active-The unit collects one GPS point every 15 seconds and communicates data to the monitoring computer every five minutes.

Passive-The unit collects one GPS point every minute and communicates data to the monitoring computer every four hours.

Self Insure-The vendor will be responsible for any lost or damaged devices. The vendor may recoup costs from the offender.
