On the recommendation of Britt Rosencutter, on behalf of the Facilities Maintenance Services, Linda Kizzire moved to **accept the proposal from TFM Services to establish contract pricing at the rates listed above for one (1) year, with three (3) one year options to renew.** Jennifer Dombaugh seconded the motion. The motion passed unanimously.

A review committee consisting of Greg Tuxhorn, David Portley and Robert Campbell - Facilities and Britt Rosencutter - Purchasing evaluated all proposals. The selection criteria included qualifications outlined by the RFP: pricing, references, experience, methodology, approach to staffing, supervision, security issues and overall quality of the proposal. The decision to choose TFM Services was reached unanimously.

TFM Services is a locally owned and operated company and has had past experience working with Sedgwick County.

Service Types A and B are levels of cleanliness, cleaning frequency, population, usage and type of area (bathroom, office, ect.).

A Day Porter is assigned to provide supplemental services to maintain the desired level of cleanliness consistently throughout the day.

Note:

SourceOne Management Services Inc. has a Day Porter charge of \$2,295.00/Month and Stephens Industries dba Air Capitol Building Maintenance Co. has a Day Porter charge of \$2,794.72/Month. TFM Services included the price of the Day Porter. This made them the second lowest proposal. The proposal for HHM Facility Management LLC was not considered based on past performance.

***Questions and Answers:***

Linda Kizzire asked: "Which one of the facilities will actually have the Day Porters?"

Greg Tuxhorn (Facilities Maintenance Manager) answered: "The Day Porter services will be based out of the Main Courthouse. They also will take care of the Historic Courthouse, as well as several other facilities, but this is their base."

Tim Kaufman asked: "This contract appears to be smaller than the previous custodial contract, is that accurate?"

Joe Thomas answered: "The reason for that is that the last time it was a consolidated contract for all of the various facilities, and we've now broken it up. You'll be seeing subsequent recommendations in the very near future."
