On the recommendation of Joe Thomas, on behalf of the Regional Forensic Science Center (RFSC), Tim Myers moved to **accept the low quote from GenTech Scientific, Inc. (GenTech) in the amount of \$98,175.00.** Linda Kizzire seconded the motion. The motion passed unanimously.

The LC-MS/MS is a liquid chromatograph mass spectrometer. It is an instrument that is used to detect drugs of abuse in biological samples. This will allow the laboratory to transition assays from other instruments, which will lighten analytical loads, allow for procedural changes, reduce time for analysis, and greatly increase case throughput.

The funding source for this item is the 2019 Coverdell grant that is designated to help address the opioid crisis, which is the same grant that was used earlier to procure the Peak nitrogen generator. This grant expires 12/31/19, GenTech guarantees delivery by 12/15/19.

Questions and Answers

Linda Kizzire: Does it come with the PC and the monitor like the one from Waters was offering?

Shelly Steadman: Yes. We sent an e-mail to the vendor to verify the computer and monitor were included, as well as the vacuum pump.

Russell Leeds: Since it's mentioned on here about the Peak nitrogen generator, could you explain how that interacts with the LC-MS or does it?

Shelly Steadman: Yes. The Peak nitrogen generator is required to run the instrumentation and was required to also run the previous LC-MS instrument that was before you recently. In order to manage the grant dollars efficiently, we first had to understand the cost of the generator that was required to operate these instruments and go through this process a secondary time knowing the amount of money remaining we had to actually purchase the instrument.

On the recommendation of Josh Lauber, on behalf of Public Works, Linda Kizzire moved to **accept the quote from Sedgwick County Electric Cooperative Association, Inc. in the amount of \$75,000.00**. Russell Leeds seconded the motion. The motion passed unanimously.

Sedgwick County Electric Cooperative Association, Inc. owns and operates a power line that conflicts with CIP project R348, which is scheduled for construction in 2020. It was determined during plan review that the current location of the 3-phase power line is on private right-of-way that existed prior to the county acquiring right-of-way for the project. R134 is funded annually to purchase right-of-way and/or relocate utilities at various locations as needed, prior to construction projects.

Questions and Answers

Angela Caudillo: This indicates the R134 is funded annually for this reason so is that where the funding is going to come from?

David Floyd: That's correct. There's a shopping cart number on the top left of the table showing the funds have been properly pre-encumbered for that project.
