This project will provide accessible ADA upgrades to Sedgwick County Park including, but not limited to: new concrete sidewalks and landings, accessible ramp, parking, striping, wheel stops, detectable warnings, signage, accessible charcoal grills, and accessible picnic tables. This project also includes a new accessible shelter, electrical pedestal, aluminum dock, decking, guard rails on both sides of gangway, security curbing around edges of the dock, and landscaping.

These improvements are part of the county’s ongoing efforts to ensure accessibility in our programs and services.

Tim Kaufman wanted to clarify if the county had checked with Farha Construction, Inc. to ensure they could do the work at the price bid and in the amount of time as indicated.
