- During the month of January, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 3 day and 10 residential program visits.
- The SCDDO finalized an agreement with Wichita Transit to offer up to \$1,500 for paratransit services to individuals eligible for the intellectual/developmental disability (IDD) system in Sedgwick County. The program is part of a program administered through the SCDDO Funding Committee. Paratransit services are designed to assist individuals with IDD access employment and the community in ways that were not previously available. The program will not replace transportation services provided by residential providers. Targeted Case managers can complete the application. If an individual does not have a case manager they can call the SCDDO to access assistance with the application.
- At the January Community Council meeting Raven Alexander with Wichita Transit provided an overview of the Wichita bus service and their new "MyStop" app designed to assist people understand the bus system. Individuals with a disability qualify for a 50% discounted fair for the regular bus service. individuals to plan bus trips by typing in the "to" and "from" addresses then it shows how long it will take and which buses and stops are involved in the trip. The app also provides real-time bus location information. The information app and on the bus system can be found their website at: https://www.wichitatransit.org/Pages/default.aspx
- The SCDDO successfully provided options counseling to 96% of the around 200 individuals needing to select a
  new provider because KETCH terminated their Targeted Case Management (TCM) program effective Jan. 31.
  Despite multiple outreach efforts and letters, there were nine individuals that have not selected a new provider.
  The agency providing day, residential or personal care services will be responsible for conducting the person
  centered plan for those that have another service provider but haven't selected a new TCM agency. However,

six of the nine do not receive services and their TCM services will be closed. These individuals can restart TCM services by calling the SCDDO for options counseling.
