- During the month of August, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 11 day and 2 residential program visits.
- The Sedgwick County Intellectual/Developmental Disabilities Advisory Board (IDDAB) met Tuesday August 9<sup>th</sup>. IDDAB elected officers at the meeting and recommended affiliation (contingent on licensure) for a new residential and day provider.
- Sedgwick County hosted a meet and greet with the incoming Project SEARCH interns. This year there are a total
  of three Project SEARCH interns working to increase employment skills and explore their vocational interests.
  Four Sedgwick County departments attended the meeting: Print Shop, Information Technology Services,
  Exploration Place and Elections. The 2022/2023 school year is the fewest interns the Sedgwick County Project
  SEARCH site has hosted; this relates directly to the impact of COVID when many students with special needs
  chose to graduate early.
- GoodLife Innovations came to the August SCDDO All Staff meeting to share about their new neighborhood network. The neighborhood network is situated in an apartment complex in Wichita. It offers semiindependent adults with intellectual/developmental disabilities a safe option to live independently with technology assisted care.
- Sherry Arbuckle participated in the August InterHab Issues Forum. Members of the IDD service system met to set advocacy goals for the next legislative session. Priorities included a rate increase for IDD targeted case management, which has been paid the same rate for over 15 years. Another priority was to work towards a more sustainable rate increase system for Home and Community Based Services that accounts for regular cost of living increases.

•	An Americorp VISTA started with the SCDDO August 30 <sup>th</sup> . Spencer Allen accepted the Workforce VISTA position. He will be working to implement and promote the new Direct Support Professional Registered Apprenticeship program. Additionally, Spencer will be working with the four Project SEARCH sites in Sedgwick County.
