# **Questions and Answers**

Russell Leeds: How many trucks do we have in our Fleet?

Brian Richey: We have two (2) front line battalion chief vehicles and one (1) reserve for a total of three (3).

Russel Leeds: The vehicle we are rotating out, is that your vehicle?

Brian Richey: Yes. The one we are rotating out has roughly 200,000 miles from every day use. It's not so much the miles it is always the hours as well. It all compounds.

Greg Gann: Is this a gas or diesel truck?

Brian Richey: It is a diesel.

Brandi Baily: I do have one question and it is something I've always wondered. How come we buy the manuals? Why are they not included?

Brian Richey: It is just the way Ford does it. They do not include them. If you were to buy it personally, you wouldn't get them. They are basically for people in my position for the maintenance and troubleshooting of the vehicles.

Brandi Baily: We do use the manuals and they don't just set?

Brian Richey: Absolutely. Anytime we work on the trucks or electronics, we refer to the manuals for troubleshooting. These are not like an owner's manual they are technical prepared manuals for engine repair and transmission repair.

Tim Myers: We sent this out to 95 vendors and we only received one (1) response?

Brian Richey: It's a really unique time we are in right now. We used to get all kinds of bids. With the current vehicle situation across the world, Ford is the only one that is even allowing us to buy vehicles at this time. Chevrolet, Dodge, any of those, are not responsive to fleet needs at this point.

Tim Myers: We believe that we will have this by December 26th?

Brian Richey: Yes. We are talking maybe midsummer of next year. We typically bid these trucks way before now but Ford has a two (2) week window that we can order for this year and if we miss that window we have to wait until they open it again next year. That is why we are bidding these late in the year. Typically, we bid these in January or February with a late year delivery. It is a unique situation we are in right now.

Britt Rosencutter: The vendor did not even receive pricing to bid us until a week ago. The window for ordering is in late November or December and is only open until it is full which could be for only one day.

### **Questions and Answers**

Greg Gann: Is the specialized equipment on the truck transferred to the new vehicle or is this a complete vehicle ready to go upon receipt?

Brian Richey: Some of the equipment is moved over, the pumper tank you see on this one will be replaced. Typically the tanks stay on that truck its whole life. The truck in the picture is roughly 30 years old, by the end of that life cycle the equipment is pretty much worn out. The transfer is not cost effective. This cost does not include the fire pump on the back, that will be bid separately. Typically we transfer the loose equipment and the hose appliance from truck to truck. Typically its very limited.

Brandy Baily: Since the equipment is bid separately will it be in around the same time that the truck is? Will it be available when the truck is available so the truck can be put together?

Brian Richey: We will be bidding the tank that sits in the back of that truck as a separate bid. They can typically turn those out in 180 days. It should not delay that truck being put in service. Fire is able to build those easier than the chassis.

Russell Leeds: This says 18.6 points and it is almost a 29-year-old truck. So low mileage, the wear and tear comes from?

Brian Richey: The wear and tear comes from use of the truck. Operating it up and down hills, getting stuck in riverbanks, and fields. There is heat stress from the grass fires, the radiant heat messes with the plastics underneath, the wiring and the coating on the wiring. The bigger problem is parts and availability for trucks like this are almost non-existent. We salvage because parts have been obsolete for 15 years, that is another obstacle that we face, to fight to repair a truck that is 25 years old in this environment.

This vehicle carries specialized medical equipment, a slip-in pump unit with water for fighting fires, Jaws of Life for extrications, and other types of equipment that may be needed. SCFD 1 utilizes 10 of these apparatuses throughout the county.

#### **Questions and Answers**

Greg Gann: Are these generally the vehicles that are first response? The 911 call that arrive on scene first is that correct?

Brian Richey: That is correct. Typically these vehicles we are talking about here are mainly used for all medical calls and grass fires. They are our first out for any medical call.

Greg Gann: Is it fair to say these see daily use?

Brian Richey: Absolutely, there are several of these. The one in Haysville can see eight (8) to ten calls a day. Usually all are called out multiple times a day. It just depends on the call load.

Brandy Baily: This is just for the truck and the chassis part is separate?

Brian Richey: What we are bidding today is the chassis with the bed and all of the optional equipment we bid with it. The only part not being bid today is the fire pump that goes in the back. All of the loose equipment transfers from truck to truck like the AUDs and the Jaws of Life. All of that is transferred from the old truck to the new truck, because we do not want to replace those every time we do the squads. So basically its their truck that we outfit. We add the extinguishers, the SBC rack, all of the communications, and the lighting is done in-house.

Russell Leeds: Going back to the point system, you were at 18.3, some would say that 97,000 miles isnt that many miles but again the wear and tear on these come from the... Is this a diesel engine?

Brian Richey: Yes it is a diesel. It is not only the mileage, it is the hours they idle. Not so much the environment they are in, they are used off road but it is limited. We try to use our Brush Trucks for that application, the longevity of the vehicle suffers but we cant always keep them in service the way we want to.

Russell Leeds: On a fire scene the engine runs, it idles for the pump?

Brian Richey: Yes. It might take five (5) minutes to get the scene but it will idle eight (8) to ten hours, it just depends. The fire we worked up north, unless you have experienced it or witnessed it, we had one (1) truck run for 80 hours solid. Those events happen, these units are not typically exposed to that level of severity. There are Brush Trucks that run eight (8), ten or twelve hours at a time.
