C. Account of events leading to the use of force including specific youth behaviors and non-physical interventions:

1. The youth arrived at JIAC after being released from the hospital for the second time that evening. He was agitated and said he would not answer any questions or do anything he was asked to do. He said he would sit in the JIAC intake area until his court date. He pressed all of the door buttons in an attempt to get out. He unplugged a computer monitor and removed two computer mice from the intake counter and smashed them on the floor. He wrote on the wall with a pen, inserted it into a lock, and said he would use it as a shank. He took off his shirt and socks and got into a fighting stance. He was given verbal instruction and redirection multiple times throughout. Several JDF staff responded and one was able to talk the youth into sitting down and talking. After a few minutes, the staff member left and the youth became agitated again. The youth reached up onto the intake counter class divider and was then placed in a Side Clinch by JDF staff and taken to JDF via a MAB Standing Hold.

Mechanical restraints used, if any, and length of time employed: None

Description of injuries sustained by youth or staff, if any: None

Policy implications: None

Corrective actions taken: A debrief was completed by JIAC and JDF Coordinators. A comprehensive review was completed by all JIAC staff along with the Continuous Quality Improvement Administrative Coordinator. *Findings: JIAC staff are expected to intervene more quickly to remove items from the intake counter and use body positioning as a form of prevention from youth taking possession of items, JIAC lead staff will be the point of contact and leader during use of force incidents. Retraining was provided.*

Level of discipline administered, if any: None

2. The youth pushed past a staff member to exit the calming room (which is not locked) and enter the intake area where the above incident was taking place. As staff attempted a Safe Clinch Bicep & Wrist Escort to guide her to the holding room, she went "dead weight" and lay on the floor laughing. Another staff came to assist and the two staff were able to use the MAB Standing Hold to walk her to the holding room.

Description of injuries sustained by youth or staff, if any: None

Policy implications: None

Corrective actions taken: This was a component of the above-mentioned comprehensive review and staff were retrained on moving other youth to a separate, locked area during special incidents.
