## Dante Corimanya

- Currently seeing a decrease in influenza. Influenza activity (or flu-like) symptoms were at 2.8% in the United States and 1.9% in Kansas. Cases from the CDC matched to the H1N1 virus.

- Discussion/Question: Dr. Gallagher ran a call with a crew, patient was in the doorway, they loaded the patient into the truck and he died.
