## **Sedgwick County Association of Cities (SCAC) Meeting Minutes**

Kechi, KS 67067  
September 10, 2022**

SCAC Met at 9:00am on Saturday, September 10, 2022 at Kechi City Hall. Council Member Tom Jones (Park City), SCAC Vice Chair, presiding. SCAC members and visitors are shown on the attached list.

**Welcome:** Vice Chair Tom Jones (Park City) welcomed members and guests. Kechi Mayor Ashley Velazquez welcomed everyone to Kechi and spoke about a new Kechi Café opening in October. There is also a fundraising campaign underway called Smile for the Mile to raise money for a new playground.

**Cities in Attendance:** Bel Aire, Bentley, Clearwater, Derby, Haysville, Kechi, Mount Hope, Mulvane, Park City, Wichita, and Valley Center

### **Approval of July 9, 2022 Meeting Minutes**

The Minutes from the July 9, 2022 meeting was submitted for approval.

**ACTION TAKEN:** Motion made by Council Member Bryan Frye (Wichita) to APPROVE the July 9, 2022 meeting minutes. Seconded by Vice Mayor Becky Tuttle (Wichita). **Motion Passed Unanimously.**

### **Approval of September 1, 2022 Treasurer's Report**

Council Member Gina Gregory (Valley Center), SCAC Treasurer, presented the September 1, 2022 Treasurer's Report.

**ACTION TAKEN:** Motion made by Council Member Ben Saucedo (Park City) to APPROVE the September 1, 2022 Treasurer's Report. Seconded by Vice Mayor Becky Tuttle. **Motion Passed Unanimously.**

### **Sedgwick County Update: Commissioner Jim Howell**

- Sedgwick County has 12 Fire Departments/Districts and 40 stations
- Sedgwick County Fire District 1 (SCFD1) has nine stations
- Three cities have own full time department
- Sustainability is a real challenge
- No Sedgwick County Commissioner has ever paid Sedgwick County Fire District 1 (SCFD1) taxes
- Services provided to places that don't pay fire district taxes
- Resolution to create a steering commission



Sedgwick County Association of Cities

- Another resolution to separate administration services for SCFD1 from the county, could save fire department money
- Long term goal is going to Topeka to ask for an elected fire board
- First step is to the creation of SCFD1 Steering Commission by adopting a resolution
- Commission would be nine members
- One appointed by each of the following cities: Haysville, Goddard, Maize, Park City and Bel Aire
- Four at-large positions
- Elected Fire District Boards are most common – Sedgwick County model is the exception
- All of this is at the request of SCFD1 staff
- Communities input:
  - Allow SCAC to appoint at least one of the at-large members to the Steering Commission to represent the smaller cities
  - Mayor Lehnerr (Park City): Likes the idea, but is it sustainable?
  - Would like to have input from SCFD1 Chief Williams at next SCAC meeting
  - We need an accurate calculation/forecast of cost savings

**Sedgwick County Regional Forensic Science Center Report:** Mayor Shelly Steadman, Director, Sedgwick County Forensic Science Center

- Coroners Office and Crime lab are under one roof which allows more efficiency
- In Kansas, forensic/autopsies are performed by either Sedgwick or Johnson County
- In Sedgwick County, we work in half as much space with twice the case load
- Case load continues to increase
- Unclaimed body cremation continues to increase
- Drug identification lab - Fentanyl has skyrocketed
- Overdose deaths up to 113%
- Arson and firearms investigations has increased
- DNA lab cases have increased
- Grant funding is critical to our facility

**ACTION TAKEN:** Motion made by Mayor Jim Benage (Bel Aire) to receive and file report. Seconded by Mayor Russ Kessler (Haysville). **Motion Passed Unanimously.**

**Sedgwick County Emergency Management:** Jon Marr, Deputy Director, Sedgwick County Emergency Management

- Work for all 20 cities
- Community Emergency Response Team (CERT) training
- Born out of two major earth quakes in Mexico City and Japan
- Two programs: basic training and advanced training
- Basic training:
  - Train & Release
  - Prepare individuals and families
  - Education and skills to respond



Sedgwick County Association of Cities

- Build confidence and defines expectations
- Creates resiliency within your community
- May be requested as a reserve contingent in extreme situations
- Advanced Team Training:
  - Advanced FEMA training
  - Deployable skills
  - Organized volunteer team
  - Specially trained to supplement professional responders
  - May be deployed out of county of state
- Will manage expectations and provide life saving interventions and incident stabilization
- Training will be offered through fire departments
- 20 hour FEMA created program - Friday evening, all day Saturday and Sunday afternoon
- The goal is to bring the programs to the vulnerable communities
- Classes will be formed per request from fire chiefs
- CivicReady: Mass notification and public alerting will allow cities to send alerts to residents on an opt-in basis, primarily email based
- Alerts will include public safety, public health and community bulletin alerts
- Alerts can be geo-targeted
- Beta testing will begin soon and available to all cities in Q4
- This is a free service

**Recommended ACTION TAKEN:** Motion made by Council Member Ben Saucedo to receive and file. Seconded by Mayor Terry Somers. **Motion Passed Unanimously**
