**Commissioner Pete Meitzner, Sedgwick County Update**

- Mental Health and Substance Abuse Coalition En Banc
  - Discussed the different needs of Sedgwick County to address the growing mental health and substance abuse crisis happening within Wichita.
  - Sedgwick County, along with the Mental Health and Substance Abuse Coalition are requesting increased support at the legislature in Topeka
    - Please ensure that we are all using the same language, and have a good understanding of the issues facing Sedgwick County.

Mayor John Lehnerr (Park City) suggested all cities in Sedgwick County draft a resolution supporting a state mental health hospital located in the Sedgwick County region.

- Annual Call Volume
  - Call Volume has been steadily rising for the last several decades, with a large jump in 2021
    - 2021 Reported 69,822 calls, which is a 9.3% increase from 2020
    - Roughly 84% of calls came from within the city of Wichita
    - A majority of the calls are happening between 1pm and 6pm
  - Increasing workforce concerns have caused ongoing issues with service delivery and availability
  - How a call works
    - The individual contacts dispatch, dispatch asks as many questions as possible to ensure the right services get provided
    - Response- Ambulance and team are sent the location

- On Scene- On the crew arrives on scene they perform an assessment of the individual(s) involved to determine the best level of care
- Transport- This is on an as-needed basis, and takes roughly 15 minutes
- Hospital- Individual(s) is/are dropped off at nearest hospital
- Available for next call- Once ambulance has been cleaned, the crew is ready for the next call
- In 2021, Sedgwick County ranked calls by frequency
  - 1. Hospital Transfer
  - 2. Sick Person
  - 3. Difficulty Breathing
    - These are separated by different categories to assist the Acuity
      - Lower Acuity
      - Emergent
      - Ongoing Resuscitation
      - Psychiatric
      - Critical
      - Dead without resuscitation efforts
- Dashboard
  - Sedgwick County EMS has developed dashboard to track and deliver data

SCAC Appointments to the WAMPO Technical Advisory Committee

**Background:**

The WAMPO Technical Advisory Committee (TAC) reviews technical information about transportation studies and issues as well as provides the WAMP Transportation Policy Body (TPB) with their professional recommendations on documents, plans, and activities. They also help with the adoption of transportation documents such as the annual Transportation Improvement Program.

WAMPO TAC meets the fourth Monday of every month at 10:00 a.m. at the Reagan Building, 271 W. 3<sup>rd</sup> Street, Wichita, KS 67202. The meetings are in-person, but a virtual option is available.

Sedgwick County Association of Cities has three appointments on WAMPO TAC to represent the 19 smaller communities in Sedgwick County: Dan Squires, City of Derby; Mayor Pat Stivers, City of Maize; Council Member Ron Colbert, City of Valley Center.

Mayor Stivers and Council Member Colbert have been appointed to represent their respective city on the WAMPO TPB and can no longer serve on the WAMPO TAC. Therefore, SCAC needs to appoint two new representatives to the WAMPO TAC. Appointment may be an elected official or city staff.

According to WAMPO TAC Bylaws:

**3.3.2** A person's membership on the TAC **shall** be terminated upon the member leaving his or her position named for membership on the TAC, or by the group represented by the person choosing a replacement representative.

**3.3.3** Missing three (3) meetings within a calendar year will be considered a resignation by the member unless the TAC votes to retain the member.

***Recommended Action: Appoint two officials from separate cities to serve on the Wichita Area Metropolitan Planning Organization (WAMPO) Technical Advisory Committee (TAC).***
