A. TO HAVE THE CHAIRMAN OF THE COUNTY COMMISSION SIGN THE FORM THAT WOULD ALLOW FOR "DECLARATION FOR PARTICIPATION IN THE FIREFIGHTER RELIEF FUND FOR 2009". THIS FORM IS SIGNED ANNUALLY BY THE CHAIRMAN.

Mr. Gary Curmode, Fire Chief, greeted the Commissioners and said, "To delineate what this is about, two percent of all our fire insurance premiums written in the State of Kansas are directed to the Insurance Commissioner's Office to provide funding for the State Firefighters Associations. According to state statutes, the money that the associations receive can only be used to provide benefits to commissioned firefighters. The formula for the amount received is based upon population covered. The Sedgwick County Firefighters Relief Association receives approximately \$65,000 a year. A portion of the money that is given to the State Firefighters Association is to provide training to firefighters; the remaining money is split up among the several hundred Firefighter Relief Associations throughout the State to provide other benefits. Benefits may include: eyeglasses, disability insurance and life insurance. With this said I ask that you approve the declaration and authorize the Chairman to sign.

Chairman Parks said, "Okay, the only comment I would have on that, has there ever been any thought about doing this by reference, instead of having a council action each time?"

Chief Curmode said, "Not that I know of, sir. It's been this way for the past 15 years and then I noticed that when I was in the City, they also had the same format they had to accomplish then."

Chairman Parks said, "This is once a year?"

Chief Curmode said, "Yes, this is once a year."

Chairman Parks said, "Time flies, I guess. It certainly could be done by reference, but I guess if it's only once a year we can have that put out to the homeowners so they'll know where two percent of their policy is going to, so is there any other discussion on this? What's the will of the Board?"
