  - i. Commissioner Ryan Baty called the meeting to order at 5:33 p.m.

#### 3. NEW BUSINESS

- a. Meeting Business Discussion
  - i. Overview and Purpose of Citizens Advisory Board Ryan Baty, County Commissioner 1. 3 Goals
    - a. Bigger/Broader voice to District 4. Most diverse district. Wants everyone to be represented and have a voice.
    - b. Reinforce the role of an Advisory Board. Wants this board to be a true advisory board that considers the issues and serve its purpose.
    - c. Influence future direction of community. Wants insight of the board on community issues.
  - ii. Review and Discuss Bylaws, KOMA and KORA Justin Waggoner, County Counselor 1. KOMA – Kansas Open Meetings Act
    - a. Meeting has to be open to the public, public has to be able to view and hear the meeting. Public has a right to notice about upcoming meetings
    - b. What is a meeting? When a majority of the members meet either, inperson, social media, phone, video conference, etc.
      - i. 7 or more for this board
      - ii. Serial meetings violate KOMA example: polling members
      - iii. An exception is setting a time to meet.
    - c. Sub-committees are subject to KOMA as well
    - d. Things Not to do
      - i. Do not Reply All
      - ii. Do not Vote by Email Considered a secret ballot

- iii. Be careful about commenting on Social Media if 7 or more are talking on social it could violate KOMA
- iv. OK for 7 or more to be at the same public gathering as long as no discussion of CAB business
- 2. KORA Kansas Open Records Act
  - a. Be aware that any email communication you send to County Staff or other Board members is subject to KORA
- 3. By-Laws
  - a. Quorum is 7 members
  - b. 2/3 to add additional items to the agenda
  - c. Conflict of Interest abstain on issues relevant to you.
- iii. Order of Meeting Agenda Commissioner Ryan Baty / Citizens Advisory Board
  - 1. This agenda item and the next were discussed together.
- iv. Meeting Frequency, Meeting Topics Commissioner Ryan Baty / Citizens Advisory Board
  - 1. Commissioner Baty will run the meeting
    - a. For Zoning cases, board will appoint a chair to run the discussion that day
  - 2. Meeting Frequency Tentatively meeting every other month
    - a. Can call additional meetings if needed
    - b. Might coordinate tours on off months
    - c. Day of month may change, right now, last Tuesday of month @5:30pm
    - d. Venue may change
    - e. 75-90 minutes
  - 3. Topics
    - a. Presentations from County Elected Officials, Appointed Officials, Staff, Task Force representatives, etc.
      - i. Presentation, Q&A, Discussion
    - b. Appropriate Role of County Government
      - i. 82% of population lives in the cities
- b. Overview of County Government County Manager Tom Stolz
  - i. Tom Stolz gave an overview of the difference between County Government and City Government.
  - ii. Reviewed County Organizational Chart
    - 1. 7 Divisions with 46 Departments, 9 other organizational functions
  - iii. Home rule cities can lay their own rules, counties not so much
  - iv. Reviewed what the County provides State services, County only services
  - v. Reviewed how the County Pays for Services Taxes, Grants, other revenue sources
  - vi. Reviewed County Budget Process
  - vii. Reviewed fiscal state of Sedgwick County
  - viii. Recommended Budget
    - 1. No increase in Mill Levy
  - ix. Questions/Priorities
    - 1. Chris Stingo asked about the Budget Public Hearing on August 2
      - a. Tom Stolz explained how the public hearing works, invited people to attend
    - Krister Johnson asked, how many people are on Sedgwick County payroll

       Tom Stolz replied, fluctuates between 2600-3000
    - 3. Alison Despard asked, with the grant funding coming for mental health, is Sedgwick County getting updates on how that money is being spent?
      - a. Tom Stolz responded, yes. Recommended bringing in Joan Tammany from COMCARE to speak to all the services that are provided. A better question is, is the State funding this enough?
      - b. Commissioner Baty added, COMCARE is \$55 million budget and only \$5 million is property tax funded

- c. Tom Stolz added, EMS is 3-1 revenue with tax payers propping up
- d. Commissioner Baty added, 46 departments, 16 are on behalf of the state. Over the last 10 years the expenses are up 30% while funding from State is down over 20%. Legislative agenda to get State to fund their part.
- e. Tom Stolz included, the State has a history of taking funding away forcing counties to increase property taxes.
- 4. Donald Gering Jr. asked, how can you speak so positive about mental health issues
  - a. Tom Stolz responded, many reasons, we have a Bio-Med Health Center coming in, COMCARE Crisis has a new building, City is looking to create a social service effort for homeless, building a Mental Health Hospital, all of these pieces add up and there is actual money being funding towards it.
  - b. Commissioner Baty included, there are 5 things, we have the capacity to build the gold standard
    - i. Mental Health Hospital
    - ii. COMCARE Crisis Expansion with medical detox
    - iii. Bio-Med Health Center 3,000 med students in downtown Wichita
    - iv. MAC Multi-Agency Campus City of Wichita program, wrap around services for homelessness
    - v. Mental Health Court
- 5. Jordan Walker asked, what is the benefit of moving from Paramedic/EMT model to double Paramedic?
  - a. Tom Stolz responded, better customer service, less burn out, internal training
- 6. Commissioner Baty covered his priorities for the 2024 Budget
  - a. Staffing Stability
  - b. Hold line on Property Taxes
- 7. Jordan Walker asked about County Facilities
  - a. Tania Cole replied, we are always looking for efficiencies in our leases. Part of the process with looking for a new Administration Building is how to house County Departments in an efficient and cost effective way.

- a. Commissioner Baty mentioned he sits on the Homeless Taskforce and discussed when they meet
- b. Commissioner Baty said he will ask Sheriff Easter to come speak to the board.
- c. Helen Rolfe commented that she is happy to be a part of this board.
