ORDER OF BUSINESS

- 1. Chair David Sowden called the meeting to order at 4:03 PM.
- 2. Invocation Observed by a moment of silence.
- 3. Flag Salute Members stood for the flag salute.
- 4. New member swearing in Rebecca Tang, student member of the board, was officially sworn in by County Clerk Kelly Arnold.
- 5. County Clerk Kelly Arnold comments
 - a. Mr. Arnold shared that the County Clerk's office is processing homestead property tax relief filings. An informational sheet will be provided to the advisory board at next month's meeting.

6. Roll Call – Determine Quorum

- a. David Sowden, John Nicholas, Liz Loera, Joseph Elmore, Olivia Hayse, Bryan Porter, Brad Smith, Rebecca Tang
- b. Amanda Amerine arrived after the roll call.
- c. Quorum was present.
- 7. Approval of minutes December 1, 2023
 - a. Motion to approve minutes made by Chair David Sowden.
 - b. Motion seconded by Brad Smith.
 - c. Approved 8-0.

8. New member introduction – Rebecca Tang

a. Rebecca shared that she is a sophomore at Derby High School. She is grateful for the opportunity to be a part of the board and learn from the other members. She hopes to become a better leader and improve her communication skills during her time on the board.

9. Public agenda -- No members of the public signed up for public comment. One attendee shared commends later in the meeting—see below.

10. New business

- a. Commissioner Howell 2023 Report/2024 Issues
 - i. Commissioner Howell appreciates the work of the board and thinks they have done great work this year.
 - **ii.** Governor Kelly included \$40 million in proposed budget for a homelessness infrastructure grant program; hopefully this will allow for the multi-agency center to be fully funded within a year.
 - **iii.** Metropolitan Area Building and Construction Department (MABCD) and technology are now housed in separate funds thanks to legislation passed this year.
 - **iv.** Driver's license bill introduced in the legislature yesterday would allow for restricted licenses to be issued after revocation due to traffic violations.
 - v. Commissioner Howell distributed two handouts detailing the Sedgwick County 2024 legislative platform and Emergency Communications department developments in recent years (attached).
 - vi. BoCC approved a joint legislative platform with the City of Wichita, Greater Wichita Partnership, and Regional Economic Area Partnership (REAP); Commissioner Howell would like to see more active language rather than "support" statements.
 - vii. Vice-Chair John Nicholas asked about amendments to statutes related to public works listed on the legislative platform document.
 - 1. Commissioner Howell believes this is a funding issue; he will come back with a more detailed answer.
 - viii. Chair David Sowden asked about placement issues related to the juvenile offender code.
 - 1. Commissioner Howell said that this refers concerns regarding residential options for youth who have been affected by the criminal justice system but do not qualify for placement in either foster care or detention.
 - ix. Commissioner Howell said that the community-based 911 board is in the process of being formed.
 - **x.** Two weeks ago, a new process began to review 911 calls on a weekly basis if they involve injury due to a fire or if there is a critical discussion regarding a call. Data related to these calls are being made public.



- **a.** Olivia Hayse believes that the CAB's priority should be getting more public involvement. She also asked what items the CAB formally submitted statements on in 2023.
 - i. Chair David Sowden answered that there were no formal opinions submitted to the BoCC in 2023.
 - ii. Olivia would like to see more action from the board; she believes that the CAB covered a lot of topics but did not take it beyond meeting discussions this year.
- **b.** Rebecca Tang suggested that the board expand the social media platforms that it uses to make content more accessible to a wider audience.
- c. Commissioner Howell said that public attendance is a challenge for all CABs. The purpose of the CAB is to advise him, and he welcomes opinions. He mentioned that the BoCC's agendas are very full, and meeting once a month might limit how many topics the CAB has time to discuss.

 - ii. Motion seconded by John Nicholas.
 - iii. Approved 8-0.
- e. Secretary nominations
 - i. Liz Loera was nominated by Brad Smith; Liz accepted the nomination.
- **f.** Secretary election
 - i. Motion to elect Liz Loera as Secretary made by Chair David Sowden.
 - ii. Motion seconded by Joseph Elmore.
 - iii. Approved 8-0.

4. Former Chair David Sowden remarks

- **a.** David shared that he will be leaving the board. He said that the role of the CAB members is to solicit comments and concerns from the public. He believes that the CAB's conversations have always been civil and respectful, and this needs to continue. He shared that County officials recognize the impact of this CAB. He thanked everyone for their participation on the board.
- **b.** Commissioner Howell shared that he was initially hesitant about forming a CAB, but that his opinion has changed. He thanked David Sowden and described him as detailed, faithful, organized, communicative, and knowledgeable.

5. Public comment

a. George Theo Harris shared that his wife Janet was on this board previously and he wanted to come to the meeting to show respect for David for his work while she was on the board up until now. He mentioned that he would like Commissioner Howell to encourage the Sheriff to legalize marijuana.

6. Meeting adjourned by newly elected Chair John Nicholas at 5:18 PM.
