On the recommendation of Dallas Shaffer, on behalf of Various Departments of Sedgwick County, Anne Smarsh moved to **accept the overall low bid* from AmeriPride Uniform Services and establish contract pricing for one (1) year with two (2) one (1) year options to renew.** Jennifer Dombaugh seconded the motion. The motion passed unanimously.

Note: The annual spend for last year was \$35,000.00. There are currently 21 different departments that will utilize the contract. Overall analysis consists of what each vendor priced and the estimated quantities of usage for items.
