On behalf of the Facilities Department, recommend to **accept the low proposal meeting specifications from Scott Rice Office Interiors, LLC in the amount of \$8,306.75.**

The Correll brand offered by Commercial Concepts & Furnishings Option 2 did not meet the specification for a round table base (cast iron) minimum 28" in diameter. The Correll table has "spider legs" which do not provide the same level of durability and stability required.
