### **OPERATION TALON, SPRING 2005 WARRANT SWEEP**

THE SEDGWICK COUNTY SHERIFF'S OFFICE CONDUCTED A MULTI-AGENCY WARRANT SWEEP IN SEDGWICK COUNTY BETWEEN 4PM AND 10PM ON WEDNESDAY, APRIL 06, 2005.

THIS WARRANT SWEEP RESULTED IN THE ARREST OF 58 PEOPLE AND CLEARED A TOTAL OF 76 WARRANTS. THE TYPES OF WARRANTS THAT WERE SERVED ON THESE PEOPLE WERE FELONY, MISDEMEANOR, TRAFFIC, DOMESTIC, JUVENILE, AND CIVIL WARRANTS.

THE WARRANTS SERVED HAD BEEN ISSUED BY THE SEDGWICK COUNTY DISTRICT COURTS, AS WELL BY COURTS OF THE JURISDICTIONS THAT THE ASSISTING AGENCIES ARE RESPONSIBLE FOR.
