SEDGWICK COUNTY DEPUTIES ARREST A TOP TEN FUGITIVE AND THREE OTHER FUGITIVES PROFILED AS THE FELON OF THE DAY WERE RECENTLY CAPTURED.

SHAWN SOBANSKI WAS PROFILED AS A TOP TEN WANTED FUGITIVE BY THE SEDGWICK COUNTY SHERIFF'S OFFICE ON MARCH 24, 2009. SOBANSKI WAS WANTED FOR AGGRAVATED SEXUAL BATTERY, AGGRAVATED BURGLARY AND POSSESSION OF OPIATES. ON JULY 13, 2010, SEDGWICK COUNTY SHERIFF DEPUTIES RECEIVED A CRIMESTOPPERS TIP THAT SOBANSKI WAS LIVING WITH HIS SISTER AT 2318 E. MESITA DRIVE. DEPUTIES SEARCHED THE HOUSE AND FOUND SOBANSKI HIDING IN THE BASEMENT. SOBANSKI'S SISTER, KRISTINA TIMPY, OF WICHITA, KANSAS WAS ARRESTED DURING THIS WARRANT INVESTIGATION FOR AIDING A WANTED PERSON. CHARGES ARE PENDING. .

CLAUDE LOLAR WAS PROFILED AS THE FELON OF THE DAY ON MAY 28, 2010. LOLAR WAS WANTED FOR FORGERY AND IDENTITY THEFT. ON JULY 6, 2010, WINFIELD POLICE ARRESTED LOLAR IN WINFIELD, KS.

DEPUTIES WITH THE SEDGWICK COUNTY SHERIFF'S OFFICE WENT TO WINFIELD AND TRANSPORTED LOLAR BACK TO SEDGWICK COUNTY.

WAYMAN KIDD WAS PROFILED AS THE FELON OF THE DAY ON JANUARY 28, 2010. KIDD WAS WANTED FOR AGGRAVATED BURGLARY, CULTIVATING AND DISTRIBUTING MARIJUANA, TWO PROBATION VIOLATIONS FOR BURGLARY, AND A PROBATION VIOLATION FOR THEFT. ON JULY 15, 2010, WICHITA POLICE OFFICERS ARRESTED KIDD AT 1725 N. ROCK ROAD.

RAYMOND E. TROTTIER WAS PROFILED AS THE FELON OF THE DAY ON JUNE 30, 2010. TROTTIER WAS WANTED FOR FELONY DUI. ON JULY 7, 2010, TROTTIER WAS ARRESTED BY THE FT. WORTH POLICE DEPARTMENT. ON JULY 15, 2010, DEPUTIES WITH THE SEDGWICK COUNTY SHERIFF'S OFFICE FLEW THE SHERIFF'S AIRCRAFT TO FT. WORTH, TX. AND TRANSPORTED TROTTIER BACK TO SEDGWICK COUNTY.

THE SEDGWICK COUNTY SHERIFF'S OFFICE DISTRIBUTES THE "FELON OF THE DAY" AND THE "TOP TEN" LIST TO ALL LOCAL MEDIA OUTLETS WITHIN SEDGWICK COUNTY AND THE SURROUNDING COMMUNITIES. FELONS WHO HAVE BEEN PREVIOUSLY HIGHLIGHTED WITH ACTIVE WARRANTS REMAIN POSTED ON THE SHERIFF'S WEB SITE. MEDIA OUTLETS WHO POST THE "FELON OF THE DAY" AND "TOP TEN" ON THEIR WEB SITE ARE ASKED TO UPDATE THIS INFORMATION AS FELONS ARE ARRESTED.

OFTEN IT IS INFORMATION FROM OUR COMMUNITY WHICH HELPS LAW ENFORCEMENT TRACK DOWN THESE WANTED FELONS. WITHOUT ASSISTANCE FROM THE PUBLIC THESE WANTED FELONS CAN REMAIN FREE. THERE ARE MANY WAYS A CITIZEN CAN SUBMIT INFORMATION ABOUT WANTED PERSONS
