Chairman Sciortino said, "Let's wait just a second before you call the next item, because Commissioner Gwin . . . Hey, you know what. Commissioner Gwin is leaving. We might want to consider hiring her on a part-time basis to review all the minutes of the meetings because she's really good about that. Would you call the next item please."

RETIREMENTS

A. PRESENTATION OF RETIREMENT CLOCKS.

1. GAY RITCHEY, DIRECTOR OF VOLUNTEER SERVICES, SEDGWICK COUNTY ZOO, RETIRED JANUARY 1, 2003 AFTER TWO YEARS OF SERVICE.

Ms. Lucretia Taylor, Diversity and Employee Relations Manager, Division of Human Resources, greeted the Commissioners and said, "I'm here to present the retirement certificate to Gay Ritchey, who is director of volunteer services at the Sedgwick County Zoo. Gay will be retiring January 1, or retired January 1 after two years of service.

Gay plans to spend time with her husband Mark and she can devote more time to doing a lot of volunteering with the Zoo and the volunteer office and making enrichments for animals to play with in their exhibits. She also plans to make pottery decorated with animals.

Gay has worked exclusively in the volunteer department for the Zoo for the last 29 months. She volunteered in the graphic design department for special events for 15 years prior to working at the Zoo. Gay describes her period of employment as 'working at the zoo is the best job I've ever had. The staff is the most competent group of people I have ever worked with and they are dedicated, loyal and work very hard'. Gay taught art in grades 1 through 12 in Belle Plaine, Wichita and Maize prior to working with the zoo, so she says she was a Kansas public employee for the last 30 years."

Commissioner Gwin said, "There's your certificate. Ben misspelled his name again, but that's okay. On behalf of the Board of County Commissioners and the folks of Sedgwick County, we want to present you with your retirement clock, hoping that you don't have to work on the clock anymore, but just enjoy your volunteer time. Thank you for your service. Do you want to say anything before we call the next one?"

Ms. Gay Ritchey, Director, Volunteer Services, Sedgwick County Zoo, said, "There's several of you here in the room that do not have blue volunteer shirts to work at the zoo, but we can provide you with those anytime."

2. PAMELA LESTER, CASE COORDINATOR, DISTRICT ATTORNEY'S OFFICE, WILL RETIRE FEBRUARY 1, 2003 AFTER 11 YEARS OF SERVICE.

Ms. Taylor said, "Commissioners, our next retiree is Pamela Lester. Pamela is a case coordinator with the District Attorney's Office who will retire February 1, 2003 after 11 years of service with the District Attorney's Office. Unfortunately, Pamela has had a family emergency this morning and is unable to be here but we will make sure that she receives her certificate and clock as well."

Chairman Sciortino said, "Okay."

3. EDDIE STEGALL, ZOOKEEPER, SEDGWICK COUNTY ZOO, RETIRED JANUARY 1, 2003 AFTER 30 YEARS OF SERVICE.

Mr. Russell said, "Our final retiree is Eddie Stegall, zookeeper at the Sedgwick County Zoo. Eddie retired January 1, 2003 after 30 years of service. Eddie."

Commissioner Gwin said, "We think Eddie was standing out there when the zoo opened and just wanted to keep staying. Come on up, Eddie. This is your retirement certificate. I want you to keep that and then on behalf of the Board of County Commissioners and the folks of Sedgwick County your retirement clock. Enjoy your retirement. Thank you for your service."

NEW BUSINESS

B. APPLICATION TO KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT BY CORNEJO AND SONS, INC. FOR MODIFICATION OF AN EXISTING SOLID WASTE LAND DISPOSAL AREA.

OVERHEAD PRESENTATION

Ms. Susan Erlenwein, Director, Environmental Resources Department, greeted the Commissioners and said, "The Kansas Department of Health and Environment requires that all solid waste related permits be reviewed by the local authorities for their consistency with our local solid waste plan. Cornejo and Sons Incorporated has been operating a construction and demolition landfill along K-15 and if you look at this map, you can see that it's adjacent to the Ark River, the area of the landfill outlined in red is just west of K-15 and it's basically south of I-135.

They have been in operation at this location, they've been recycling asphalt and concrete material, they have been in compliance with our local plans and we've been inspecting them on a weekly basis, as we do all disposal facilities and they have been in compliance.

The state is requiring them to renew their permit. The city recently extended their conditional use permit till April, 2004 so this is a process that we're going through to make sure that they are in compliance and consistent with our solid waste plan and they're consistent with zoning and the Solid Waste Committee reviewed this this past Monday and determined that they are consistent with our plan. I'd be happy to answer any questions you might have. Also we have representatives from Cornejo and Sons, Ron Cornejo is here, as well as Mike Hill. Thank you. I'm sorry, Chuck Hill."

Chairman Sciortino said, "Yes, I think we do have some questions or comments. Commissioner Gwin."

Commissioner Gwin said, "The only thing I wanted to get clarification, I know a couple of year's ago there was some concerns about operations next to the river. Are we confident that this is okay here?"

Ms. Erlenwein said, "The Kansas Department of Health and Environment has a rule that says a disposal facility cannot be within one-half mile of a navigable river. This is along the Arkansas River and different agencies have determined that it is or is not navigable. So another company in town, a couple of years ago as you mentioned, tried to site a construction and demolition landfill on the north end of the river and they were turned down by the state. Our local regulations do not address this half mile distance. That's a discussion that the Cornejo company will have to have with KDHE."

Commissioner Gwin said, "I see, okay. And I appreciate the mixed messages you get from different departments up there. So good luck with that. Thank you. That's all I wanted to find out."

Chairman Sciortino said, "I don't see that there's any other questions. So what's the will of the Board on this item please?"

C. AGREEMENT WITH CITY OF PARK CITY, KANSAS REGARDING THE WICHITA HEIGHTS WATER SYSTEM.

OVERHEAD PRESENTATION

Mr. Rich Euson, County Counselor, greeted the Commissioners and said, "This matter comes before you as a project that the County Commissioners initiated in the early 1990s and on the overhead is a map showing the area that is covered by the agreement that's on your agenda today. The area in red is roughly in the vicinity of 53rd and Broadway and the red line is the district that was created as the Wichita Heights Water District and at the time that was created, the entire district was in the unincorporated area of the County. The yellow diagonal line on this map shows the boundary line between the City of Wichita, which is to the southwest, and the City of Park City, which is to the northeast.

The district was set up to serve approximately 170 users and the financing was fairly complicated. This was over a million dollar project and in order to make this affordable for the users there was a combination of financing from Community Development Block Grants, County general funds, County bond funds and special assessments to the properties involved.

In 1998, the City of Wichita annexed the area to the southwest of the yellow line and at that time they asked us to remove them from the obligations of the agreement, in other words, the obligations to pay for the user fees and surcharges and we did so at that time and we released 54 users that were in that southwestern portion.

Now, the City of Park City in the year 2000 annexed the area to the northeast and they are asking for the same thing. All of this area was originally hooked up to the City of Park City's water system. When the City of Wichita was released in 1998, they hooked the southwestern portion up to their area. The northeastern portion would continue to be hooked up to the Park City system.

The agreement before you would release the balance of the properties, in other words 116 users, from the fees and surcharges that are set forth in the 1991 agreement. It would require Park City to hold the county harmless from any liability for operation or maintenance of this water system and the properties would continue to be liable for special assessments until the bonds are paid off in the year 2006.

Mayor Bergquist is here on behalf of the City of Park City and I will also be happy to answer any questions that I can concerning this matter."

Chairman Sciortino said, "Okay. Well, we have a couple of questions and Mayor Bergquist, we're happy to have you with us. Commissioner McGinn."

Commissioner McGinn said, "Thank you, Mr. Chairman. Rich, this is a result of two communities growing together and annexations and what we're doing here is we're trying to help another community, just as we did the City of Wichita, at the same level. Is that correct?"

Mr. Euson said, "That is correct. We're trying to do essentially the same thing we did for the City of Wichita in 1998."

Commissioner McGinn said, "And we happen to be the governmental entity at the time because there wasn't a city from either direction to put this district in place, but now that the two communities have grown together, it's time for us to pass it on."

Mr. Euson said, "That is correct."

Commissioner McGinn said, "Thank you."

Chairman Sciortino said, "As I see it, we're just extending to Park City the same courtesy that we extended to Wichita. So I don't see that this is anything controversial at all. Excuse me, Commissioner Gwin."

Commissioner Gwin said, "And just from the historical perspective, this is something that the City of Park City and Commissioner McGinn and I have been working on for quite a while, even while I still represented part of Park City and I think we did, looking at the numbers, do our best to try to treat both communities fairly. I think it's an important transition that we're completing here and certainly the project was because the need was very dire at the time, but now that we have the opportunity, I think this is the appropriate thing to do. Thank you."

Chairman Sciortino said, "Commissioner Norton."

Commissioner Norton said, "I'm very supportive of this. I think any time we can help our small communities prosper and take care of these issues I think we should. I'd like to know, at least for the record, the dollar impact of our decision today. I know there is some money attached to it and what will that be, just on the record?"

Mr. Euson said, "Sure. Commissioner Norton, in 1998 when we released 54 users from the City of Wichita, the City of Wichita paid us \$27,000. In this case, we're releasing 116 users and the net

impact, the net release, the payment from Park City is \$50,000 and the net remaining is \$86,000. In other words, we had a contractual obligation to go to the year 2006 and we're releasing that, as we did for the City of Wichita."

Commissioner Norton said, "That's all I had."

Chairman Sciortino said, "Okay. Any other questions? I don't see there are any. So what's the will of the Board on this item please?"

And as you know, Dr. Oeberst has been a great addition to the Regional Forensic Science Center. She is well liked by her customers but more importantly she has their respect and confidence and I happily ask you to approve the agreement and authorize the Chair to sign."

POWERPOINT PRESENTATION

Mr. David Spears, P.E., Director/County Engineer, greeted the Commissioners and said, "Mr. Parnacott is here telling me there is a map there for you. Item F-1, before you today are six resolutions authorizing the sale and conveyance of six parcels of property and also six notices of intent to convey these properties. These properties are in connection to the railroad overpass project in Haysville.

The resolution stipulates that the property is no longer required for public purposes by Sedgwick County and that the County will enter into negotiations with the City of Haysville as to the terms and conditions of a purchase agreement. The six notices of intent puts the public on notice that Sedgwick County intends to convey the property to the City of Haysville. Bob Parnacott has prepared all the paperwork this morning and the map. And if you have any questions, we'd be glad to try to respond. If not, I'd recommend that you adopt the resolutions."

Chairman Sciortino said, "Commissioner Norton."

Commissioner Norton said, "Well, obviously I'm going to be in support of this. This is something we've worked on with Dave and the legal assistance of Rich and others for a couple of years. I know Bill Hancock had worked on it even prior to me getting here. I think it's going to be important to the future of Haysville, as they try to create some economic development. The one thing this will do is enter into the negotiations, the conveyance. It's not the final act. We'll have to come up with what we feel is a reasonable price for Haysville to pay.

I'll have to tell you, and I'll go on record to say, that I hope that we'll get the price down where it is more of an economic stimulus to them to have the property than a burden. In these tough times, economically, no small towns have a lot of money to be purchasing and this is a critical area of their town after the tornado. But this is just the conveyance to start the process to finish it up."

 - B-409 BRIDGE ON 53RD STREET NORTH BETWEEN 167TH AND 183RD STREETS WEST (OVER COWSKIN CREEK): \$69,000
 - B-410 BRIDGE ON 45TH STREET NORTH BETWEEN 167TH AND 183RD STREETS WEST (OVER COWSKIN CREEK): \$67,000

Mr. Spears said, "Item F-2 is an agreement with Parsons Brinckerhoff Quade and Douglas, Inc. to design four bridges this year. For the record, the bridges are in the Capital Improvement Program and are designated as: B-409, a bridge on 53rd Street North between 167th and 183rd Streets West over the Cowskin Creek; B-410, a bridge on 45th Street North between 167th and 183rd Streets West;

B-411, a bridge on 4th Street North, which is Central, between 167th and 183rd Streets West and B-412, another bridge on the same mile on 4th Street North, between 167th and 183rd Streets West. The total cost is \$204,000, which includes surveying, hydrology, permits for the division of water resources, geology, all right-of-way documents, utility coordination and design. Because even though I didn't say it daily, or whenever you helped me, I certainly appreciated it and it was right here and it will always be remembered.

As Ben said, your wit, your wisdom has always been appreciated and your humor for sure. I mean, there's times when I've had to deal with Ben and other commissioners and you know, we've had some serious issues and we want to punch walls and everything else and so once in while it's always been great to be able to go to another commissioner and be able to laugh and you've always provided humor with a lot of difficult decisions that we've had to make.

I thought it was interesting, you showed the picture of Cowtown cleaning up and you showed me that not too long ago and I just remember, as a new commissioner, the tornado hit Haysville and south Wichita."

Commissioner Gwin said, "Well, that was your deal, you're the one that dragged us down there."

Commissioner McGinn said, "Well, but you were the one that made it fun and exciting. But I just . . . I was very uncomfortable. I seemed like all we were doing was going to ceremonies and talking about, as public officials, what we were going to do and I felt like maybe we needed to go help clean up the mess and so we got the truck and I remember going in and asking you and your eyes

got this big, like 'what are you talking about, Carolyn', not knowing what you were getting involved in, you said 'okay, let's go' and so we spent two or three days down in Haysville cleaning up. And so, I think we've got some pictures of that somewhere too.

But anyway, to sum it up, I just want to sincerely say thank you. I wish you the best in your endeavors. I'm not concerned about your future. You're a bright, smart individual and I know you're just going to make great strides here in the future. So, thank you."

Commissioner Gwin said, "Thanks. One of the things that Carolyn and I have had to deal with these last four years is that people get us confused. And so, I thought as a legacy I'd leave you some gray hair and my height so that they could continue the process of trying to figure out who you were."

Commissioner McGinn said, "Well, I have noticed the gray hair. I got a haircut the other day and I noticed all the gray hair in my lap. So thanks."

Commissioner Gwin said, "So maybe be working so people can tell us apart."

Commissioner McGinn said, "Okay."

Chairman Sciortino said, "Commissioner Norton."

Commissioner Norton said, "Well, sure I have some things to say but everybody is going to have to help me with this because I do this when most people leave or have birthdays or what and I've done it for a lot of years. It's kind of a take off on 'you might be a redneck if' but in this case 'you might be Betsy Gwin if'. So, I'll read the line and then you can say 'you might be Betsy Gwin'.

Okay, is everybody ready? If you have a closet just for coffee cups, you might be Betsy Gwin. If you belong to the hairstyle of the month club, you might be Betsy Gwin. If you're the only person who knows all the animals' names at the Zoo, you might be Betsy Gwin. If you always show up for the midnight performance at the Zoo during the race looking for a man, you might be Betsy Gwin. And if you're truly number one in my book, you might be Betsy Gwin."

Chairman Sciortino said, "Thomas."

Commissioner Winters said, "Well, thank you. I just want to be very short because I don't want to start crying either. But I really do want to say just two things really. Thank you for all the service that you've given to citizens and to this commission and to the bench. I know that, you know, I guess things change over time and I think probably in local government the complexion changes but

I'll always remember the work that we did with Mark Schroeder, Bill Hancock, you and myself rocking and rolling on lots of things and I feel a little bit older now myself just thinking about the term that I've spent here but I just want to say thank you for all the service you've given and thanks for all the help you've given me over the years. I appreciate it very much."

Chairman Sciortino said, "You know, Betsy has had an identify crisis, especially when McGinn came on board. Betsy was referred to as Commissioner Guinn and Carolyn would be Commissioner McGwin. During the time that I've had my shoulder operated on she signed her name so often saying 'Gwin for' because I wasn't able to sign, so we referred to her as Betsy Gwinfor

Betsy, I'm going to tell you something, just from the bottom of my heart, one of the things that I've really appreciated in you is when you make a decision that this is something that you're for or you're against, you just stand for it. You don't care what it might be impacting politically or what have you, if you have a position that you truly believe is correct and right, you have the will to stand up for it and to continue down that road, without any wavering and that's a little unique with politicians. Sometimes, you know, politicians want to take polls to see is this the correct thing or will the majority of the people believe this but it's been my impression on you that if you think it's right, you go ahead and vote your heart and your conscience and you're to be congratulated on that.

And Commissioners, I don't know about you, but I think I'm just going to stand up and do a little clapping. Okay, enough of that."

Commissioner Gwin said, "Well, I thought my pictures said it all, so I don't know that I have anything to add. There were more, but we don't have all day. But thank you all for your kind comments. I've enjoyed my service. I'll see you."

Chairman Sciortino said, "Okay, is there anything else to come before the Board? Mr. Euson, do we have an Executive Session? Okay."
